- *2157 HEALTH—INFRINGEMENTS OF SMOKE-FREE ENVIRONMENT ACT 2000—Mr Secord asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Health, and Minister for Medical Research—
 - (1) As of 11 April 2018, how many enforcing officers in the state of New South Wales are employed by NSW Health or Local Health Districts to enforce the Smoke-free Environment Act 2000 in New South Wales?
 - (2) How many infringement notices for breaches of the Smoke-free Environment Act 2000 have been issued in New South Wales between 11 April 2017 and 11 April 2018?
 - (a) Of these infringement notices, how many were issued for infringements identified between 9 AM and 5 PM?
 - (b) Of these infringement notices, how many were issued for infringements identified between 5:01 PM and 8:59 AM?

Answer-

NSW Health inspectors monitor compliance with smoke-free laws under the Smoke-free Environment Act 2000. Infringements of the Act are also enforced by other NSW agencies such as NSW Police, especially in transport settings.

Smoke free outdoor compliance is high, with inspectors observing 99% compliance for inspections among people in smoke-free outdoor areas from July 2016 to June 2017.

*2158 FINANCE, SERVICES AND PROPERTY—DEPARTMENT OF FINANCE POSITIONS MOVED TO QUEANBEYAN—Mrs Houssos asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Finance, Services and Property—

Since 25 August 2017, how many new jobs within the Department of Finance have been moved to Queanbeyan?

Answer-

The Department of Finance, Services and Innovation has committed to relocating up to 50 roles to Queanbeyan by December 2018.

Since 25 August 2017, three roles in Queanbeyan have been filled and a further three are likely to be recruited to in the near future in Public Works Advisory. A further 10 roles in the Department are presently located in Queanbeyan.

The remainder of the 50 roles to be located in Queanbeyan by December 2018 will be made up of a combination of currently filled roles located in Sydney, vacant roles and new roles who can support property and infrastructure programs in southern NSW. The Department is implementing a strategic workforce planning and change management process to ensure roles are filled with capable candidates and to provide increased employment opportunities in the Queanbeyan region.

- *2162 REGIONAL WATER—PUBLIC FUNDS—Mr Graham asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) Were any public funds spent at the function held at the Tub Thim Thai restaurant in Moree in October 2015?
 - (a) If so, how much was spent?

Answer—

I can only speak for Government agencies within my portfolio, and in this regard, I refer to my answer to question number LC 1981 printed in Questions & Answers Paper No. 147.

*2163 TREASURER—SYDNEY MOTORWAY CORPORATION SALE—Mr Graham asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Treasurer, and Minister for Industrial Relations—

Does the sale of the Sydney Motorway Corporation involve any guarantees to bidders about the construction of the:

- (1) Western Harbour Tunnel?
- (2) Beaches Link (Northern Beaches Tunnel)?
- (3) Sydney Gateway?
- (4) F6?

Answer-

No. The Government has announced it will sell 51 per cent of Sydney Motorway Corporation (SMC), the entity delivering WestConnex, to help fund the critical M4-M5 Link.

- *2164 SPORT—STADIUMS—Mr Graham asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
 - (1) How many corporate suites are there in the Sydney Football Stadium?
 - (2) How many corporate suites will there be in the rebuilt Sydney Football Stadium?
 - (3) How many corporate suites are there in the Olympic Stadium?
 - (4) How many corporate suites will there be in the refurbished Olympic Stadium?
 - (5) Does the \$729 million cost to demolish and rebuild the Sydney Football Stadium include the compensation paid to the Sydney Roosters, Waratahs, Cricket NSW and Sydney Football Club?
 - (6) Are there any parties who will receive compensation arising from this project?

Answer-

The Sydney Football Stadium currently has 51 suites and 155 outdoor boxes. Stadium Australia currently has 110 suites and 120 outdoor boxes. The number of corporate suites in the redeveloped venues is subject to finalisation of detailed design.

The Sydney Cricket and Sports Ground Trust will work with tenants to minimise disruption during the redevelopment of the Sydney Football Stadium. While work is being done with each of the tenants to determine impacts most associated disruption costs are expected to be borne by the Trust.

*2165 TRANSPORT AND INFRASTRUCTURE—NEW SUB-MEDIUM ELECTRIC STANDARD—Mr Graham asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—

Regarding the new sub-medium electric standard that is proposed to accommodate the new intercity fleet through the ten tunnels deviation:

- (1) When will the new sub-medium electric standard be adopted and published?
- (2) Who is the authority that approves the new sub-medium electric standard?
- (3) How are they independent of Transport for NSW?
- (4) The current standard (ESC 215) mandates that there be a contingency around the kinematic envelope of 200mm. What will this contingency be reduced to in the new standard and how was this figure determined?
- (5) Will there be public consultation about the new standard and its reduced contingency before it is adopted?
- (6) Has a simulation of the new intercity fleet rolling stock been undertaken to determine its kinematic performance given the actual track geometry on the Lithgow-Mt Victoria line?
 - (a) If so, what speeds were used in this simulation?
- (7) Will tighter maintenance regimes on the Mt Victoria-Lithgow line be required to accommodate the new intercity fleet?

- (a) If so, how will the maintenance regime change?
- (8) When will the new intercity fleet start running to Lithgow?

I am advised:

(1) to (7) The track used in the Ten Tunnels Deviation was originally ballast track. This type of track requires safety standards that factor in the range of sideways tilt that the trains may experience. The track in question was upgraded in the 1970's to accommodate the introduction of the V-Set trains. The upgrade lowered the tunnel floor, removed parts of the tunnel lining and replaced the existing ballast track with slab track. The proposed tunnel modifications to allow for the introduction of the New Intercity Fleet are similar to these works.

Slab track, compared to ballast track, has a much lower range of tilt and enables engineers to determine safety standards with more certainty as there is less natural movement of both the track and trains. Through detailed studies and computer simulations, the Assets Standards Authority has developed a set of standards for operating the new trains on this type of track. This allows the New Intercity Fleet to operate safely along the entire line. It is currently anticipated that these standards will be adopted in the latter part of 2018 and will be published on the Assets Standard Authority website when finalised.

- (8) The first trains in the New Intercity Fleet will begin testing and commissioning in early 2019. New trains will start operating on the Blue Mountains Line to Mount Victoria in mid-2020, followed by Lithgow a few months later.

*2168 PLANNING—PROPOSAL TO AMEND SUTHERLAND SHIRE LOCAL ENVIRONMENTAL PLAN 2015—Mr Mookhey asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Planning, Minister for Housing, and Special Minister for State—

I refer to the proposal that seeks to amend Sutherland Shire Local Environmental Plan 2015 to increase the maximum building height and floor space ratio for 10-14 Merton Street, Sutherland.:

- (1) Is the Minister aware that the Development Application (DA) has been knocked back twice and the Department of Planning is now using public money to employ an Independent Consultant to assist the Developer through the Gateway Process?
- (2) Does the Minister support the use of public money to employ an Independent Consultant to assist a Developer through the Gateway Process?

Answer-

I am advised:

- (1) A development application for residential flat buildings on the site was refused by Sutherland Shire Council in 2003 under the Sutherland Shire Local Environmental Plan 2000. The controls for the site were reviewed and updated in the Sutherland Shire Local Environmental Plan 2015. Council has since approved two development applications for residential flat buildings on the site in 2016 for 10 Merton Street, and in 2017 for 12-14 Merton Street.
- (2) The Environmental Planning and Assessment Regulation 2000 enables the Department of Planning and Environment to recover costs incurred as part of the rezoning review process from the proponent. The proponent has been invoiced for the full cost of this work.

- (5) The Department of Planning and Environment covered the cost of the Arts 2025 Summit.

- *2171 RACING—GREYHOUND RACING—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
 - (1) What was the budget for the Greyhounds Racing Integrity Commission in 2016/2017?
 - (2) What is the budget for the Greyhounds Racing Integrity Commission in 2017/2018?
 - (3) Is Greyhound Racing NSW required to fund any part of the Greyhound Racing Integrity Commission before July 2022?

- (1) The Greyhound Welfare & Integrity Commission (Commission) was established by the Greyhound Racing Act 2017 (GRA) on 3 July 2017.
- (2) The budget for GWIC in 2017/2018 is \$11 million.
- (3) GRNSW is required to provide funding to GWIC before 2022. .
- (4) Greyhound Racing NSW (GRNSW) is required to propose an annual target in consultation with the Commission and report on its performance in its annual report.
- (5) GRNSW submitted an annual stakeholder engagement plan in September 2017. The document has not been published.
- (6) GRNSW paid an operating licence fee of \$164,855 on 10 October 2017.
- (7) I have issued a statement of expectations to GRNSW, which includes expectations relating to animal welfare.

- (a) \$55m, completed in October 2016.

- (i) There was no additional cost to Transport for NSW.
- *2173 PRIMARY INDUSTRIES—GAME MEAT—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) How many game meat harvester vehicles are currently licensed by the NSW Food Authority?
 - (2) How many inspections of game meat harvester vehicles have been undertaken by the NSW Food Authority since 30 June 2016?
 - (3) How many game meat field depots are currently licensed by the NSW Food Authority and what are their locations?
 - (4) How many inspections of game meat field depots have been undertaken by the NSW Food Authority since 30 June 2016?

Answer-

- (1) 440 licensed game meat field harvesters.
- (2) 255 inspections of game meat field harvesters.

The licence categories of game meat field harvesting and game meat field chiller both attract a priority two risk classification, which for the Authority means audits are scheduled every two years for field chillers and inspections scheduled every three years for field harvesters. An annual report is prepared from the Authority's database to identify any facilities that have not been inspected within this period, and where gaps have been identified mandatory inspections are allocated to the local officer. This is indicative of the game meat field harvester inspection figures being less than the number of licenced facilities.

I am advised staffing information is available in the Authority's Annual Report.

Greyhound Racing NSW (GRNSW) advises that the Greyhounds as Pets facility at Wyee is used primarily for rehoming greyhounds and that in only limited circumstances the facility boards greyhounds for fee or reward. GRNSW advises that to the extent that it is considered that the Wyee facility is required to comply with the NSW Code of Practice No. 5 – Dogs and cats in animal boarding establishments, GRNSW confirms that the facility is compliant.

An industry specific code of practice for the welfare of greyhounds is currently being developed by the Greyhound Welfare and Integrity Commission, in consultation with the Greyhound Industry Animal Welfare Committee and Greyhound Racing NSW (GRNSW). While the Code is not yet finalised, it is likely to contain details of the welfare requirements for greyhound kennelling facilities, including shelters, pounds and breeding establishments.

As it is imperative that these renovations meet the requirements of the code of practice for the welfare of greyhounds currently being developed by the Greyhound Welfare & Integrity Commission, a decision regarding the GAP renovations will be made when this industry specific code is available.
- (3) Two.
- (4) In addition to being turned out twice a day, the existing kennel block provides greyhounds with access to the outdoors and natural light conditions.
