Answer—

There has been extensive research and analysis all coming to the same conclusion - mergers bring benefits to communities. KPMG was engaged to provide analysis over time, the outcome of this work is publicly available.

- *1363 LOCAL GOVERNMENT—COUNCIL ADMINISTRATOR DETERMINATIONS AND DECISIONS—Mr Primrose asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) For which Councils established or subsequent to May 2016 have you or the former Minister changed or overridden the determinations and decisions of the Administrator?
 - (2) What determinations and decisions were changed or overridden?

Answer-

I am advised:

Administrators are legally empowered to exercise all functions of the Mayor and Council. An administrator can refer any matter to the Minister for Local Government for a decision.

The NSW Government has advised Administrators on making decisions to ensure they are consistent with the Proclamations establishing new councils, the Local Government Act 1993, and guidelines assisting Administrators implement stronger, more efficient councils.

I am advised that four Interim General Managers have resigned.

I am advised that Administrators are subject to the same legislative provisions that require them to act with honesty and declare all pecuniary interests as any other citizen who wishes to stand for election as a councillor.

 - (2) Given reports that Wagga Wagga Rural Referral Hospital has put in place a senior recruitment freeze, is Wagga Wagga Rural Referral Hospital delaying in any way the recruitment of staff of any position level in any area?

Answer-

- (1) The new Wagga Wagga Rural Referral Hospital opened in January 2016. In the past 12 calendar months, the hospital has treated more than 3,000 additional admitted patients. In anticipation of increased patient activity, additional funding was made available to the hospital.
- (2) There is no recruitment freeze at Wagga Wagga Rural Referral Hospital.

Answer-

I am advised:

As you would be aware, during the 16 years that Labor were in Government, fares went up 87 per cent. Since Opal's introduction in 2012, Opal fares have not, on average, risen above CPI.

Opal card fares have not increased on trains and ferries since January 2015 and on buses and light rail since 2014.

The NSW Government has frozen fares for Opal card customers until July 2017 and has not made a final decision about the future of Opal fares.

- *1382 TRANSPORT AND INFRASTRUCTURE—LIGHT RAIL—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—
 - (1) What is the current operational capacity of the city bound Inner West Light Rail from 8am to 9am for each day Monday to Friday?
 - (2) What is the average operating load of the city bound Inner West Light Rail line between 8am and 9am for each day from Monday to Friday?
 - (3) What is the current operational capacity of the Dulwich Hill bound Inner West Light Rail from 5pm to 6pm for each day from Monday to Friday?
 - (4) What is the average operating load of the Dulwich Hill bound Inner West Light Rail line between 8am and 9am for each day from Monday to Friday?
 - (5) What is the forecast capacity of the CBD and South East Light Rail in both directions during peak hours for each day from Monday to Friday?
 - (6) What is the forecast capacity of the Parramatta Light Rail during peak hours in both directions?

- (3) Total operational capacity in the afternoon peak is the same as the morning peak

- *1383 PRIMARY INDUSTRIES—MACQUARIE PERCH—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—

 - (a) The answer to 1077 referred to the current indicative distribution of Macquarie Perch in the Wollangambe River catchment as at 2015 when the Clarence Colliery spill occurred.
- *1384 ENVIRONMENT—OFFICE OF ENVIRONMENT AND HERITAGE SURVEY—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for the Environment, Minister for Local Government, and Minister for Heritage—

Regarding a media release entitled 'Koala spotted crossing the road near Queanbeyan' issued by the Office of Environment and Heritage on 28 June 2016:

- (1) Has the Office of Environment and Heritage undertaken the survey alluded to in the media release: "NPWS plan to undertake surveys at Cuumbean in the coming months to get a much better picture of the population this reserve supports"?
 - (a) If yes, what were the results of the survey?
 - (b) Will the survey be publicly released?
 - (i) If not, why not?

Answer—

I am advised:

- (1) Yes.
 - (a) No Koalas were sighted therefore there were no results to publish.
 - (b) See A.
- *1385 RACING—ELECTRONIC GAMING MACHINES GAMBLING PREVALENCE STUDY—Mr Field asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—

In regards to the Government's recent commitment to undertake a gambling prevalence study this year:

- (1) Will the study be a survey, similar to the 2011 NSW Gambling Survey by Ogilvy Illumination?
- (2) When will the study be conducted?
- (3) When are the results expected to be finalised?
- (4) Will the Government consider undertaking a quantitative study, as opposed to a qualitative survey?

Answer—

A prevalence study is expected to commence in mid 2017 with results expected to be finalised by mid 2018. The study will be similar to the 2011 NSW Gambling Survey undertaken by Ogilvy (i.e. the study will explore participation in gambling activities, frequency of gambling, attitudes to gambling, impacts of gambling and help seeking behaviour). The study will be both quantitative and qualitative.

'Liquor and Gaming NSW is subject to legal restrictions which prohibit the disclosure of certain information obtained in the exercise of functions under gaming and liquor legislation'.

Transplant outcome data is managed and reported on annually by national transplant registries specific to each transplant specialty. The outcome data measures the organ function after transplant. Transplant surgery in NSW occurs in highly specialised transplant centres, each of which contributes outcome data to the relevant national registry.

It is NSW Health policy to offer the opportunity for organ donation to families/next of kin where someone dies in circumstances where organ donation is possible.

A National Donor Family Support Service has been established to provide support to families of organ and tissue donors. In NSW a Donor Family Support Coordinator is available through the N~W Organ and Tissue Donation Service to support families of deceased donors before, during and after donation.

Support is provided in a number of ways and differs depending on the donor family's needs. The service includes counselling or referral to local grief counsellors if preferred.

In 2012, the government released the Increasing Organ Donation- Government Plan. NSW has seen sustained increases in organ and tissue donation rates over the past five years and continues to support a 'whole of hospital' approach to organ donation to further boost donation and transplantation rates.

The plan outlines a range of strategies to strengthen the statewide systems for organ and tissue donation, improve organ donation outcomes in NSW hospitals, and, support Health staff to identify, effectively care for and get family support for organ donation for all potential donors.

The NDIA is also responsible for providing Information, Linkages and Capacity Building (ILC) to assist participants to build their independence and make informed choices. The NDIA ILC Commissioning Framework also confirms that NDIS registered providers of supports are also eligible to apply for a grant to deliver ILC activities.

After the transfer, all residents will have a Service Agreement with a provider to deliver support in relation to independent living in their home and an Accommodation Agreement with a Specialist Disability Accommodation provider outlining how the property and tenancy services will be managed.

The Accommodation Agreement will include residents' right to occupy their home, their responsibilities and the provider's responsibilities.

If an NDIS participant needs, or chooses to move, their Support Coordinator, funded by the NDIS, will assist the participant to find a new home.

House residents can vote to change their Supported Independent Living provider after two years if a majority of the residents (or their decision makers) are in agreement.

The Government is developing a strategy to transition state disability assets to best meet the needs of people with disability into the future under the NDIS.

While Cystic Fibrosis is not included as one of the conditions in List B of the National Disability Insurance Scheme (NDIS) Operational Guidelines - Access - Disability Requirements, the guidelines also clarify that the list is "not exhaustive and in no way suggests that a person with a condition different to those listed would not have a permanent impairment."

Ability Options, as part of a consortium, has been selected as a provider for the transfer of specialised disability services to the non-government sector.

The criteria for the tendering process for ADHC group homes included eight principles that residents, families and carers told FACS were most important to them when selecting a provider. Only service providers who showed they could deliver services to these standards were shortlisted.

As such, Queensland and South Australia do not have a central database of card holders and Western Australia does not record participant addresses.

- (a) An Australian Skills Quality Authority (ASQA) 2013 Report on Training for the White Card for Australia's Construction Industry noted that the majority of general construction induction training cards issued each year in Australia were from Queensland and Western Australia.
- (b) This information is not available.
