 - (1) Has any driver working on or in relation to the WestConnex project worked a day shift followed by a night shift or worked a night shift followed by a day shift?
 - (2) Do all contractors or subcontractors working on or in relation to the WestConnex project comply with the National Heavy Vehicle Regulator safety and compliance standards?

Answer-

I am advised:

This is a matter for the Minister for Western Sydney, Minister for WestConnex and Minister for Sport.

- *2131 WESTCONNEX—WESTCONNEX PROJECT—Mr Mookhey asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
 - (1) Has any driver working on or in relation to the WestConnex project worked a day shift followed by a night shift or worked a night shift followed by a day shift?
 - (2) Do all contractors or subcontractors working on or in relation to the WestConnex project comply with the National Heavy Vehicle Regulator safety and compliance standards?

Answer-

Safety is the highest priority in the delivery of the WestConnex project. All transport contractors working on the project are expected to comply with relevant laws and regulations and Sydney Motorway Corporation has a zero-tolerance approach to non-compliance.

I am advised that Sydney Motorway Corporation is not aware of circumstances where double shifting of individual drivers or operators has occurred .

- *2132 PRIMARY INDUSTRIES—APIARY SITES AND FEES—Mr Mookhey asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) What is the annual revenue received by the Local Land Services from apiary site fees since 2012-13?
 - (2) How many apiary sites are leased by Local Land Services?

Answer-

(1) Annual revenue received by Local Land Services since 2012/13 is shown in the table below:

It should be noted LLS was formed 1/1/2014, so figures are shown only since LLS commenced operations. 2017/18 figures are for the part financial year up to the date of the Question With Notice request.

While revenue varies from year to year based on seasonal conditions and related bee activity, the increase seen between 2016/17 and 2017/18 is largely due to the implementation of a standardised pricing system across all apiary sites on public land.

(2) LLS currently have 2,717 apiary sites under permit across the state.

- (1) Revenue received for the financial year 2016-17 was \$430,832 and for the financial year 2017-18 (to 31 March 2018) was \$410,142.
- *2135 TOURISM AND MAJOR EVENTS—NEWCASTLE 500 SUPERCARS—Mr Shoebridge asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Tourism and Major Events, and Assistant Minister for Skills—
 - (1) What is the final cost for contaminated waste from Newcastle 500?
 - (2) How does the answer to Question (1) compare to the amount initially budgeted?
 - (3) What damage was caused to roads in the area by the Newcastle 500 Supercars event?
 - (4) What are the costs of repairs to any roads damaged by the Newcastle 500 supercars event?
 - (a) Who will pay this cost?
 - (5) When will the results of Supercars sound monitoring during the Newcastle 500 be released to the public?
 - (6) How many sound level breaches occurred during the event?
 - (7) How did Destination NSW respond to sound level breaches?
 - (8) What steps were taken to inform the public of sound level breaches predicted in sound modelling for the event?
 - (9) What investigation occurred following the injury of two onlookers by debris during the race?
 - (a) Will the findings of any investigation be made public?
 - (10) What measures will be taken to ensure no such accident occurs again?
 - (11) What steps were taken to manage pollution from the event, in particular plastic and foam discarded by patrons?

Answer-

(1) The management of any contaminated waste relating to the Newcastle 500 event is the responsibility of Supercars Australia. Questions relating to the cost of contaminated waste should be addressed to Supercars Australia.

- (2) See answer to question 1.
- (3) Some road surfaces sustained minor damage during the Newcastle 500 race. Supercars Australia has repaired the damage.
- (4) The cost of repairs to the roads damaged by the Newcastle 500 race is the responsibility of Supercars Australia.
 - (a) See answer to question 4.
- (5) Supercars Australia is responsible for Newcastle 500 noise management. Supercars Australia conducted sound monitoring during the race. Data recorded will be used to assist in the planning of future races
- (6) As the Motor Racing (Sydney and Newcastle) Act 2008 does not include directions relating to noise levels, no breaches were reported.
- (7) See answer to question 6.
- (8) Supercars Australia widely communicated the findings of its noise management plan to the community online, by letterbox drop and during the residents' face-to face and community engagement meetings. Newcastle residents were also able to meet and discuss their concerns with Supercars Australia's Community Engagement Manager and the NSW Government's Newcastle 500 Coordination Office.
- (9) Investigations following incidents occurring during the Newcastle 500 race are the responsibility of SafeWork NSW and the Confederation of Australian Motor Sports, the motor racing governing body.

- (10) Destination NSW, the NSW Government's tourism anci major events agency, will continue to require that Supercars Australia meets the safety criteria specified by the Confederation of Australian Motor Sports and the Federation Internationale Automobile during future Newcastle 500 races.
- (11) Supercars Australia implemented a waste management plan for the inaugural Newcastle 500 event. Supercars Australia is putting in place strategies to reduce litter from future events, including plastic and foam discarded by patrons and event contractors.

What further works are being planned for Gordon Railway Station, a State Heritage listed station, to cope with the more commuters, as a result of the closure of the Epping line?

As part of the More Trains More Services program, Sydney Trains is extending the canopy on Platform 1 at Gordon Station, to protect customers in all weather conditions.

The canopy will encourage customers to spread evenly along the platform and use the full capacity of the train when boarding and alighting. This will reduce train dwell times at Gordon Station, particularly in the AM peak, and support the integration of Sydney Metro North West services and T1 North Shore services at Chatswood Station.

The canopy has been designed to respect the station's heritage importance.

There is no defined geographic area of a road reservation. The term road reservation refers to the status of the land. A single closure of road reservation may contain a very small or very large portion of road reservation.

However, I am able to confirm the total area of road closed each year.

(1) Approximately 14,400 hectares of road reservations were closed in 2015-16.

- (2) Approximately 11,800 hectares of road reservations were closed in 2016-17.
- (3) From 1 July 2017 to 11 April 2018 approximately 11,200 hectares of road reservations were closed.
