- \*2482 PRIMARY INDUSTRIES—RECREATIONAL FISHING—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) In relation to the Minister's previous answer that the Recreational Fishing Trusts financial reports are published online:
    - (a) Why was the 2016/17 Trust Fund Report not published until April 2018?
    - (b) Why was the latest three year Investment Plan published three and a half months after its commencement?
    - (c) When will the 2017/2018 Trust Fund Reports be published?
    - (d) Have annual reporting exemptions ever been requested from Treasury relating to either the Trust Funds or Department of Primary Industries?
  - (2) In relation to s239 of the Fisheries Management Act, what are the guidelines and provisions being used to determine what detail is written into the Trust Fund summaries on the application of money?
  - (3) Are these Trust Fund summaries audited or unaudited?
  - (4) Do the Recreational Fishing Trusts meet the reporting requirements of the Public Finance Audits Act?
    - (a) If not, why not?
  - (5) Has the Minister ever requested an independent audit of the Recreational Fishing Trusts?
    - (a) If yes, was it published?

#### Answer—

(1)

- (a) Section 239 of the Fisheries Management Act 1994 prescribes that a report on the application of money in the Recreational Fishing Trusts (and other Trust Funds) during each reporting year must be included in the Department of Industry's Annual Report. The relevant Annual Report for 2016/17 was published in 2017.
  - Each year, the Department of Industry also prepares a special purpose financial report, which is provided to Treasury and audited by the Audit Office.
  - Summary information on the Recreational Fishing Trusts is also published periodically on the Department of Primary Industries (DPI) Fisheries website to make it easy for the public to access information on programs run using funds from the Freshwater and Saltwater Trusts. This includes relevant extracts of the Department of Industry's Annual Report.
- (b) The Recreational Fishing Trusts Investment Plan is a non-statutory document and is not required to be published. NSW DPI publishes and periodically updates the document on the NSW DPI website for the information of fishers.
- (c) The NSW Department of Industry's Annual Report, with relevant reporting on the Recreational Fishing Trusts, will be published in 2018 in accordance with statutory timeframes.
- (d) Not to my knowledge.
- (2) The current format for reporting on the Recreational Fishing Trusts in the Department of Industry's Annual Report provides details on total grant funds received by the NSW Department of Industry to undertake various projects during each financial year.
- (3) The annual report of the NSW Department of Industry is tabled in Parliament each year. The special purpose financial reports on the seven Fisheries Trust Funds are provided to Treasury and audited by the Audit Office.

- \*2483 PRIMARY INDUSTRIES—RECREATIONAL FISHING ADVISORY COUNCIL—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) The Minister has previously said that the Recreational Fishing Advisory Council is the statutory body providing advice on expenditure from the Recreational Fishing Trusts. Has the Minister ever approved Trust funding for any projects against the advice/recommendation of his Advisory Council?
    - (a) If so, what programs?
  - (2) Has the Minister made Trust investment decisions without seeking the advice/recommendation of the Advisory Council?
    - (a) If so, what projects?
  - (3) Have all the projects and programs in the latest Investment Plan:
    - (a) Made application for funding in the current three year plan?
      - (i) If so, which ones?
      - (ii) If not, why not?
    - (b) Been assessed against the criteria by the Expenditure Committee and Advisory Council?
    - (c) Been recommended for approved funding by the Advisory Council?
  - (4) In the latest Investment plan, there is no mention of the funding for Strategy #6 of the Marine Estate Management Strategy (MEMA). Can the Minister clarify:
    - (a) What amount of Trust Funds are being allocated to this MEMA strategy?
    - (b) And what programs and projects are being initiated to facilitate strategy #6?

- \*2484 PRIMARY INDUSTRIES—FISHING PROJECTS—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) Regarding Recreational Fishing Trust Fund monies and investments since 2015/16:
    - (a) Which projects or programs were audited?
    - (b) Which of these audits were independently produced?
    - (c) Which projects or programs have been unsuccessful?
    - (d) Were relevant audits presented to the Expenditure Committees and Advisory Council members before funding applications were assessed?
  - (2) What audits or performance evaluations have been conducted for the Angler Access project to receive continued funding?
  - (3) The Fish For Life project was launched by the Deputy Director of Fisheries at the Australian Fishing Trade Association trade show on 24 July:

- (a) Is this a Trust funded project?
- (b) Who owns the Intellectual Property and "trademarks" to this brand?
- (c) Who did the Department of Primary Industries (DPI) consult with to develop the brand?
- (d) How much was budgeted to develop this project?
- (4) The Recreational Fishing Trusts have allocated funds for a Recreational Fishing Safety Officer project:
  - (a) How much funding has gone to this project in total?
  - (b) Who are the recipients of the funding?
  - (c) When will the funding expire?
- (5) How many DPI positions (fulltime and contractors) are remunerated by the Recreational Fishing Trusts?

## Answer—

(1)

- (a) Each year, the Department of Industry prepares a special purpose financial report for the Recreational Fishing Trusts which is provided to Treasury and audited by the NSW Audit Office. In addition, the Department's Internal Audit Program has undertaken the following audits since 2015-16 that covered Recreational Fishing Trust funds:
  - NSW Department of Industry Grants Administration (2015)
  - NSW Department of Primary Industries (DPI) Licence Revenue Management (2017/18)
- (b) Audit reports by the NSW Audit Office and the Department's Internal Audit Unit are independently produced.
- (c) There has been one termination of a deed for a whole project, which was being run by the Recreational Fishing Alliance of NSW using funds from the Recreational Fishing Trust, since 2015/16. The relevant project was titled 'NSW Crown Lands and Reserves vesting and securing recreational fishing access for the future'.
- (d) The above audit reports were not provided to the Recreational Fishing Trust Expenditure Committees and the Recreational Fishing NSW Advisory Council.
- (2) There are two projects with 'angler access' in the project title, these being the DPI Fisheries Manager (Inland Angler Access) project and the DPI Fisheries Management Officer (Inland Angler Access) project. With regard to project performance evaluations, DPI is responsible for administration of grants from the Recreational Fishing Trusts Funds and project managers submit milestone reports for Trust funded projects, which is used to monitor and track progress of projects.

A project milestone summary report is also made available to the Expenditure Committees and the Advisory Council on an ongoing basis to provide information on the progress of Trust projects.

(3)

- (a) No, it is part of a broader Trust Funded project related to recreational fishing information.
- (b) NSW DPI has applied to IP Australia to trademark Fish for Life.
- (c) DPI has been consulting with the Recreational Fishing NSW Advisory Council during development of the Fish for Life identifier.
- (d) Development of the Fish for Life identifier commenced as part of a broader project so there is no specific budget at this stage. Following development of the identifier, funding is now being sought from the Recreational Fishing Trust Funds for strategic implementation of the identifier on a broader scale, with a specific budget.

(4)

- (a) Funding of \$233,750 from the Recreational Fishing Trust Funds has been approved for the Recreational Fishing Safety Officer Project. DPI has disbursed \$70,125 to the project so far based on completed milestones.
- (b) The project is being undertaken by the Recreational Fishing Alliance of NSW.
- (c) The disbursement of funds from the Recreational Fishing Trust to the project by DPI is based on the progressive completion of milestones outlined in the funding deed between the Department of Industry and the Recreational Fishing Alliance of NSW. Funding for Trust projects usually expires when all funds have been disbursed and milestones completed.

(5) In 2017/18, based on recorded work effort, there were 64 Full Time Equivalent NSW Department of Industry staff paid to deliver priorities for recreational fishing in NSW using funds from the Recreational Fishing Trust.

During this period, no payroll contractors were acquired using funds from the Recreational Fishing Trusts. Please note the Department's definition of a contractor is an individual who is engaged to undertake operational work that would or could be regarded as work normally undertaken by an employee, but internal expertise is not available. These contractors are distinct from employees as they are engaged under a different set of legal arrangements.

- \*2485 PRIMARY INDUSTRIES—RECREATIONAL FISHING MEETING—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) On Monday 27 August 2018, the Minister held a meeting with a group claiming to be representatives for Recreational Fishing:
    - (a) Who was in attendance at the meeting?
    - (b) Were any commitments offered to the group by the Minister?
      - (i) If so, what were they?

(1)

- (a) Please refer to my quarterly diary disclosures, which are made publicly available on the Department of Premier and Cabinet website.
- (b) To manage the risks in the marine environment and use the fishing sector as part of the solution.
- \*2486 PRIMARY INDUSTRIES—PEAK BODY TENDER—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) In regards to the Peak Body Tender RFT ID DI-DPI-17-471 which closed on 9 February:
    - (a) What has been the reason or reasons for the repeated delays in making an announcement on the successful applicant?
    - (b) Has the Minister been informed of any concerns or complaints made about the tender applicants or processes?
    - (c) When does the Minister expect an announcement to be made on the tender?

## Answer-

(1)

- (a) I have been advised that delays have been necessary to ensure proper governance and due diligence.
- (b) Yes, once the tender had been finalised.
- (c) The matter is in the hands of the NSW Department of Primary Industries and is not for the Minister to determine.
- \*2487 PRIMARY INDUSTRIES—FISHERIES COMPLIANCE AND PENALTY NOTICES—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) Of the 2,268 penalty notices issued by Fisheries compliance officers during 2017/18:
    - (a) How much money was recovered from offenders?
    - (b) In what Treasury account were the recovered monies allocated?
    - (c) Can the Minister provide a breakdown of penalty notices issued by the three different enforcement/compliance projects funded by the Recreational Fishing Trusts?

## Answer-

(1)

(a) \$561,764.80 DPI Fisheries does not recover the monies owed from penalty notices that fisheries officers issue. Revenue NSW, a division of the Department of Finance, Services and Innovation

- administers the recovery of monies owed from penalty notices. DPI Fisheries receives updates from Revenue NSW relating to when and how fines issued by DPI fisheries officers are paid.
- (b) The majority of the recovered monies were paid into the Treasury Consolidated Fund and a smaller amount into the Marine Protected Areas Fund.
- (c) Coastal fisheries enforcement program (9 officers)
  - 185 Inland fisheries enforcement program (6 officers)
  - 145 Coastal recreational mobile squads (3 officers) 71
- \*2488 LANDS AND FORESTRY—CROWN LAND LEASE—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
  - (1) When did the lease over Crown land held by the Pambula preschool on Dingo Street, Pambula expire?
  - (2) When did the preschool provide the documents to the Department of Industry-Lands in order to renew the lease?
  - (3) Has the lease been renewed?
    - (a) If not, why not?
  - (4) If the lease has not been renewed, when can the preschool expect to be in a position to have a new lease?
  - (5) Which office in Crown Lands is dealing with this matter?
  - (6) How many meetings have been held between the preschool and Crown Lands since 2013?
  - (7) If the lease has not been renewed, is it usual business practice to take five years for a lease renewal application to be determined?
  - (8) Did the Member for Bega make representations to the Minister on the lease renewal?
    - (a) If so, when and on how many occasions?

- (1) 31 December 2013.
- (2) Documentation was initially provided to the department in 2013. The application was unable to be actioned at that time as land use investigations were ongoing. The department is now able to assess an application and on 25 September 2018 the applicant was advised of further documentation required.
- (3) No.
  - (a) An assessment will be undertaken when all relevant documentation has been received.
- (4) The land is subject to Aboriginal Land Claims. These claims will need to be dealt with before any lease can be offered.
- (5) Nowra Regional Office is managing the end of lease assessment report and Crown Property Services will manage the lease application, once all required documentation has been received.
- (6) All communications have been by telephone or in writing.
- (7) There are many factors that can impede efficient processing of a lease application.
- (8) This matter is being managed at Regional Office level, see Question 5.
- \*2489 HEALTH—WEE WAA MEDICAL CENTRE—Mr Mookhey asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Health, and Minister for Medical Research—
  - (1) To date, how many days in 2018 have in person general practitioner services been available in Wee Waa Medical Centre?
  - (2) How many full-time equivalent general practioners are currently employed at Wee Waa Medical Centre?

Wee Waa Medical Centre is a privately run GP practice and does not fall within my responsibilities as the Minister for Health.

- \*2490 ENERGY AND UTILITIES—NUCOAL SHAREHOLDER COMPENSATION—Revd Mr Nile asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
  - (1) Is the Minister aware of any representations made to the disenfranchised innocent shareholders of NuCoal that they would be paid compensation, or given any consideration, as a result of actions taken by the Government against the mining company?
  - (2) What steps does the Government contemplate to take to give proper restitution to those mum and dad shareholders?
  - (3) What does this situation tell potential shareholders and investors in New South Wales mining and energy industries?

- \*2491 ARTS—TWYFORD THEATRE PROJECT—Mr Secord asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
  - (1) Given you informed the Legislative Council on 18 October 2018 that \$7.4 million of funding announced by the Member for Bega, Andrew Constance MP and the Minister for Regional NSW and Deputy Premier, John Barilaro MP, for a new professional arts and theatre space at Twyford Hall ("the Twyford Theatre Project"), Merimbula, on Friday 25 May 2018 did not come from the Regional Cultural Fund, what specific Government funded program(s) did the funds come from?
  - (2) Was the Twyford Theatre project funding approved by the Government before the announcement was made by the Member for Bega and the Deputy Premier on 25 May 2018?
  - (3) When, and to whom will the funds be distributed to allow for the completion of the Twyford Theatre project?

Answer—

- \*2492 REGIONAL NEW SOUTH WALES—TWYFORD THEATRE PROJECT—Mr Secord asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
  - (1) Given the Minister for the Arts informed the Legislative Council on 18 October 2018 that \$7.4 million of funding announced by the Member for Bega, Andrew Constance MP and the Minister for Regional NSW, and Deputy Premier, Mr John Barilaro MP for a new professional arts and theatre space at Twyford Hall ("the Twyford Theatre Project"), Merimbula, on Friday 25 May 2018 did not come from the Regional Cultural Fund, what specific Government funded program(s) did the funds come from?
  - (2) Was the Twyford Theatre project funding approved by the Government before the announcement was made by the Member for Bega and the Deputy Premier on 25 May 2018?
  - (3) When, and to whom will the funds be distributed to allow for the completion of the Twyford Theatre project?

Answer-

Funding for the \$7.4 million Twyford Theatre Project is from the \$1.6 billion Regional Growth Fund. The Government is working with Twyford Hall Inc. regarding project details.

- \*2493 REGIONAL NEW SOUTH WALES—ROC PARTNERS ADVICE—Ms Voltz asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
  - (1) Have the details of the contract with Roc Partners for their advice on investments from the GO NSW Equity Fund been published as required by the Government Information Public Access Act?
    - (a) If so, on what date was the contract published?
    - (b) If not, why not?

No. Section 38 of the Government Information Public Access (GIPA) Act 2009 provides an exception for industry support contracts.

- \*2494 TREASURER—PARTIES TO THE PORT COMMITMENT DEEDS—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Treasurer, and Minister for Industrial Relations—
  - (1) In your answer to Budget Estimates supplementary question 91 you said: 'The parties to the Port Commitment Deeds (PCDs) are the Treasurer and the private sector port operators. Parties to the PCDs are set out in the leases, which are publicly available.'
    - (a) Does the word "Treasurer" appear anywhere in the lease for the Port of Newcastle?
      - (i) If so, on which page?
      - (ii) If not, how can the Treasurer be a party to the lease if the word "Treasurer" does not appear once in the document?
    - (b) Do the Port Commitment Deeds include any signatures?
      - (i) If so, who signed the Port Commitment Deeds?
      - (ii) If not, why not?
    - (c) Did the Treasurer sign the Port of Newcastle lease?
      - (i) If so, on which page?
      - (ii) If not, why not?
      - (iii) Are there any signatures on the lease apart from those on page 250 and if so, whose signatures are they?

## Answer—

(1)

- (a) No. The Treasurer is not a signatory to the long-term lease document.
- (b) Yes. The Port Commitment Deeds are signed by the Treasurer for and on behalf of the Crown in right of the State of New South Wales, and representatives of the Port Lessees, Port Managers and the purchasers.
- (c) No. The signatories to the lease are the lessor, Port of Newcastle Lessor Pty Ltd and the lessee, Port of Newcastle Investments (Property) Pty Ltd.
- \*2495 PREMIER—COMMUNITY BUILDING PARTNERSHIP PROGRAM GRANT—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Premier—
  - (1) Has the Australian Multicultural Christian Society returned the \$10,000 grant it received under the Community Building Partnership Program?
    - (a) If so, when was it returned?
    - (b) If not, what action, if any, has been taken?
    - (c) If not, will the Government pursue legal action to recover monies owed?

## Answer—

This question has been answered in Budget Estimates; I have since referred you to my answer.

I am disappointed you have not bothered to read my answer to General Purpose Standing Committee No.1, which was provided to the Committee on 2 October 2018.

\*2496 SPORT—WESTERN SYDNEY STADIUM DEVELOPMENT SITE—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—

- (1) Given Paul Doom's comments that the Government "will be seeking a commercial return on the space" in the North-West corner of the Western Sydney Stadium development site:
  - (a) Has the Minister requested any expression of interest for the development of that site?
  - (b) Has the Minister received any expressions of interest for the future development of that site?
    - (i) If so, from whom?
  - (c) Has the Minister held any discussions with organisations regarding potential future development of that site?
    - (i) If so, with whom?

- (a) No.
- (b) The NSW Police Citizens Youth Club has previously expressed interest in the site.
- (c) Ministerial diaries are publicly available.
- \*2497 SPORT—WESTERN SYDNEY STADIUM BATHROOMS—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
  - (1) How many women's toilets will Western Sydney Stadium provide in total?
    - (a) How many will be provided per floor/elevation?
    - (b) How many will be provided in total for general admission seats?
  - (2) How many disabled access toilets will Western Sydney Stadium provide in total?
    - (a) How many will be provided per floor/elevation?
    - (b) How many will be provided in total for general admission seats?

## Answer-

- (1) The new Western Sydney Stadium will have a total of 448 female patron toilets, excluding accessible and unisex toilets.
- (2) The new Western Sydney Stadium will have a total of 24 accessible toilets.
- \*2498 SPORT—WESTERN SYDNEY STADIUM PERMANENT DISABLED ACCESS SEATS—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—

How many permanent disabled access seats will be available in Western Sydney Stadium?

## Answer—

The new Western Sydney Stadium will have a total of 237 permanent accessible seats.

- \*2499 SPORT—WESTERN SYDNEY STADIUM DEDICATED PERMANENT DISABLED CAR SPACES—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
  - (1) How many dedicated permanent disabled car spaces will be available in parking lots attached to the Western Sydney Stadium?
    - (a) How many permanent disabled car spaces will be available in each car park?

Answer—

The new Western Sydney Stadium will reinstate car parks to the north and west of the stadium. There will be 7 permanent Disability Discrimination Act (DDA) compliant spaces in total. An additional 13 car spaces can be created by converting regular parking spaces to DDA spaces to suit operational requirements.

The southern carpark owned by Parramatta Park Trust also has 3 DDA compliant car spaces.

\*2500 SPORT—WESTERN SYDNEY STADIUM FOOD OUTLETS—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—

How many food outlets will be operating in the new Western Sydney Stadium?

## Answer—

The new Western Sydney Stadium will have 14 permanent food and beverage outlets, this will be supplemented by mobile kiosk provisions and barbeque areas. Suites,

Boxes and Media Areas also have food and beverage distribution locations.

- \*2501 SPORT—BATEMANS BAY AQUATIC AND CULTURAL CENTRE FUNDING—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
  - (1) Under what specific grant program or programs from within the Regional Growth Fund has funding been allocated to the Batemans Bay Aquatic and Cultural Centre?
  - (2) How much has been allocated from each type of program?
  - (3) When were these decisions made?

#### Answer—

1-3 The Regional Growth Fund is administered by the Deputy Premier and questions regarding grants under the Regional Growth Fund should be directed to him.

#### Answer-

I am advised: Exploration Licence Application (ELA) 5573 and ELA 5574 are over parts of Exploration Licence (EL) 6676 held by the Crown. EL 6676 was overlain by former coal exploration licences that were subject to the Independent Commission Against Corruption's (ICAC) investigation in 2013, not specifically EL 6676.

The Operational Allocation Framework was introduced to meet the Government's commitments to implement ICAC recommendations. ELA 5573 and ELA 5574 are being considered under the Operational Allocation Framework.

In accordance with the Operational Allocation Guidelines, all coal exploration licence applications are considered by the Coal Resource Operational Allocation Committee and taken to the Cabinet Standing Committee on Resources and Land Use prior to a final decision.

The market interest test was carried out in accordance with the Guidelines. Under clause 7.2 of the guidelines, for applications made against mining leases, such as ELA 5574, where the proposed allocation area could be part of a larger unallocated coal resource, the market interest test may also be conducted against the larger unallocated resource.

In any case, where the coal resource within the application area is likely to support a standalone mine or impact on a resource that could support a stand-alone mine, those facts are considered as part of the assessment of the application.
