Seven (7) Combat Sport Inspectors are employed by the Office of Sport on an ongoing basis and 15 are employed by the Office of Sport on a casual basis.

- *1852 SPORT—COMBAT SPORTS INSPECTORS TRAINING—Ms Voltz asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
 - (1) How many hours/days of training are provided to each Combat Sports Authority Inspector?
 - (a) Where is the training for Combat Sport Authority Inspectors delivered?

Combat sports inspectors are provided, as a minimum, annual face to face training consisting of 14 hours over two days. One 2-day training course and two 1-day training courses will occur in 2018. Training is provided at the Office of Sport, Sydney Olympic Park or other suitable venues such as Sydney Academy of Sport and Recreation, North Narrabeen.

- *1853 PREMIER—SAFE SCHOOLS PROGRAM—Revd Mr Nile asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Premier—

 - (2) Can the Premier inform the public whether under the new syllabus New South Wales school children as young as five and six are to be :
 - (a) Taught material that includes the concept of "Gender Fluidity"?
 - (b) Taught that "femininity and masculinity are not necessary inherent categories that pre-exist in each individual"?
 - (c) Encouraged to "resist" the "dominant social order" and move beyond "gender as binaryism" (sic)?
 - (d) Asked to challenge the way in which they live their life "as a girl or a boy"?
 - (e) Instructed that the "desirable ways of enacting gender" is often "contradictory or fluid"?
 - (3) Can the Premier further inform the public:
 - (a) Who was involved in the drafting and preparation of the new syllabus?

Answer-

Safe Schools is not, and has never been, part of the NSW curriculum. The NSW Education Standards Authority (NESA) does not promote the Safe Schools resources.

The Safe Schools resources were developed by the Safe Schools Coalition Australia, a nongovernment organisation funded by the Commonwealth Government's Department of Education and Training. The Commonwealth Government ceased funding the program on 30 June 2017.

The NSW Government and NESA have not consulted with the Safe Schools Coalition Australia in preparing the PDHPE K-10 syllabus.

- *1854 PLANNING—BANGALOW FOOD HUB DEVELOPMENT—Ms Walker asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) Does the development of the Bangalow Food Hub, 201 Lismore Road fit within the original intent of the Local Environment Plan that permits rural industries on agricultural land?
 - (a) Has the Minister sought or received any advice on the risk that this this development will set a precedent for the industrialisation of prime agricultural land in New South Wales?
 - (2) Is there any other RU1 zoned land in New South Wales that has a development of the nature of 201 Lismore Road currently under determination by a Joint Regional Planning Panel?
 - (3) Has the Minister sought or received any advice that this development may set a precedent that all RU1 zoned land can be turned into industrial estates/developments?
 - (4) Is there an Environmental Impact Statement on 201 Lismore Road?
 - (a) If not, why not given that this site is in the middle of a wildlife corridor with evidence of the vulnerable species Koala and other threatened species?
 - (5) Is there a Koala Mitigation process, or a Koala Plan of Management for 201 Lismore Road for the protection of this species which are protected under both State and Commonwealth Acts?
 - (a) If not, why not?
 - (6) What protections are being incorporated in the 201 Lismore Road development plan to protect the koala population?
 - (a) Why are there no plans for an overpass, when this development is on a busy regional road with evidence of high koala car strikes and mortalities?

I am advised:

- (1) This is a matter for the Northern Joint Regional Planning Panel to determine after considering the assessment of the application from Byron Shire Council staff.
 - (a) No, each development application is considered on its merits. Councils can determine whether rural industries are a suitable use for rural land within their local government areas.
- (2) There are currently no developments of a similar nature on RU1 zoned land that are being considered by a Joint Regional Planning Panel.
- (3) No, each Council can determine whether industrial uses, rural or otherwise, are permitted within their RU1 zone.
- (4) No, an Environmental Impact Statement is not required for this type of development.
 - (a) Council is responsible for ensuring adequate threatened species assessments have been undertaken to support this application.
- (5) No.
 - (a) This land does not meet the criteria that requires the preparation of a Koala Plan of Management. Council has recently requested information in relation to clearing of trees to better inform its assessment.
- (6) This is a matter for the Northern Joint Regional Planning Panel to determine after considering the assessment report from Byron Shire Council staff.
 - (a) This is also a matter for assessment by Council staff and determination by the JRPP.

- (2) Five Private Native Forestry plans have been terminated due to serious contraventions by the landholder of the plan.
- *1856 ASSISTANT MINISTER FOR SKILLS—LIDCOMBE TAFE CAMPUS—Ms Walker asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Tourism and Major Events, and Assistant Minister for Skills—
 - (1) Has the Government undertaken any planning to close, sell or repurpose the Lidcombe TAFE campus?
 - (2) Have facilities managers been given instructions not to do any more maintenance at Lidcombe TAFE campus?
 - (a) If so, why?

- *1857 LANDS AND FORESTRY—MOGO STATE FORESTS PULP LOGS AND SAWLOGS—Ms Walker asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
 - (1) What quantity of wood from Mogo State Forest Compartments 147 and 148 was supplied to mills in the Eden region, under the haulage subsidy arrangement funded by the Environment Trust "Protection of Koalas in Murrah Mumbulla Tanja Bermagui" project?
 - (a) What quantity of pulp logs?
 - (b) What quantity of sawlogs?

Answer-

(1)

- (a) and (b) The Environment Trust project is not a haulage subsidy. The NSW Government ceased timber harvesting in four State forests in the Eden Management Area as part of plans to conserve important Koala habitat in that area. Timber to meet long-term Government contracts with local customers is being sourced from forests further afield in the South Coast Management Area. The Environment Trust project is funding the additional costs which would have been incurred and passed onto customers in supplying timber from further afield. 373 tonnes of pulp logs and 311m3 of sawlogs have been supplied from compartments 147 and 148 of Mogo State Forest as part of this initiative.

 - (2) Was the decision to suspend logging a result of input by stakeholders and the community?
 - (a) Did the registration of three (3) significant trees by the National Trust in Compartment 148 contribute to the decision to suspend logging?
 - (b) Did the evidence of wombat holes in Compartment 148, provided by WIRES, contribute to the decision to suspend logging?
 - (c) Did the public meeting held by CoastWatch in Moruya, where the community expressed their concerns about logging in Mogo State Forest, contribute to the decision to suspend logging?

Answer-

- (1) (2) and (3) I am informed that timber harvesting was undertaken in several compartments in Mogo State Forest on the south coast earlier this year. Mogo State Forest is a regrowth forest that has been producing timber for generations and Forestry Corporation's current operations are harvesting timber from an area it has worked in and regenerated several times in the past. I am informed that Forestry Corporation. Forestry Corporation met with interested community members on site to discuss its operations and specific questions they had about wildlife in the area. Where possible, Forestry Corporation works with community members to amend operations to address concerns raised. The operations have not been suspended. Rather, timber harvesting operations in compartment 148 have concluded as per the harvest plan. Small areas were not harvested for silvicultural reasons (timber was either not mature or of poor quality) and some individual trees were protected as a result of feedback given during community consultation.
- *1860 ROADS, MARITIME AND FREIGHT—KOALA DEATHS ON PACIFIC HIGHWAY UPGRADE—Ms Walker asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Roads, Maritime and Freight—

As at 17 November 2017, no koalas have been killed as a direct result of clearing or construction works on the Pacific Highway Upgrade. Since the progressive installation of fauna fencing on existing highway north of Wardell began in November 2016 as part of the Woolgoolga to Ballina upgrade, there have been no koala road kills recorded.

- (1) Operations in pine plantations are regulated by the Department of Primary Industries (DPI) under the Plantation & Reafforestation Act. I am informed that neither Forestry Corporation nor DPI are aware of any claims Forestry Corporation is not following regulations in relation to timber harvesting activities in Bago State Forest.

- (1) We are in the early planning phase of the Western Sydney Strategic Sustainability Plan and consulting with key stakeholders, including environment groups. Our work has commenced with a detailed audit of existing data about biodiversity in Western Sydney. We will be filling in any gaps through on ground surveys. We have ecologists in Western Sydney now who are conducting surveys, and this work will continue through to January. We will be using the data gathered to understand the impacts of planned urban growth and to develop the conservation plan that will mitigate these impacts.
- (2) Exact timing of announcements is not known.
- (3) Public feedback will be an important part of the plan's development. We have a range of community engagement pathways planned, including community consultation in small groups to assist in development of the Plan, and public exhibition of the draft Plan. This will commence in the new year. We understand the Western Sydney community is interested in their local environment and they can rest assured that we will consider their feedback as we develop this plan.

When did the Department of Planning learn that the design for the Coal Handling and Processing Plant (CHPP) for the Maules Creek mine would be different to the design on which noise levels were modelled?

Answer-

I am advised:

 The noise modelling undertaken for the 2011 Environmental Assessment (EA) of the Maules Creek Coal Mine assumed sound power levels and indicative location details associated with the proposed Coal Handling and Processing Plant (CHPP).

A modification to the EA in 2013 changed the orientation of the CHPP and associated facilities and further noise assessment confirmed that the noise predictions at receptors were consistent with the original EA.

The 2015 Annual Review for the Maules Creek Coal Mine identified that the sound power levels for the CHPP exceeded the levels used in the EA for the mine.

An official caution was issued by the Department on 8 June 2016 under the Environmental Planning and Assessment Act 1979.

Since then, Whitehaven has implemented a range of mitigation measures to reduce noise levels at the mine, including installing additional panels around the CHPP.

Regardless of noise generated by specific plant and equipment, the mining operations must continue to meet strict off-site noise limits at surrounding residences.

The Department of Planning and Environment will continue to carefully monitor compliance with these limits to ensure the local community is adequately protected.

(1) \$3.8 billion has been allocated to the Corrective Services NSW Prison Bed Capacity Program. The amount includes capital and recurrent allocations.

Capital allocations and the associated amounts spent for the Immediate Future Needs, Rapid Build Prisons and Medium Term Needs components of the Prison Bed Capacity Program.

The additional beds are in the form of modular cells and conversions of one-out cells into two-out cells will accommodation both maximum and minimum security male and female inmates.

Beds are being added at centres including Metropolitan Special Programs Centre, the Metropolitan Remand and Reception Centre, and Cessnock, Dillwynia, Bathurst, the Mid North Coast Correctional Centre, South Coast Correctional Centre, Junee Correctional Centre and Parklea Correctional Centre.

The former Wollongong Community Offender Support Centre at Unanderra has been re-purposed as the Illawarra Reintegration Centre.

The Mary Wade Correctional Centre was recently opened.

To put this into context, it is worth noting that, although some years have very low or no flow, the average annual flow at Wilcannia (near the bottom of the unregulated system and effectively the inflow to the Menindee system), measured for over 100 years, is greater than 1,730,000 megalitres per year, meaning more than a full Menindee system every year on average.
