\*426 **ROADS, MARITIME AND FREIGHT—CAR REGISTRATION RECORDS**—Dr Faruqi asked the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

Answer—

I am advised:

Roads and Maritime Services is not aware of any ongoing issues related to the integration of Roads and Maritime Services databases with those of Service NSW. Roads and Maritime uses reasonable efforts to ensure vehicle registration records are up to date and accurate. Measures are taken to correct errors whenever detected or notified to Roads and Maritime by customers or other enforcement agencies.

SafeWork NSW (formerly WorkCover) does not have the authority or jurisdiction to investigate allegations of child sex abuse.

Given the serious nature of such allegations, the NSW Police Force is rightly the appropriate law enforcement agency to investigate such matters.

I am advised:

- (1) For inmates discharged in 2014 the average length of time was 227.6 days.
- (2) Sentenced inmates can expect to spend at least their non-parole period in custody. Inmates with a total sentence of more than three years can only be released to parole if the State Parole Authority approves their release. There is no expected length of time for remand inmates because courts decide whether these inmates are released on bail or convicted and sentenced to imprisonment.
- (3) On average, inmates discharged in 2014 spent 17.7% of their time in custody on remand.
- (4) Corrective Services NSW delivers adult literacy and numeracy programs to develop inmate core skills to Australian Core Skills Framework (ACSF) level 3. The time to complete these programs varies dependent on the inmate's skills level. In general, inmates with the lowest literacy and numeracy skills require up to 480 hours of participation in literacy programs to develop skills to ACSF level 3.
