*504 PRIMARY INDUSTRIES—FISHING THREATS TO THE GREY NURSE SHARK POPUATION—Ms Sharpe asked the Minister for Primary Industries, and Minister for Lands and Water—

(1) Given that one of the major threats to the Grey Nurse Shark is hooking by recreational anglers, how does the Minister for Primary Industries ensure compliance enforcement by the Department of Primary Industries Fisheries officers at Fish Rock and Green Island near South West Rocks on the Mid North Coast?

Answer—

(1) The critically endangered Greynurse Shark is provided protection by the Department of Primary Industries using a number of compliance measures. Fish Rock and Green Island are two of a number of critical habitat sites along our coast that have special rules specifically designed to protect the sharks. Line fishing using bait (other than artificial baits and lures), is prohibited in those areas. Spear fishing restrictions, and a Code of Conduct for divers also apply there.

Fisheries Officers from the Hastings fisheries district based at Port Macquarie patrol the Fish Rock and Green Island Greynurse Shark critical habitat areas. Additional patrols are conducted from the larger offshore Fisheries Patrol Vessel ('FPV Swan') when patrolling that part of the coast, and with other statutory authorities (eg: Roads and Maritime Services) in joint operations. There is further capacity to conduct special operations to target high risk offenders in the area by the department's Special Operations and Investigations Group.

Patrols of these areas are planned using available resources on a risk based approach that provides for an effective deterrence and promotion of voluntary compliance across a range of fishery programs.

NSW Fisheries Officers also provide compliance patrols of the Greynurse Shark population at the nearby Cod Grounds marine reserve off Laurieton, under State/Commonwealth arrangements.

Advisory information is widely available to fishers via the department's website, and publications such as the "NSW Saltwater Guide" and "Protecting the Greynurse Shark: A guide for recreational fishers and divers". An identification guide for NSW sharks is readily available to commercial fishers and this details both the Greynurse shark and closely-related and also protected Herbsts nurse shark. There are advisory signs located at boat ramps within the vicinity of these locations, and departmental officers regularly provide face-to-face contact with key stakeholders to explain the fishing rules.

(1) Fisheries Officers plan patrols of Fish Rock and Green Island using risk based principles. Patrols are conducted when reports of illegally activity are received, and during periods of high recreational fishing, particularly over the summer school holidays and extending through the offshore game fishing period to April. Land-based covert surveillance is also used to determine fishing activity and requirements for additional on-water patrols.

Patrols may utilise district resources, the state wide offshore patrol vessel 'FPV Swan', or vessels from other authorities in joint operations.

Since January this year Fish Rock and Green Island have been patrolled on four occasions by the FPV Swan. In addition, three joint patrols of the area have been conducted by fisheries officers with RMS boating service officers. In the same period the district patrol vessel has been used on four occasions to patrol Greynurse Shark habitat at the Cod Grounds.

Last financial year 100 hours were spent patrolling the area by district fisheries officers.

Vessel logbook records do not necessarily identify specific patrols to Fish Rock and Green Island as patrols encompass other fisheries programs, and include larger offshore areas - and estuary systems.

(1) Departmental officers have found no information to substantiate any discussion between Fisheries Officers and the Macleay Argus earlier this year regarding illegal fishing at Fish Rock and Green Island.

What can be confirmed is that, in 2015, two persons were apprehended by fisheries officers using bait within the critical habitat zone at Fish Rock. On 5 January a 44yo male was issued a \$500 penalty notice for using bait approximately 60m from Fish Rock. On 29 March a 31yo male was issued a \$500 penalty notice for using live bait approximately 100m from Fish Rock. This later penalty was withdrawn following a written representation and an official caution issued for the offence.

The public is always encouraged to report suspected illegal fishing in these areas by contacting the local fisheries office, completing an on-line illegal fishing form or by calling the Fishers Watch illegal fishing phone line which has the capacity to send audio messages to fisheries officers in real time. There is also an online reporting function on the Department of Primary Industries' Fisheries webpage if people would like to make an anonymous report.
