\*1459 LOCAL GOVERNMENT—LOCAL COUNCIL ENGINEERS—Mr Primrose asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for the Environment, Minister for Local Government, and Minister for Heritage—

What are the reasons that the Government does not require local councils in New South Wales to have a professional engineer as a member of their senior staff?

Answer-

I am advised:

It is a matter for individual councils to determine their workforce.

\*1460 TRANSPORT AND INFRASTRUCTURE—CBD AND SOUTH EAST LIGHT RAIL BENEFIT-TO-COST RATIO—Mr Mookhey asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—

When was the Minister first informed that the benefit-to-cost ratio of the CBD and South East Light Rail had decreased from 2:4 to 1:4?

Answer—

At the time I became Minister the BCR was 1:4.

Answer—

I am advised:

- (1) The NightRide bus service expenses are included in Transport for NSW annual reports.
- (2) The average number of trips between 2012-13 and 2015-16 was 64,860 per year.
- (3) The NSW Bureau of Crime Statistics and Research (BOCSAR) records incidents of crime reported to Police. BOCSAR records are a matter for the Minister for Police.

- \*1462 EDUCATION—BOTTLED WATER FOR SCHOOLS—Mr Mookhey asked the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education representing the Minister for Education—
  - (1) How many schools in New South Wales has the Department of Education instructed to only provide bottled water to students?
    - (a) Please include a list of school names.
  - (2) How many public schools in New South Wales are in areas where there is no local water supply for human consumption or where the local water supply is considered unsafe for human consumption?
    - (a) Please include a list of school names.
  - (3) How many public schools in New South Wales have been issued with boil water notices
    - (a) Please include a list of school names and how many times a boil water notice has been issued to.each school.

Answer—

(1) and (2) I am advised that government schools that provide bottled water to students and use rainwater tanks are listed on the Department of Education's website.

The department requires individual schools to use bottled water for a short period, if needed, should a water quality issue be identified while remediation works are undertaken.

I'm advised there are no government schools in areas where the water supply is unfit for human consumption.

(3) I am advised that boil water notices are issued by NSW Health when required. The Department of Education does not hold this information.

\*1463 TRANSPORT AND INFRASTRUCTURE—CBD AND SOUTH EAST LIGHT RAIL DISABILITY ACCESS—Mr Mookhey asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—

In relation to the Government's plans regarding the CBD and South-East light rail:

Answer-

I am advised:

The CBD and South East Light Rail project will be fully compliant with all required accessibility standards including the Disability Discrimination Act 1992. It will be accessible for commuters with a disability and wheelchair accessible.

In relation to awarding Another Slice of Life Australia Pty Ltd grant funding of \$80,000 in 2010 and \$150,000 in 2013 under the Government's Community Building Partnership program (South Coast electorate) for the construction of a workshed and other facilities at the location of the organisation's sustainable living and vegetable gardens:

- (5) Is the Government concerned that the facilities for which funding was provided under the program were built on private land that is owned by the husband of the Managing Director of Another Slice of Life Australia Pty Ltd, given that the land in question is now advertised for sale, including these additional facilities, for a price of \$410,000, an increase of almost seven times the purchase price of \$61,000 paid in 2007?
  - (a) If so, what action will the Government take to investigate this matter and the role of the relevant State Member of Parliament in assessing and allocating the funding of these projects?
- (6) What provisions are in place to ensure community funding grants provided by the Government are not able to be used in any way that would allow a private individual to benefit financially from any improvements that grant funds may have made to a private property or land holding?

(1) to (5) I am advised the Member for South Coast has no conflict of interest relating to Another Slice of Life or its directors.

The Government is currently reviewing the circumstances of the grants awarded to Another Slice of Life Australia and has ordered an independent audit. Following the audit, the Government will determine the appropriate action, including options for repayment.

As you are aware, the Community Building Partnership Grants Program was established by the former Labor government of which you were a member.
