 - (1) Is the Minister aware of the report from the Herald Sun on Monday 21 May that suggests the City of Melbourne will be applying guidelines that avoid classifying children according to gender and discourages boys-only and girls-only activities?
 - (2) Can the Minister advise whether children in New South Wales will find popular books such as Thomas the Tank Engine, Noddy and Winnie the Pooh banned from libraries and schools?
 - (3) Does the Government propose or plan to follow this example which will effectively prevent children as young as three from developing their unique gender identity as they mature into young adults?
