- *1289 LANDS AND FORESTRY—TALUS STREET RESERVE—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
 - (1) What is the status of the lease and any proposed sub tenancies over the Talus Street Reserve?

Answer-

The Head Lease is due to expire on 4 April 2018. The status of the Head Lease over the Talus Street Reserve is currently the subject of ongoing litigation and is a matter for the manager of the Talus Street Reserve Trust. The status of any proposed sub tenancies is a matter for the Head Lessee.

- *1290 LANDS AND FORESTRY—GOSFORD PUBLIC SCHOOL SITE—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
 - (1) Is the Gosford Public School site located on Crown Land? If not, what is its status?
 - (a) If so, is it reserved or dedicated and for what public purpose?
 - (2) Was the site transferred or vested in another Government agency? If so, when?
 - (3) When was the Minister administering the Crown Lands Act 1989 advised that the Government was considering the sale, lease or any other dealing in the site?
 - (4) Was a land assessment carried out over the site in accordance with the Crown Lands Act 1989? If not, why not?
 - (5) Has an Aboriginal Land Claim been lodged over the former Gosford Public School site? If so, when?
 - (6) Has the Minister determined the claim? If not, why not?

Answer-

- (1) No. The former Gosford Public School site is not located on Crown land administered under the Crown Lands Act 1989. It is currently held in freehold title by Property NSW.
- (2) It is understood the site was previously held in freehold title by the Minister for Education and Minister for Education and Training and was vested to Property NSW pursuant to the Government Property NSW Amendment (Transfer of Property) Order 2016 published on the NSW Government Legislation website on 29 April 2016.
- (3) This site is not on Crown land, therefore the Minister administering the Crown Lands Act 1989 cannot administrate.
- (4) No. As the site is not on Crown land.
- (5) No. As the former Gosford Public School site is not located on Crown land it is not "claimable Crown land" as defined by the Aboriginal Land Rights Act 1983.
- (6) No. There is no Aboriginal Land Claim to determine.
- *1291 LANDS AND FORESTRY—POPPY PARK LAND CLAIMS—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
 - (1) Is the public reserve at Gosford known as "Poppy Park" located on Crown Land?
 - (2) If so, is it reserved or dedicated and for what public purpose?
 - (3) Has an Aboriginal Land Claim been lodged over the reserve? and If so, when was it lodged?
 - (4) Has the Minister determined the claim? If not, why not?

Answer-

- (1) Yes.
- (2) The subject land was partly reserved for "public recreation" in 1972 and partly in 2004 by addition to

the existing Reserve 78162.

- (3) Yes. The subject land and adjoining Crown land is subject to a series of Aboriginal Land Claims lodged by the Darkinjung Local Aboriginal Land Council on 1 October 2015.
- (4) No, the Aboriginal land claim has not been determined.

There are a large number of Aboriginal land claims across NSW that are assessed in order of receipt or otherwise on an agreed priority basis.

The process of investigating Aboriginal land claims is both exhaustive and necessary to satisfy the statutory requirements of the legislation and precedents of the Courts.

*1292 LANDS AND FORESTRY—ROOKWOOD NECROPOLIS TRUST—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—

What remuneration is paid to the Chair and two members of the Rookwood Necropolis Trust, appointed for a two year term commencing 1 December 2016?

Answer-

Remuneration of Crown cemetery trust boards, including the Rookwood Necropolis Trust Board, is based on an evaluation performed by the Public Service Commission.

The Chair of Rookwood Necropolis Trust is remunerated at the rate of \$35,000 per annum.

The other Rookwood Necropolis Trust board members are paid employees of the operational trusts that deliver cemetery services at Rookwood, and are therefore not entitled to board remuneration.

 - (a) 2013-14 9.7 (incl. 1 contingent worker) Admin support included in total nil.
 - (b) 2014-15 13.8 (incl. 1 contingent worker) Admin support included in total 0.9.
 - (c) 2015-16 27.8 (incl. 1 contingent worker) Admin support included in total 1.6.

Total also includes Biodiversity Reform 5 FTE; secondments/special projects/Landcare initiative 5 FTE.

*1296 PLANNING—URBANGROWTH NORTH PARRAMATTA GROWTH TRANSFORMATION—Mr

- *1296 PLANNING—URBANGROWTH NORTH PARRAMATTA GROWTH TRANSFORMATION—Mr Shoebridge asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) Under the proposed UrbanGrowth North Parramatta Growth Transformation Program what buildings within the heritage core will remain in public ownership?
 - (2) Will any new buildings be erected within the heritage core, if so, what?
 - (3) Have the geotechnical and/or archaeological investigations into the site begun?
 - (4) Will there be a complete archaeological investigation of the sub floor areas of the Matron's Quarters, Lying In Hospital and 3rd Class sleeping quarters?
 - (5) What are the proposed uses and/or readaptive uses of the Female Factory site?
 - (6) UrbanGrowth have stated that their conservation investigation and planning will enable consideration of a National heritage Listing, what steps is UrbanGrowth taking to consider this?
 - (7) Are any further steps being taken to consider a World Heritage Listing for the site?

Answer-

I am Advised:

- (1) Most of the heritage buildings within the heritage core and in public open space areas are expected to remain in public ownership.
- (2) A: No residential buildings are proposed within the heritage core. The site zoning does allow for two support buildings within the heritage core, such as for bathrooms or additional rooms to support future uses.
- (3) Yes. These investigations are underway. They commenced in December 2016 and are expected to be completed by mid-2017.
- (4) The historical archaeological investigations currently underway within the former Female Factory are to develop a methodology to undertake repairs to those buildings whose structural stability is compromised. The three buildings referred to are not undergoing structural repairs, hence no archaeological investigations are taking place there. However, if ground disturbance is required, then further archaeological investigations will take place.
- (5) No decisions have yet been made on the future uses of the heritage core. The vast majority of the heritage core buildings are occupied by Health NSW. Vacant building 104 (former asylum) is undergoing emergency heritage repair to stabilise and waterproof it. In November 2016 UrbanGrowth NSW held a community event, Sprout, seeking the community's and heritage specialists' views on possible future uses for the former Female Factory site. UrbanGrowth NSW is researching a number of exemplar case studies (including international sites) where heritage buildings and spaces have been conserved and re-purposed. Our investigation will also analyse governance and maintenance structures.
- (6) UrbanGrowth NSW has been liaising with the Historic Heritage Section of the Federal Department of Environment and Energy in relation to the Parramatta Female Factory heritage, and will continue this liaison. The Department manages the process for including a place on the Federal Heritage List. UrbanGrowth NSW sent a letter of support for the National Heritage Listing to the Federal Department of Environment and Energy.
- (7) UrbanGrowth NSW is not aware of any action to consider a World heritage listing for this sight.

- *1298 PRIMARY INDUSTRIES—KENSINGTON POND EMBANKMENT PROJECT—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) On what date did the Dam Safety Committee list the Kensington Centennial Park Pond as a prescribed dam?
 - (2) What was the reason the Dam Safety Committee listed the Kensington Centennial Park Pond as a prescribed dam?
 - (3) Who is the owner of the Kensington Centennial Park Pond?

Answer-

- (1) On 10 May 2016 the NSW Dams Safety Committee (DSC) informed (by letter) Mr Robert Casimir, Design Manager, Sydney Light Rail project that at the DSC's May 2016 meeting a decision was made to prescribe the pond. According to the Dams Safety Act 1978 a prescribed dam means a dam that is specified in schedule 1 of the Act. This is usually updated annually by way of Government Gazettal and when this next occurs the schedule will list the pond.
- (2) Significant deficiency in flood capacity and the results of dam break assessment work carried out by consultants working on the project.
- (3) Transport for NSW is acting as the dam owner during construction and through operation of the Sydney Light Rail.
- *1299 TRANSPORT AND INFRASTRUCTURE—KENSINGTON POND EMBANKMENT PROJECT—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—

- *1301 TRANSPORT AND INFRASTRUCTURE—METRO OFFSETS—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—
 - (1) What is the Government's detailed plan to fully offset the greenhouse gas emissions of electricity consumed by the operation of the Sydney Metro?

Answer-

I am advised:

The NSW Government remains committed to offsetting the greenhouse gas emissions from operational electricity use for Sydney Metro.

In early 2016 the commencement of a procurement process to secure a power supply for Sydney Metro Northwest and associated offsets via a renewable energy source was announced. The procurement process is scheduled to be substantially complete by mid-2017. This allows enough time for any new generator capacity to be installed in 2019 when Sydney Metro Northwest will commence operations.

- *1302 ENVIRONMENT—SMITHS LAKE FISH DIE OFF—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) What was the cause of the Smiths Lake fish die off in December 2016?
 - (2) What actions is the Office of Environment and Heritage taking to prevent a recurrence of another similar fish die off?

Answer—

- *1303 PRIMARY INDUSTRIES—SMITHS LAKE FISH DIE OFF—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) What was the cause of the Smiths Lake fish die off in December 2016?
 - (2) What actions is the Department of Primary Industries taking to prevent a recurrence of another similar the fish die off?

Answer—

(1) I am aware of a fish kill at Symes Bay (Smiths Lake) which occurred over a number of days during early December 2016. Symes Bay is a shallow bay within Smiths Lake and forms part of the Port Stephens-Great Lakes Marine Park.

Fisheries Officers from the Department of Primary Industries inspected the site on 13 December 2016 and found large numbers of dead and dying Mullet. Initial investigations indicated no abnormal water quality issues as being the likely cause; however it was reported that the water temperature was high.

Following initial field investigations, water and fish samples were collected and submitted for analysis with the Department's Elizabeth Macarthur Agricultural Institute (EMAI). Water quality tests showed no significant toxicants or other issues that could have contributed to the fish kill.

The analysis of water quality readings and sampled fish found evidence to support a finding that a combination of environmental factors (high water temperatures) and opportunistic parasitism by a protozoal pathogen (Trichodina spp) (determined from histopathology and further molecular investigation) contributed to the mortalities. These protozoal outbreaks are known to occur in fish when under stress. The observed elevated water temperatures are likely to have created an ideal environment for this type of protozoal infestation.

(2) Fish kills in coastal intermittently closed and open lagoons and lakes (ICOLLS) can be a natural occurrence. A review of my Department's fish kill database indicates that fish kills are more likely to occur in summer. This is likely to be due to the generally higher water temperatures which can contribute to changes in water quality or other environmental factors.

My Department will continue to work closely with other relevant State agencies and local government on developing strategies to improve the health and resilience of coastal lakes and the broader NSW marine estate.

- *1304 ENVIRONMENT—ASBESTOS FIRE WORKS—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) Are commercial fireworks operators in New South Wales required to store fireworks in containers that have asbestos?
 - (2) Did the 2016/2017 Sydney Harbour New Year's Eve fireworks contractor use storage containers that had asbestos?
 - (3) Are there any environmental or human health risks of the use of asbestos in containers by commercial fireworks operators?

Answer-

This question should be directed to the Minister for Finance, Services and Property.

- *1305 PRIMARY INDUSTRIES—DOLPHIN MARINE MAGIC POOL—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
 - (1) What specifically was the metal fragment swallowed by the dolphin calf Ji-Ling at Dolphin Marine Magic?
 - (2) Are the facilities at Dolphin Marine Magic suitable for breeding seals?
 - (3) Can you please provide an update in relation to the formal undertaking by Dolphin Marine Magic in relation to the proposed new seal pool?

Answer-

- (1) A small flat piece of metal of unknown origin.
- (2) The facilities are suitable for breeding
- (3) It is not appropriate to provide information on ongoing operational compliance and enforcement action being undertaken by the Department of Primary Industries.
- *1306 ENVIRONMENT—GORE BAY OIL SPILL—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) How much oil was spilled into Sydney Harbour during the Gore Bay oil spill on December 30, 2016?
 - (2) What was the cause of the spill?
 - (3) What was the environmental impact of the spill?
 - (4) Why did it take the Environment Protection Authority two months to direct Viva Energy to clean up a marine fuel oil spill at their Gore Bay Terminal in Greenwich?

I am advised:

- (1) The amount of material and cause of the spill is subject to the Environment Protection Authority's (EPA) ongoing investigation.
- (2) See Question 1.
- (3) The EPA has engaged the Office of Environment and Heritage to obtain expert advice on the cleanup, as well as the Sydney Institute of Marine Science and the University of NSW to assist with assessment of environmental harm.
- (4) A clean-up operation began immediately with EPA on site.
- *1307 ROADS, MARITIME AND FREIGHT—GORE BAY OIL SPILL—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Roads, Maritime and Freight—
 - (1) Who held the Port Safety Operations Licence previous to the current holder of the licence?
 - (2) Is the Minister satisfied with the performance of the Port Safety Operations Licence holder in relation to the Gore Bay oil spill on December 30, 2016?

Answer-

I am advised:

- (1) The then Sydney Ports Corporation.
- (2) The Port Authority of New South Wales responded appropriately as set out in its Port Safety Operating Licence. A boom was deployed at Gore Cove to contain the spill to the shoreline/water interface and no contamination occurred beyond that area.

- (1) A total of 46 shark sightings were seen over the Christmas Holiday period (19 December 2016 to 29 January 2017 excluding 25 December 2016). Twenty six were sharks 2m or larger in total length and therefore considered as potentially dangerous. These larger shark sightings comprised of 14 Bull Sharks, 5 White Sharks, 2 Mako Sharks and 5 unidentified Whaler Shark species. Most shark sightings were at Redhead Beach, Lake Macquarie (23 shark sightings). Sixteen of the Redhead shark sightings were sharks of 2m or larger, 10 of which were identified as Bull Sharks and one as a White Shark.
- (2) Flights were conducted at five locations; Lennox Head (Seven Mile Beach), Ballina (Shelley and Lighthouse Beach), Evans Head (Main Beach and Shark Bay), Redhead (Redhead Beach), and Kiama (Surf Beach and Kendall's beach).
- (3) A total of 1080 flights (18-25 mins in duration depending on what was seen and environmental conditions) were flown up to 40 days from 19 December 2016 to 29 January 2017 (excluding 25th December). The contracts were for 41 days of flying but weather conditions prevented flights on 1-5 days among the five locations. On each day the contractors were required to undertake six flights flights are limited by battery life and on most days six flights were undertaken.

- (4) Flights were flown every day of the NSW Summer School Holidays (19 December 2016 to 29 January 2017 excluding 25 December 2016). The first flight each day was flown at 07:30 (EDST), with consecutive flights at half hour intervals. Pilots deviated from this if a circuit required multiple batteries (e.g. if a hazardous shark is sighted and requires monitoring beyond a battery's capacity), or if a shark sighting is declared between scheduled flights.
- (5) The total cost of the drone trials over the NSW Summer School Holiday period was \$142,342.
- (6) While there was no academy established, the NSW Department of Primary Industries (DPI) requires contractors to hold Remotely Piloted Aircraft System (RPAS) qualifications. The Department of Primary Industries (DPI) Fisheries provided the contracted drone pilots with flight details, safety procedures, and communication protocols.
- (7) No drone pilot training was provided by NSW DPI. NSW DPI uses qualified RPAS contractors at each location. Four companies were used across the five locations.
- (8) No drone flights were conducted at night (as per Civil Aviation Services Authority regulations and the current certified flight plans). The current research and bather protection program associated with the NSW DPI Shark Management Strategy is for coverage during daylight hours.
