3 STATEMENT BY PRESIDENT—CENTENARY OF THE FIRST WORLD WAR

The President made a statement acknowledging the role of the Sea Transport Service during the First World War.

Mr Gay informed the House that on Wednesday 26 August 2015, the following appointments were made:

Mr Daryl Maguire MP ceased to be Parliamentary Secretary for Veterans and the Centenary of ANZAC and was appointed as Parliamentary Secretary for Corrections, Emergency Services, Veterans and the Centenary of ANZAC,

Mr John Sidoti MP ceased to be Parliamentary Secretary for Transport and Roads and was appointed as Parliamentary Secretary for Transport, Roads, Industry, Resources and Energy, and

Dr Geoffery Lee MP ceased to be Parliamentary Secretary for Communities and was appointed as Parliamentary Secretary for Multiculturalism.

5 GRAFTON REGIONAL ART GALLERY (Formal Business)

Mrs Houssos moved, according to notice:

1. That this House notes:

- (a) that the Grafton Regional Art Gallery was opened in March 1988 and now holds the largest collection of artworks on the North Coast of New South Wales,
- (b) the important role the Grafton Regional Art Gallery plays in its local community, fostering arts and cultural connections in a major regional centre of New South Wales, and

- (c) that the Grafton Regional Art Gallery's biennial Jacaranda Acquisitive Drawing Award was first established in 1988 and has become a nationally recognised award for high-calibre artists residing in Australia.
- 2. That this House notes that the Grafton Regional Art Gallery currently has seven exhibitions on display.
- 3. That this House notes:
 - (a) the exhibition 'Bunarm Bologaman Wahl Bundjalung', or 'Brothers Coming Together of the Bundjalung Nation', a celebration of Bundjalung culture by twelve leading Bundjalung artists, and
 - (b) the Gallery's custodianship of the internationally renowned Lindt collection of photographs from the early 1870s, largely considered to be the most truthful and artistic depictions of traditional Aboriginal Australians to exist.
- 4. That this House notes the visit of the Leader of the Opposition Mr Luke Foley MP and the Honourable Courtney Houssos MLC to the Grafton Regional Art Gallery on Wednesday 8 July 2015.
- 5. That this House commends and encourages the Grafton Regional Art Gallery for its work, and further acknowledges and congratulates Director Jude McBean for her successful leadership of the gallery.

6 ROYAL SAMOAN POLICE BAND (Formal Business)

 - (c) Carriageworks is widely regarded as Australia's foremost contemporary multi-arts centre and works with diverse communities throughout New South Wales, and is a not for profit organisation, financially supported by the New South Wales Ministry for the Arts, and
 - (d) those who attended as guests at the welcoming function included:
 - (i) Mr Fonoti Manogiamanu Etuale Ioane, Samoan Consul-General in Sydney,
 - (ii) the Honourable David Clarke MLC, Parliamentary Secretary for Justice, representing the Honourable Troy Grant MP, Deputy Premier and Minister for Justice and Police, Minister for the Arts and Minister for Racing,
 - (iii) Muagututia Vailolo, Chair of the Samoa Council,
 - (iv) Malaemie Fruean, Chair of the New South Wales Council for Pacific Communities,
 - (v) Superintendent Nafo'itoa Alesana Laki, Royal Samoan Police Band,
 - (vi) Inspector Sala Opetaia Lauina, Royal Samoan Police Band,
 - (vii) Michel Tuffery, artist,

- (viii) Sam Mostyn, Acting Chair of the Carriageworks Board,
- (ix) Lisa Havilah, Director, Carriageworks,
- (x) Ms Donna Ingram who provided a Welcome to Country,
- (xi) approximately 300 members of South Pacific Islander communities in New South Wales

- (a) welcomes the Royal Samoan Police Band on the occasion of its first visit to New South Wales and congratulates it for its successful performance tour of the state, and
- (b) commends Carriageworks for its part in the organisation of the Royal Samoan Police Band's tour of New South Wales and for its ongoing work as a contemporary multi-arts centre for the people of New South Wales.

13 GENERAL PURPOSE STANDING COMMITTEE NO. 2—REFERENCE

The Chair (Mr Donnelly), according to paragraph 2 of the resolution establishing the general purpose standing committees, informed the House that on Tuesday 1 September 2015, General Purpose Standing Committee No. 2 resolved to adopt the following terms of reference:

That the General Purpose Standing Committee No. 2 inquire into and report on matters relating to elder abuse in New South Wales including:

- (a) the prevalence of abuse (including but not limited to financial abuse, physical abuse, sexual abuse, psychological abuse and neglect) experienced by persons aged 50 years or older in New South Wales,
- (b) the most common forms of abuse experienced by older persons and the most common relationships or settings in which abuse occurs,
- (c) the types of government and/or community support services sought by, or on behalf of, victims of elder abuse and the nature of service received from those agencies and organisations,
- (d) the adequacy of the powers of the NSW Police Force to respond to allegations of elder abuse,

- (e) identifying any constraints to elder abuse being reported and best practice strategies to address such constraints,
- (f) identifying any strength based initiatives which empower older persons to better protect themselves from risks of abuse as they age,
- (g) the effectiveness of New South Wales laws, policies, services and strategies, including the 2014 Interagency Policy 'Preventing and Responding to Abuse of Older People', in safeguarding older persons from abuse,
- (h) the possible development of long-term systems and proactive measures to respond to the increasing numbers of older persons, including consideration of cultural diversity among older persons, so as to prevent abuse,
- (i) the consideration of new proposals or initiatives which may enhance existing strategies for safeguarding older persons who may be vulnerable to abuse, and
- (j) any other related matter.
