- (a) On 12 August 2015 the department was advised by Lake Macquarie City Council (LMCC) that there have been rubbish problems on Elizabeth Island from people camping and from day visitors. The department has not received any indication from the local community or from LMCC that the rubbish problem was "excessive".
- (b) The department had not been formally advised of a problem with excessive rubbish on the island until very recently.

- (6) Excess rubbish was removed from the island on the weekend of 17-18 August 2015
- (7) DPI Lands will consult with Council, the community and key agencies about future management of the island. Restricting or preventing access to the island would be difficult.

*436 LANDS AND WATER, PRIMARY INDUSTRIES—ABORIGINAL LAND CLAIMS—Mr Veitch asked the Minister for Primary Industries, and Minister for Lands and Water—

- (a) Over the past four years how many private surveyors have been contracted by the Government in the determination of Aboriginal land claims?
- (b) How many Aboriginal land claims have private surveyors been contracted for?
- (2) What was the cost to the Government of the use of private surveyors for this purpose?

- (a) Over the past four years, approximately 24 external surveyors have been contracted by DPI Lands to survey land granted through the determination of Aboriginal Land Claims.
- (b) Over the past four years, external surveyors have been contracted to survey land granted for about 72 Aboriginal Land Claims. In some instances a single survey of land granted may involve multiple Aboriginal Land Claims.
- (2) Over the past four years, the cost to DPI Lands for the use of external surveyors was about \$3.8M. The cost and time required for each survey varies due to the terrain, vegetation and size of the parcel of land to be surveyed.

The new service in Cowra will be complementary to the self-dialysis service currently offered in Young.

Answer-

(1) to (8) Multicultural NSW staff will be located in the single head office location.

Service NSW will be accepting translation bookings. There are currently 41 shopfronts in operation and this will be increased to over 50. This is a massive expansion of service provision to the people of NSW.

Instead of only having access during business hours and limited locations – clients now have access 7 am to 7 pm and also on Saturdays.

The NSW Government is proud of these achievements and improvements to services and access to the people of NSW.

 to (4) The NSW Government embarked on significant reforms to the former Community Relations Commission. Following changes to Governance arrangements a new Chief Executive Officer was engaged in January 2014.

The Chief Executive Officer was tasked with leading an extensive review and stakeholder consultation of the former Community Relations Commission during 2014.

Outcomes and recommendations of this review process are reflected in the strategic plan, Harmony In Action 2014-2017, which is a road map to make NSW number one in Multicultural Practice.

The review included a recommendation to change the organisation's structure to enable Multicultural NSW to deliver improved services:

• By putting a focus on lifting the Community Engagement and Policy and Research capacity of the agency, and

• By putting a focus on Innovative Language Services and expanding access to these services to the people of NSW

Multicultural NSW has developed a structure that best delivers its strategic and legislative objectives.

I am advised by the Department of Justice that in accordance with the Government response an additional Aboriginal Witness Assistance Service (WAS) Officer has recently been appointed so that there are now three Aboriginal WAS Officers employed by the Office of the Director of Public Prosecutions (Recommendation 3).

I am further advised that the Department of Justice has conducted an initial review and a round table will be held with relevant stakeholders to discuss cultural awareness training for the legal profession (Recommendation 4 and 5).

Regarding Recommendation 6, this question should be directed to the NSW Parliament to provide an update.

I am advised the Judicial Commission expects to complete its review shortly and Justice Wood's report is due later this year (Recommendations 7 and 8).

I am advised that no application for retrial has been received to date (Recommendation 9).

- *444 FAMILY AND COMMUNITY SERVICES—BOWRAVILLE INQUIRY RECOMMEDATIONS—Mr Shoebridge asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for Family and Community Services, and Minister for Social Housing—

Answer-

The Department of Premier and Cabinet is coordinating the implementation of the recommendations made in this report and these have been allocated to different government departments.

The Department of Family and Community Services (FACS) is responsible for responding to Recommendation 14 of the Standing Committee on Law and Justice Report "The family response to the murders in Bowraville" Report 55 November 2014.

This report states that the NSW Government funds the Nambucca Youth Services Centre to provide outreach services, particularly Aboriginal youth services, in Bowraville.

FACS is working with the Nambucca Valley Youth Services Centre and other stakeholders to identify options for youth services and activities for young people in Bowraville. The Nambucca Valley Youth

Services Centre will receive \$50,000 in order to provide youth services for Aboriginal young people in Bowraville.

They are also being assisted by FACS to organise a planning day in the first week of October. This will assist the centre with its business and governance planning and scope youth service projects funded by the \$50,000.

FACS has established a Youth Services in Bowraville Working Group to support its response to Recommendation 14. Membership includes representatives from Family and Community Services, Mid North Coast Local Health District, Aboriginal Affairs, Department of Premier and Cabinet, Nambucca Valley Youth Service Centre and Nambucca Shire Council and is being extended to the families and other community members.

A draft service proposal has been developed and is being distributed for consultation.

*445 LANDS AND WATER—TRAVELLING STOCK RESERVES—Ms Barham asked the Minister for Primary Industries, and Minister for Lands and Water—

- (1) The Minister for Lands and Water has stated previously on ABC Landline that the Local Land Services is doing a review of Travelling Stock Reserves (TSRs). When will this review be completed and will the results of this review be made publicly available?
- (2) Will the Minister commit to putting a moratorium on long term leases of TSRs until this review is completed?
- (3) What is the status of the pilot program initiated by the Government to determine the future ownership or management of TSRs?
- (4) Is the Minister aware of Local Land Services issuing permits for five year grazing leases on TSR lands?
- (5) What are the details of long term leases of TSRs throughout the state?
- (6) How many long term grazing permits have been issued?
- (7) What are the policy reasons for issuing long term leases of TSRs?
- (8) Has a management framework been developed for long term leasing of TSRs?
- (9) Will the Government commit to putting a moratorium on issuing any permits for long term use of TSRs until a management framework is in place?
- (10) Has an audit of TSRs been undertaken to determine, among other things, their:
 - (a) management regime?
 - (b) ecological, economic, social & heritage value?
 - (c) status including leasing arrangement such as short, long and none?
 - (d) connectivity to other TSRs?
- (11) Is the Minister aware that a Dubbo-based action group, Combined Action to Retain Routes for Travelling Stock (CARRTS), initiated a petition on 25 June calling on the Government to refrain from fencing off, leasing or selling TSR land, and requesting that the Government to commence an immediate review which includes consultation with drovers and graziers?
- (12) Has the Minister met with CARRTS?

Answer-

- (1) Over the next few months, Local Land Services will consult with a wide range of stakeholders to develop a state-wide draft management plan and 11 draft regional management plans.
- (2) No. There is no evidence to suggest that long term permits are harmful.
- (3) See question one.
- (4) Yes. However, the process of granting longer term permits for TSRs is not new. It is common practice. The reason they are now being advertised is that, under previous arrangements, the governance surrounding the granting of some of the longer term permits wasn't strong, and there were grievances expressed about the "closed shop" nature of some processes.
- (5) Long term permits vary in length between 12 months to five years throughout the state. A range of factors are considered when granting annual or longer term permits. Permit holders who access TSRs must satisfy particular conditions which are provided with the permit.

- (6) Approximately 1,394 long term grazing permits have been issued or are being advertised across the state.
- (7) Based on the recommendations of Local Boards, Local Land Services is lengthening some longer term grazing permits from 12 months up to five years to increase maintenance and biodiversity outcomes.

- (9) No. Again, long-term permits are not new. The process for gaining a long-term permit is simply more transparent.

*446 LANDS AND WATER—BOYD RIVER TRAVELLING STOCK RESERVES—Ms Barham asked the Minister for Primary Industries, and Minister for Lands and Water—

- (1) Is the Minister for Lands and Water aware that Travelling Stock Reserves (TSRs) along the Boyd River (approximately 54 kilometres south west of Grafton, Google map coordinates -29.851580, 152.555768) are being used for overnight camping, music 'raves' and recreational four-wheel driving which is causing damage to the TSR and a nuisance to the public?
- (2) Are the Boyd River TSRs considered 'controlled TSRs' or 'managed TSRs' under the Local Land Services Act 2013?
- (3) What are the details of any designated 'stock watering places' within the Boyd River TSRs?
- (4) What current and historical permits apply to these TSRs?
- (5) Will the Minister implement a section 70 closure order to protect the Boyd River TSRs?
- (6) Has the Minister exercised his discretion under s 34AA of the Crown Lands Act 1989 to validate any secondary interests concerning any of the Boyd River TSRs?
- (7) When has the Minister exercised his discretion under s 34AA of the Crown Lands Act 1989 to validate any 'secondary interests' relating to TSRs anywhere in the state? Please provide a list.

Answer-

- (1) North Coast Local Land Services is aware that Travelling Stock Reserves (TSRs) are being used for camping and other activities, which are illegal.
 - (a) Camping is an allowed activity under permit from Local Land Services. Permits are issued regularly for camping in this area. The area is monitored on a regular basis for this activity and, in particular, during high traffic periods such as school holidays.
 - (b) Music 'raves' and four wheel driving are not approved activities for TSRs. These activities are also monitored during inspections of the area. In order to control the illegal activities, Local Land Services' staff make regular visits to the area.

Further to this, North Coast Local Land Services was part of a multi-agency operation in the Boyd River area on 19-21 September 2014, which included NSW Police, Forest Corporation of NSW, Rural Fire Service and the Department of Primary Industries. This operation targeted illegal activities that related to each organisation's area of operations.

- (2) Boyd River TSRs are considered as controlled TSRs. The definition of controlled travelling stock reserve within Part 6 of the Local Land Services Act means:
 - (a) a travelling stock reserve the care, control and management of which is vested in Local Land Services under this Part, or
 - (b) a travelling stock reserve that is a stock watering place for which Local Land Services is the controlling authority under Part 7.
- (3) None of the TSRs within the Boyd River area are designated as stock watering places.

- (4) The TSRs in the Boyd River area have been subject to a number of different types of permits. These include month-to-month agistment permits for cattle and current Annual Grazing Permits. All of these comply with current requirements of the Act and Regulations.
- (5) The Section 70 Closure Order relates to closing the TSR for purposes which are allowed under the Act, such as recreation (Section 62 of the LLS Regulation 2014) or grazing. The activities described relating to music 'raves' and four wheel driving are currently not allowed under the Act. Consequently, a Closure Order will be of no benefit in restricting these illegal activities.
