#### (Paper No. 159)

- \*2295 ATTORNEY GENERAL—THE CASE OF TOMMY ROBINSON—Revd Mr Nile asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Attorney General—
  - (1) Is the Attorney General familiar with the case of Tommy Robinson, who has been imprisoned for 13 months in the UK allegedly for reporting about the sentencing of criminals found guilty of child grooming and exploitation?

(2) the Attorney General further aware of that fact that the UK media had initially been gagged from reporting about Robinson's treatment?

We there similar laws in New South Wales that restrict the liberty of the press to report on similar issues of public concern. If so, will the Government take action to ensure the full liberty of the press to report on issues of public concern?

Answer-

In NSW, legislation governing non-publication orders and suppression orders carefully balances the need for open justice against the fair administration of justice.

- \*2296 PREMIER—ABORIGINAL CULTURE AND HERITAGE LAWS—Revd Mr Nile asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Premier—
  - (1) What concrete steps has the Government made to give effect to the commitments made by its predecessor in 2011 for a revised process for the reform of Aboriginal culture and heritage laws?
  - (2) When will the Government provide a response to the submissions received on the Aboriginal Heritage Bill 2018, which closed on 20 April this year?
  - (3) What is the forecast budget allocated to enforce any new Aboriginal heritage laws?
  - (4) Can the Government provide a timeline for implementing any new laws to protect and manage Aboriginal heritage?

#### Answer-

The NSW Liberals & Nationals Government is committed to providing a legal framework that respects and conserves Aboriginal cultural heritage in New South Wales.

Answer-

(1) Revenue NSW does not hold data on the income percentiles of individuals.

\*2299 PLANNING—WILPINJONG EXTENSION PROJECT—Mr Shoebridge asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Planning, Minister for Housing, and Special Minister for State—

- (1) What internal process will be undertaken within the Department of Planning and Environment to approve the Wilpinjong Extension Project Social Impact Management Plan when it is lodged?
- (2) What section of the Department of Planning and Environment will be responsible for approving the Wilpinjong Extension Project Social Impact Management Plan when it is lodged?
- (3) What social science expertise will be available within the Department of Planning and Environment to decide that the lodged Wilpinjong Extension Project Social Impact Management Plan meets the requirements of Condition 68 under the consent granted in April 2017?

#### Answer—

I am advised:

- (1) The Department will review the Social Impact Management Plan to ensure it meets the requirements set out in the development consent for the mine. The review will also consider the outcomes of consultation undertaken to prepare the plan, including input from Mid-Western Regional Council, the Wilpinjong Community Consultative Committee, and the local community.
- (2) The plan is required to be prepared to the satisfaction of the Secretary. The Planning Services division within the Department is responsible for reviewing management plans and staff within the division may approve these plans under delegation.
- (3) The Department has dedicated social impact assessment expertise available to provide input into the review of the Social Impact Management Plan.
- \*2300 TRANSPORT AND INFRASTRUCTURE—ROYAL RANDWICK LIGHT RAIL STOP—Dr Faruqi asked the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—
  - (1) Why has the light rail stop located on Alison Road near the intersection with Darley Road been named after the Royal Randwick Racecourse despite public submissions to name the stop Centennial Park?
  - (2) How does the naming of this stop align with the Geographical Naming Board's guidelines, including the section on name duplication?
  - (3) In the draft of proposed names, did Transport for NSW recommend Centennial Park as a name?
    - (a) If yes, why was this recommendation not taken up?
  - (4) Will the submissions received by the Geographical Names Board on naming of this stop be publically released?
    - (a) If so, when?
    - (b) If not, why not?

Answer—

I am advised:

(1) and (3) Multiple names for the 19 stops were formulated as part of the Transport for NSW consultation process prior to a formal application being made to the Geographical Names Board . A

potential name for the light rail stop in question was chosen following extensive stakeholder consultation.

- \*2301 ROADS, MARITIME AND FREIGHT—FREDERICK STREET UPGRADE—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Roads, Maritime and Freight—
  - (1) Why are safety improvements in Ashfield, on Frederick Street at John Street and Henry Street not being completed within the original completion target of end of June?
  - (2) Please provide a date for when all the safety improvements in Ashfield on Frederick Street at John Street and Henry Street will be completed?

Answer-

- (1) A minor delay has been experienced due to Ausgrid lighting approvals. Roads and Maritime Services is working with Ausgrid to facilitate these approvals as soon as possible.
- (2) The revised completion date is September 2018.
- \*2302 RACING—FREEDOM OF INFORMATION—Dr Faruqi asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry representing the Minister for Lands and Forestry, and Minister for Racing—
  - (1) Will Greyhound Racing NSW be subject to the Government Information (Public Access) Act 2009 once the Greyhound Racing Act 2017 is fully commenced?
  - (2) Will the Greyhound Racing Integrity Commission be subject to the Government Information (Public Access) act 2009 once it is established?

#### 7 JUNE 2018

#### (Paper No. 161)

- \*2303 PRIMARY INDUSTRIES—COMMERCIAL FISHERS—Mr Veitch asked the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—
  - (1) How many fishers were able to purchase shares in the share trading market with fees outstanding?
  - (2) How many fishers are still unable to pay their fees as of 1 June 2018?
  - (3) What is the total debt to fisheries at this point of time from unpaid fees?
  - (4) Are these fishers allowed to fish?
  - (5) Why is there no breakdown in the annual report on commercial fishing expenditure?(a) Will there be a breakdown on the BAP income and expenses?
  - (6) How many fishing businesses received more than half a million dollars in subsidy in the share trading?
  - (7) How many fishers were allowed to sell fishing businesses in the market and then buy some method of shares in the market?

Answer-

(1) Fishers were not excluded from participating in the subsidised share trading market on the basis of having outstanding fees. However, fishers did sign a participation deed allowing any outstanding debt to be deducted from the proceeds of the sale of shares or any fishing business buyout payment

they received. The Department of Primary Industries (DPI) cannot retrospectively determine how many of the fishers who purchased shares in the market had outstanding fees at the time.

- (2) I am advised that DPI cannot answer this question as it does not speak for commercial fishers in relation to their capacity to pay.
- (3) Currently there is \$1,995,615, including a significant residual debt that some abalone shareholders are paying off annually in addition to their annual management charges. DPI is following up any outstanding debt with fishers.
- (4) Yes.
- (5) and,
  - (a) Commercial fishing related expenditure can usually be found in the section related to Commercial Fishing Trust Fund reports. The 2016/17 Annual Report stated, "Expenditure by the department on activities relating to commercial fishing is funded from consolidated revenue with a contribution from the Commercial Fishing Trust Fund. Charges are levied for services such as licence administration and management, but are not project-specific. The Commercial Fishing Trust Fund also makes a contribution to research and uses funds to leverage research and development support from other sources. The NSW abalone and rock lobster fisheries are subject to cost recovery of attributable costs, although there is still some degree of government contribution and budgets are negotiated in detail with the relevant management advisory committees. In 2016–17, the Commercial Fishing Trust Fund contributed \$4.147 million to the department's Commercial Fishery related programs."
- (6) None.
- (7) There were two fishing business owners that cancelled one fishing business in the market and simultaneously bought other shares in a different fishing business. This was not against the rules of the share trading market. In fact, one of the aims of the fishing business buyout program was to allow fishers to consolidate multiple businesses if so desired.

The US Supreme Court case of Masterpiece Cakeshop Ltd v Colorado Civil Rights Commission 584 US (2018) has no legal effect in Australia and no bearing on NSW law.

The NSW Government is committed to ensuring that all laws in NSW are fit for purpose and that everyone in NSW is treated equally and fairly under the law. The Government will consider the Expert Panel report into religious freedom chaired by the Hon Philip Ruddock, and the Commonwealth Government response to that report.

- (6) In order to ensure continuity of course delivery and minimise the impact of the flood on students, all courses were temporarily relocated to nearby locations following the closure of the Lismore campus.
- (7) TAFE NSW -Wollongbar and Casino, Southern Cross University's Lismore Campus, the Lismore Conservatorium, St. Vincent's Hospital Lismore, 104 Conway Street and 88 Keen Street, Lismore.

In which financial year did the Government's previous decision to stop funding three year-olds in preschool take effect?

#### Answer-

The NSW Government's Start Strong program is the first funding model that extends subsidies to all children in the year before school and to all 3 year olds enrolled in a community preschool, from 2019 onwards.

Previously, the funding prioritised all children in the year before school and children from low socioeconomic backgrounds, and for children from Aboriginal families.

The Resource Allocation Model funded some children in the year before school and 3 year olds under a capped model. This meant that funding was only available to a capped number of children at each service, without regard to their age.

Universal funding for three year olds has never occurred under previous funding models.

As part of the 2018-19 Budget, the NSW Liberals and Nationals became the first state in Australia to fund universal access for three year olds in community preschools.

Due to a record investment of \$474 million dollars allocated in the 2018-19 Budget, more children than ever before will have access to 600 hours of quality early childhood education.

Research shows that quality preschool education benefits children the most in the year before school, and two years of quality preschool education has even greater benefits for vulnerable and disadvantaged children. Priority of access guidelines are important to ensure that support goes to where it is most needed and where it makes the most impact.

Priority of access will continue under Start Strong even after 3 year old subsidies are introduced in 2019.

- (a) Yes. The model was in the process of being accredited by the Murray-Darling Basin Authority (MDBA) during this period. Changes required by the MDBA are part of this process, which gave rise to a different model run number.
- (b) Both model versions were submitted to the MDBA for Independent Review to determine its representation of Murray-Darling Basin Cap conditions. The model version LT92\_30 was ultimately accredited through the Independent Review process.
- (c) Models are used to estimate water taken in accordance with the rules in the Water Sharing Plans. Concurrence is not required to update these estimates. Concurrence is only required for amendments to clauses of the Plan, such as changes to conditions that change the timing and volumes of diversions, or environmental releases. The change to reference of model version occurs as a Note in the Water Sharing Plan. The Plan specifically states that notes in the text of the Plan do not form part of the Plan (clause 8(5)).
- (d) Model version BD007e.sqq produced a Long Term Average Annual Extraction Limit of 196 GL/year. The modelled embargoes reduced this to 189 GL/year averaged over the same period for model version LT\_92\_30.sqq.
- (e) The models, developed between 2009 and 2012, reflect the Murray-Darling Basin cap modelling process. The model reports developed for the cap process are written to enable independent modelling experts to review and accredit the models. They are technical documents.

The models were accredited as part of MDBA governance processes, which included a panel of technical experts from all basin states and territories.

The cap will be replaced by the Murray-Darling Basin plan sustainable diversion limits from 1 July 2019. As part of this process the updated sustainable diversion limit models will be assessed by the MDBA and accredited by the Commonwealth Minister for Agriculture and Water Resources. Once accredited, the model reports will be made public. The sustainable diversion limit models will be developed using the most up to date information and knowledge.
