Answer-

As outlined in my media release on 22 July 2020, I have asked the NSW Education Standards Authority (NESA) to review its processes for endorsing professional development providers and their courses. This review is due to be completed this month, with new accreditation procedures to apply to all courses and providers from 2021.

NESA made a factual error on 21 October 2020 in its response to the Daily Telegraph regarding the status of a professional development course offered by the NSW Teachers Federation.

NESA has also acknowledged that it incorrectly advised me about the status of this course offered by the NSW Teachers Federation.

NESA has apologised unreservedly for the error.

The Department of Education does not directly endorse or recommend any externally developed professional learning.

- *2538 ATTORNEY GENERAL—PROVISIONS OF THE SUCCESSION ACT 2006—Mr Latham asked the Minister for Education and Early Childhood Learning representing the Attorney General, and Minister for the Prevention of Domestic Violence—
 - (1) Does the Succession Act 2006 (NSW) specifically set out the rights available to people in a 'close personal relationship' to challenge the will of the other (deceased) person in the relationship if they have been left out of the will?
 - (2) What representations has the Minister received to change the provision in question 1 above?

Answer-

- (1) The Succession Act 2006 (the Act) provides that a person with whom the deceased person was living in a 'close personal relationship' at the time of the deceased person's death is eligible to apply to the Court for a family provision order in respect of the estate of a deceased person. The Act defines 'close personal relationship' as a close personal relationship (other than a marriage or a de facto relationship) between two adult persons, whether or not related by family, who are living together, one or each of whom provides the other with domestic support and personal care.
- (2) Searches have not identified any written correspondence to me specifically about the definition of 'close personal relationship' in the Succession Act 2006 since the definition was amended in 2018. However, submissions regarding the definition of 'close personal relationship' were made to the statutory review of the Act. The report of the statutory review outlines submissions made on the

Minus18 material has not been distributed to students at Sylvania High School and no videos have been shown to students in the past three years.

Individual schools and principals are best placed to make decisions about ways to support their student populations' diversity, in consultation with the school community and relevant Department policies and procedures.

Transport for NSW discloses contracts entered into with talent acquisition service providers in line with the NSW Government procurement guidelines.

Procurement processes vary and can include using existing NSW Government prequalification schemes, or tendering for specific work.

In addition, Transport for NSW has established its own Recruitment Strategic Supplier List. This scheme was put in place to represent value for money and best available rates. It was established in April 2017.

Further in September 2018, Transport for NSW established a centralised Talent Management function with dedicated in-house resourcing to further demonstrate financial sustainability. The model has reduced reliance on external providers and if and when required, provides a governance model to ensure compliance with relevant Government policy and procedures.
