This question was asked of the Minister for Transport and Roads, but has been referred to me, Minister for Regional Transport and Roads, for response.

- (b) The speed zone reviews have not yet been completed. Any recommended change to the speed on Batlow Road, or the speed zone on the Snowy Mountains Highway near the Batlow Road intersection will be advised to the community and stakeholders once approved and an implementation date is known.

Answer—

I am advised:

- (1) The property is owned by "the State of NSW", i.e. Crown Lands, which currently is part of the Department of Planning, Industry and Environment.
- (2) The Eden Marine Centre Ltd became the head lessee on 13 December 2007.
 - (a) None.
 - (b) Two Government Agencies have current licences in the building
 - (i) NSW Water Police and the Commonwealth Department of Home Affairs (Border Force)
 - (c) Six commercial tenants were provided with licences until 11 October 2020, though several were already closed at that time. The two government tenants have been provided licences until 2 April 2021.
 - (i) Wharf side Café, Finny's, Full Fathom Five Gallery, Hooked on Seafood, Great white bite, Drift
- (3) On 11 September 2020 the Department received a building condition assessment report which identified a number of safety issues with the building.
- (4) In June 2020, a subtenant advised the Department of water leaking into their premises. a. Response above in 4.
- (5) Nil, as under the head lease, the lessee was responsible for maintaining the safety of the building.
- (6) No decision has been made about the future of the buildings, however the likely outcome is that it will be demolished to make the site safe.
- (7) The building condition assessment report identified many significant safety issues including fire safety, electrical and structural issues.
- (8) Given the extent of repairs required and the overall age and condition of the building, funding the repairs was deemed economically unviable.
- (9) Sapphire Coast Marine Discovery Centre elected to close and go into voluntary administration.
- (10) Security are currently onsite 24/7, while the tenants move their belongings. Once vacated security fencing will be erected around the site.
 - (a) Response above in 10.
- (11) Assistance is currently being discussed with the commercial tenants.
- (12) The Marine Discovery Centre has not indicated its intention to reopen and this may not be appropriate given that it has sought voluntary administration.
