\*983 **TRANSPORT AND ROADS—NSW DRIVERS' LICENCES**—Mr Graham asked the Special Minister of State, Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts, Vice-President of the Executive Council representing the Minister for Transport and Roads—

- (1) How many current NSW drivers' licences are there by category?
- (2) What is the percentage of each category of current NSW drivers' licences?
- (3) How many drivers have five demerit points or less remaining in each category of NSW drivers' licence?
- (4) How many drivers have between six and 10 demerit points remaining in each category of NSW drivers' licence?
- (5) What is the percentage of drivers with five demerit points or less remaining in each category of NSW drivers' licence?
- (6) What is the percentage of drivers with between six and 10 demerit points remaining in each category of NSW drivers' licence?

Answer—

I am advised:

1.-2. This information is publicly available on the Roads and Maritime Services website, under 'Corporate Publications' &gt; 'Statistics'.

3.-6. Transport for NSW does not report on demerit point data for NSW drivers by licence categories. Demerit points are allocated against a driver's record, who may hold dual classes of licence, and therefore, categorising this data by remaining demerit points in each licence category may provide misleading results.
