- * 5148 POLICE AND EMERGENCY SERVICES—SEXUAL ASSAULT—The Hon. Mark Latham to ask the Minister for Finance and Small Business representing the Minister for Police and Emergency Services—
 - (1) Of the 15,000 reports of sexual assault in New South Wales each year, how many are:
 - (a) Charged with an offence?
 - (b) Acquitted in court?
 - (c) Convicted in court?

Answer-

I am advised:

In the 2020 calendar year there were 15,580 individual incidents of sexual violence reported to the NSW Police Force.

Sexual violence offences do not only include sexual assaults, but ab road range of offences including sexual touching, indecent assault, sexual servitude, child pornography and historical sexual assault matters which have occurred when the victim was a child, but have been reported when the victim was an adult.

Of the 15,580 sexual violence incidents 3,610 charges have been laid against 1,827 offenders. Many of these incidents continue to be the subject of active investigations.

Of the 3,610 charges, 404 have resulted in a conviction and 798 instances where proceedings have been Nithdrawn, dismissed or a finding of not guilty made by the court. The remaining charges are currently before the court.
