I am advised:

NSW Government agencies are on track to meet the bulk of stimulus and support commitments in 2020-21. The Department of Planning, Industry and Environment's Leadership Team regularly review economic stimulus programs across the cluster and, where required, implement corrective actions to ensure the programs are delivered as effectively as possible.

The total economic stimulation and support allocation to Health is \$1.17 billion over 5 years, with investments in recurrent and capital spending to keep the community safe, and to boost jobs and growth in the pandemic. As per usual practice, NSW Health is working with NSW Treasury to have any unspent stimulus carry forward into 2021-22.

Answer-

(1) In November 2020, the Ministry requested medical vacancy data from Local Health Districts and Specialty Health Networks for the week of 2 to 8 November 2020. A vacancy is defined as a vacant funded position approved by the Chief Executive as available for a health employee or clinical contractor to occupy following successful application. These vacancies are not an indication of the absence of a physical doctor being present but rather an existing or newly created role that is due to, or currently undergoing, recruitment to fill. Many reported vacancies have a temporary backfill arrangement to ensure service requirements are met. Examples of temporary workforce arrangements include, but are not limited to, the use of locums and temporary contracts.
