* 5419 AGRICULTURE AND WESTERN NEW SOUTH WALES—DUCK HUNTING—The Hon. Emma Hurst to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Agriculture and Western New South Wales—

- (1) Why does NSW allow shooters with a Waterfowl Identification Test (WIT) score of just 50 to hunt, when other states like Victoria and South Australia require a score of 57?
- (2) Are shooters required to pass the WIT annually?
 - (a) If not, why?
- (3) Are shooters required to re-apply for their licence every 12 months?
 - (a) If not, why?
- (4) When setting quotas, does the Department of Primary Industries (DPI) consider the impact on duck populations across eastern Australia (and not just in NSW)?
 - (a) If not, why?
- (5) In regards to the 2020-2021 Annual Waterfowl Quota Report:
 - (a) Why has there been an increase in quotas, despite the report finding a 'high proportion of dry dams' and 'low duck numbers'?
 - (b) What is the justification for setting quotas for birds with very low population levels, such as the Pink-eared Duck (309) and Chestnut Teal (175)?
 - (c) According to the Report, there were only 3,242 Hardheads estimated in the Riverina region. This is a significant drop from 16,868 in 2018 (as quoted in the 2019-20 hunter information update report). What is the explanation for this concerning decline in population?
- (6) What is the justification for continuing to set quotas that are many times higher than the actual number of birds being killed annually? For example, in 2018-2019, the total quota was 41,046, compared to 1,554 birds actually killed.
- (7) Can the Minister please provide a list of all rice growers with an active NSW Native Game Bird Management (Owner/Occupier) Licence?

Answer—

- (1) The NSW Native Game Bird Management Program bears no semblance to recreational duck hunting in other states. The NSW program is for agricultural protection purposes and requires anyone involved to pass the WIT with a score of 50/66 points, which is a 75 per cent pass rate. The NSW Government is not involved in the decision-making process that relates to duck shooting in other states.
- (2) No.
 - (a) The WIT is designed to set a benchmark of waterfowl identification. Analogous to a driver's licence or a recreational boat licence, testing is not required annually. Skills are further developed and enhanced through experience.
- (3) Yes, if an annual licence is held.
 - (a) Otherwise, Game (G) Hunting Licences can be granted for up to five years. All hunters must hold a current licence before hunting, regardless of the term of the licence.
- (4) Yes, surveys are conducted annually in the Riverina region of NSW to estimate the size of duck populations where most of the harvest takes place. Areas outside of the Riverina are not surveyed, so the quota is based on an underestimate of the total duck population in eastern Australia.
- (5) 2020-2021 Annual Waterfowl Quota Report:

-
- (a) The increase in the 2020-21 quota is attributable to the increased number of Pacific Black Duck and Australian Wood Duck observed during surveys across all waterbody types on a species-by-species basis reflecting relative abundance.
- (b) Chestnut Teal are predominantly located outside of the Riverina region of NSW and Pink-eared Ducks are a highly dispersive and nomadic species that favour natural shallow wetlands, so the quota for these species is based on an underestimate of the total duck population for NSW.
- (c) The figure of 16,868 was incorrectly reported and has since been updated. The estimated abundance for Hardheads in 2018-19 was 1,037. The figure of 16,868 relates to the 2017-18 estimated abundance for Hardhead. This species is highly nomadic and possibly in a higher concentration at the time on the back of favourable breeding conditions during 2016-17.
- (6) Quotas are set based on a 10 per cent harvest rate and this is the maximum amount that would be harvested while still being conservative and sustainable.

Answer—

- (1-2) The 2020-21 Early Childhood Education Scholarships Program is the first year of a three-year scholarship program.

The program has been developed to help increase the number of qualified early childhood teachers in the early childhood education sector in NSW.

This program builds on three previous scholarship programs to increase the number of early childhood teachers available in NSW:

- The Rural and Remote Early Childhood Teaching Scholarship
- Incentive Scholarship
- Aboriginal Early Childhood Education Scholarship.

- (3) Up to a maximum of \$20,000. The Department is working with individual scholars to determine individual grant award amounts. This information is not yet available.

Individual grant awards take into account a range of factors, including completed units of study, for instance where a scholar has partially completed a qualification or has recognised prior learning.
