Answer-

(1) NSW Procurement has been responsible for Fleet Management and Leasing from FY 2016/17 and has no access to data relating to the State Fleet which was decommissioned at the end of FY2015/16.

- Electric vehicles include Battery Electric Vehicles, Plug-in Hybrid Electric Vehicles and Hybrid Electric Vehicles.
- This data includes light commercial vehicles and passenger vehicles only. It excludes NSW Police vehicles.
- The NSW Government Resource Efficiency Policy set a target from 2020–21 that 10 percent of **new general purpose passenger fleet cars** purchased or leased by agencies are to be electric or hybrid vehicles. This target was exceeded in Calendar Year 2020 with 57% of new general purpose passenger fleet cars being electric or hybrid vehicles.

\* 5435 TREASURER—COAL ROYALTY REVENUE COLLECTED AND RETURNED TO LGAS—The Hon. Mark Latham to ask the Minister for Finance and Small Business representing the Treasurer—

I refer the Minister to his answer to Question 937 (18 December 2019) concerning coal royalty revenue returned to the Singleton and Muswellbrook Local Government Areas (LGAs):

- (1) Can the Minister now update this data please for the:
  - (a) 2019-20 financial year? and the
  - (b) 2020-21 NSW Budget projections?

Answer—

Treasury has advised me as follows:

(1) In 2019-20, the NSW government collected \$0.86 billion in coal royalties from mines in the Singleton and Muswellbrook Local Government Areas (LGAs), accounting for 57 per cent of total coal royalties collected in 2019-20. These estimates include revenue from mines that operate across LGA borders.

In 2020-21, the NSW government expects to collect around \$0.69 billion in coal royalties from mines in the Singleton and Muswellbrook LGAs, accounting for 55 per cent of total coal royalties expected to be collected in 2020-21. These estimates include revenue from mines that operate across LGA borders.

The corresponding expected outcomes for 2021-22, 2022-23 and 2023-24 (reflecting the 2020-21 Half-Yearly Review forecasts) are as follows:

#### Approximate proportion of forecast coal royalties, estimated to be generated from locations in Singleton and Muswellbrook LGAs

Fiscal Year	Forecast coal Royalties	Percentage of total coal royalties
2021-22	\$0.76 billion	55 per cent
2022-23	\$0.77 billion	55 per cent
2023-24	\$0.79 billion	55 per cent

(2) Revenue collected from coal royalties is not hypothecated for infrastructure expenditure and instead goes directly into consolidated revenue.

The Local Government Areas of Singleton and Muswellbrook fall within the Upper Hunter Electorate. Capital expenditure allocated to the Upper Hunter electorate was \$91.7 million in 2019-20 and \$45.4 million in 2020-21.

Major projects funded through this expenditure include:

- Muswellbrook Land and New Fire Station
- Muswellbrook Hospital Redevelopment Stage 2
- New England Highway upgrade between Belford and the Golden Highway
- New England Highway Singleton Bypass
- New England Highway Muswellbrook Bypass
- Muswellbrook South Public School Upgrade

These allocation totals do not include funding that provides benefits to multiple electorates including the Upper Hunter.
