- * 5438 EDUCATION AND EARLY CHILDHOOD LEARNING—LINDFIELD LEARNING CENTRE—The Hon. Mark Latham to ask the Minister for Education and Early Childhood Learning—
 - (1) How much has been spent on the construction of gender neutral toilets at the Lindfield Learning Centre School over the past three years?
 - (2) What age groups are these toilets available to?

Answer-

(1) No additional scope was required to include the all gender toilets. The only distinguishing factor for the all gender toilets is signage.

The estimated total cost to deliver Stage 1 and Stage 2 of the Lindfield Learning Village is available publicly in the NSW budget papers. The cost to deliver specific elements of this project are held Commercial in Confidence so as to not prejudice any future tender processes.

- * 5439 EDUCATION AND EARLY CHILDHOOD LEARNING—LINDFIELD LEARNING CENTRE—The Hon. Mark Latham to ask the Minister for Education and Early Childhood Learning—
 - (1) What action has the Minister taken to sack the a) classroom teacher and b) school principal at the Lindfield Learning Centre responsible for allowing an anti-NSW Police poster to be displayed in a primary school classroom with the words "Pigs out of the country" (twice) and "White lives matter too much"?
 - (2) What action is the Minister taking to outlaw political and ideological content in NSW schools, given the way in which Lindfield and other examples are breeding hatreds, disrespect and barbarism in NSW school students?

Answer—

- (1) This matter has been referred to the Department of Education's Professional and Ethical Standards (PES) Directorate for investigation.
- (2) The Department implements the Controversial Issues in Schools Policy in all NSW public schools. All schools are expected to follow the guidelines to ensure that schools are places of neutral discourse and learning. Teachers should not influence political views of students.
- * 5440 EDUCATION AND EARLY CHILDHOOD LEARNING—NAPLAN—The Hon. Mark Latham to ask the Minister for Education and Early Childhood Learning—
 - (1) What arrangements have been made for the conduct of the 2021 NAPLAN tests in NSW schools? Answer—

In 2021, 72% of NSW schools will sit NAPLAN Online and 28% of NSW schools will sit paper tests.

All NSW schools that are participating in NAPLAN Online in 2021 had an opportunity to participate in practice tests between 22 March and 23 April 2021.

To support schools to prepare for NAPLAN Online in May, training took place across the state in February/March 2021. Additional refresher training was also offered to school staff at the start of Term 2.

Schools can also access the training environment within the online assessment platform. The training environment replicates the NAPLAN Online test environment and assists with in-school training for NAPLAN Online administration.

Provisions in the event of COVID-19 interruptions during test weeks

In December 2020, Education Council agreed that for NAPLAN 2021:

- if a school has not been closed due to COVID-19 that NAPLAN be undertaken by all eligible students who are present at the school on the day; and
- the inclusion of an additional week during the security period to maximise school participation.

There are two test security weeks for NAPLAN this year, to accommodate potential interruptions to NAPLAN due to COVID-19.

If schools are temporarily closed due to COVJD-19, NESA will work with these schools to amend their NAPLAN test schedule to ensure students have maximum opportunity to complete testing once these school have reopened.
