 - In the Tumut & Adelong Times article titled "Council merger 'was never going to work" dated 11 May 2021, Minister Tudehope is reported saying:

For the benefit of the House, the Minister committed at budget estimates to make the reports [Boundaries Commission reports and its recommendations into Snowy Valleys Council and the Cootamundra Gundagai Council demergers] public.

- (2) On what date will the Minister make their statement/ decision in relation to the Boundaries Commissions reports into the possible demerger of these two councils?

 - (1) Is the Minister aware that Stockholm's Astrid Lindgren Children's hospital in Sweden is ceasing the routine treatment of gender dysphoric children with puberty blocking drugs and cross sex hormones due to infertility and cancer concerns?
 - (2) Is the Minister aware that last week Australian gender clinicians from Westmead Hospital criticised the medicalisation of children's gender dysphoria?
 - (3) In both cases the Health Minster was asked by the media for a response to these developments and declined to comment.

(a) Why is the New South Wales government not speaking to the media about this important issue of child well-being?

I am aware of the matters being raised by the Member.

Treatment and care of children and adolescents with gender dysphoria is a complex issue which must always be handled with the greatest level of care and sensitivity.

NSW Health supports practice that is consistent with advice from the Royal Australasian College of Physicians (RACP) on care and treatment for children and adolescents with gender dysphoria. This care should be based on evidence and advice from medical and other health professionals with specific expertise, in consultation with the affected child or adolescent and their family.
