- \* 5709 PROPOSED REPLACEMENT OF WEE WAA HIGH SCHOOL—Mr Roy Butler to ask the Minister for Skills and Tertiary Education, and Minister for Sport, Multiculturalism, Seniors and Veterans representing the Minister for Education and Early Childhood Learning—
  - (1) Will consideration be given to the Wee Waa community's expressed interest in a speciality Agricultural Technology High School utilising the research capacity and farmer utilisation of the new technology in the district?
  - (2) Will the Minister ensure there is proper resourcing for this consideration?

#### Answer-

I joined the school community to announce funding to deliver a new high school for Wee Waa on 3 June 2021.

The Department of Education is consulting with the local community including the Wee Waa High School leadership team, agriculture teacher, and local industry experts to ensure the new facilities can provide learning facilities designed for future focused operational models of agriculture.

A community information is scheduled for Wednesday, 23 June 2021 and I encourage interested community members to attend and provide feedback on the project.

Further information on the project and the upcoming information session will be shared with the local community and is available on the School Infrastructure NSW website.

- \* 5710 WEE WAA HIGH SCHOOL ENROLLMENTS—Mr Roy Butler to ask the Minister for Skills and Tertiary Education, and Minister for Sport, Multiculturalism, Seniors and Veterans representing the Minister for Education and Early Childhood Learning—
  - (1) What is the total number of students currently enrolled at Wee Waa High School as at 6 May 2021?
  - (2) What is the enrolment capacity of Wee Waa High School?
  - (3) Does the Department of Education hold modelling data on projected student numbers?
    - (a) If so, will the Minister publicly release this data?

#### Answer—

- (1) The total number of students enrolled at Wee Waa High School as at 6 May 2021 is 129.
- (2) and (3) Every eligible student who wishes to attend a New South Wales government school will be given a place at their local school. Accordingly, the Department of Education does not have fixed enrolment capacities at New South Wales government schools. Schools have the capacity to adapt to fluctuating enrolments though the use of a combination of temporary and permanent teaching spaces.
- \* 5711 NEWCASTLE RECREATION RESERVE—Mr Tim Crakanthorp to ask the Premier representing the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts—
  - (1) On what date did the Minister receive the Heritage Council's recommendation to list the Newcastle Recreation Reserve on the State Heritage Register?
  - (2) Has the Minister fulfilled the requirements under Section 34 (1) of the Heritage Act 1977?
    - (a) If not, why not?

#### Answer-

- (1) I received the Heritage Council's recommendation to list the Newcastle Recreation Reserve on the State Heritage Register on 4 May 2021.
- (2) I have fulfilled the requirements under Section 34 (1) of the Heritage Act 1977 by deciding to list Newcastle Recreation Reserve on the State Heritage Register within 14 days of receiving the Heritage Council's recommendation.
- \* 5712 JUSTICE OF THE PEACE SERVICES—Mr Tim Crakanthorp to ask the Minister for Customer Service, and Minister for Digital—
  - (1) Does the Newcastle Service Centre provide Justice of the Peace (JP) services for community members?
    - (a) If so, how many employees at the Newcastle Service Centre are JPs?
    - (b) If so, what times are JP services available?

#### Answer-

Service NSW's Newcastle Service Centre provides Justice of the Peace (JP) services for customers with four team members currently registered as Justices of the Peace.

Customers can phone the Service NSW Contact Centre on 13 77 88 prior to attending a Service Centre to confirm that a Justice of the Peace is working in their local Service Centre that day.

The Service NSW website also includes information about how customers can find a nearby Justice of the Peace by using the JP Public Register.

In the event that a customer attends a Service Centre and a Justice of the Peace is not available, Service Centre staff can assist the customer in finding a nearby alternative on the JP Public Register in the self-service area. There are same day Justice of the Peace services available at the nearby Newcastle Court House.

- \* 5714 RENTAL VACANCY RATE IN NEWCASTLE—Mr Tim Crakanthorp to ask the Minister for Families, Communities and Disability Services—
  - (1) Is the current rental vacancy rate in Newcastle under 1 per cent?
  - (2) What consideration has been given to specialist homelessness services (SHS) in Newcastle who are seeing unprecedented demand for their services?
  - (3) Can it take up to eight weeks to get an appointment with a case worker at some SHS providers in Newcastle?
  - (4) Will the Minister consider providing additional resources to these services to assist them in managing their demand?
  - (5) What other options is the Minister exploring to assist in managing the current housing crisis?

#### Answer-

#### I am advised:

The Real Estate Institute of NSW publishes Vacancy Rate Survey Results on their website at https://www.reinsw.com.au/Web/Members/Property\_data/vacancy\_Rates\_Survey.aspx.

In 2020-21, the Government will spend \$291.8 million to provide homelessness services and programs across the state. This includes over \$6 million in funding for six Specialist Homelessness Services (SHS) in the Newcastle local government area.

The Government is offering three-year contracts to SHS providers to commence on 1 July 2021, with a strong focus on service quality and client outcomes.

Housing 2041 is the Government's 20-year vision for housing in New South Wales which aims to benefit people across the housing spectrum. Further information is available at: https://www.planning.nsw.gov.au/Policy-and-Legislation/Housing/A-Housing-Strategy-for-NSW.

- \* 5715 COASTAL AND ESTUARY GRANTS—Mr Tim Crakanthorp to ask the Minister for Local Government—
  - (1) How much has been spent from the Coastal and Estuary Grants Program (as at 7 May 2021)?
    - (a) What funds are remaining in the Coastal and Estuary Grants Program?

- \* 5716 ELECTRIC SCOOTERS—Mr Tim Crakanthorp to ask the Minister for Transport and Roads—
  - (1) Considering electric scooters are used widely across New South Wales, why are they still illegal?
  - (2) Will legalisation of the use of electric scooters in New South Wales be considered?
  - (3) What other Australian jurisdictions have legalised the use of electric scooters?

#### Answer-

I am advised:

- (1) While electric scooters are available to purchase and use on non-road related areas they are not considered safe for use on the road network in New South Wales.
- (2) The potential advantages of electric scooters must be balanced against the safety of all road users. For electric scooters to be legalised for use on the road network, evidence must be provided showing they can be used in a safe and compliant manner.
- (3) It is understood that electric scooters are permitted for use on public roads or road-related areas in Australian jurisdictions other than South Australia and New South Wales. However, between these jurisdictions there remains inconsistency in the permitted power outputs, maximum speeds and infrastructure on which electric scooters are permitted.
- \* 5717 NEWCASTLE LIGHT RAIL WARNING SIGNS—Mr Tim Crakanthorp to ask the Minister for Transport and Roads—

Are there any plans to remove the variable message signs located at the approaches to the Newcastle Light Rail crossing at Stewart Avenue?

#### Answer—

I am advised:

In response to an identified pattern of vehicles running the red light at the Newcastle Light Rail crossing on Hannell Street, Transport for NSW (TfNSW) has implemented a number of improvements to the crossing, including improved signposting, pavement markings and a mast arm for the signal display. In addition, nearby temporary fencing for adjacent building construction works was removed.

Recent discussions with Keolis Downer have indicated red light running instances have declined and, as a result, TfNSW will remove the temporary message boards in the coming weeks.

- \* 5718 NEWCASTLE PORT RESTRICTIONS—Mr Tim Crakanthorp to ask the Treasurer—
  - (1) Is the purpose of the penalty on container traffic at the Port of Newcastle to create a disincentive or obstacle to developing a container terminal?
    - (a) If not, what is the purpose of the penalty on container traffic at the Port of Newcastle?
  - (2) Can a container terminal at the Port of Newcastle be developed?
  - (3) What consideration has been given to the Prime Minister's view that a container terminal should be built at the Port of Newcastle?

#### Answer-

Treasury has advised me as follows:

- (1) This is a matter currently before the Courts. The Port Commitment Deed contains commercial arrangements between the Port of Newcastle and the State of New South Wales that were agreed as part of the State's transaction for the long-term lease of the Port of Newcastle in 2014. The State received \$1.75 billion as a result of the transaction, which is helping to fund State infrastructure.
- (2) We refer the Honourable Member to the current NSW Freight and Ports Plan as to the State's policy position on the development of additional container capacity in New South Wales. Any decision to build a container terminal at Newcastle is a matter for the private operator of the Port of Newcastle.
- (3) The State's position in relation to the development of a container terminal at the Port of Newcastle is set out in the NSW Freight and Ports Plan.
- \* 5719 MOULD ISSUES IN LAND AND HOUSING CORPORATION PROPERTIES—Mr Tim Crakanthorp to ask the Minister for Water, Property and Housing—
  - (1) What consideration has been given to the concerns I have raised on behalf of multiple constituents with the with Land and Housing Corporation (LAHC) about mould issues in their properties?
  - (2) Do you stand by your statement in 2021 Budget Estimates Supplementary Questions that there have been no mould issues in any LAHC properties in the NN07 allocation zone in the past decade?
  - (3) What terminology does LAHC use to record cases of mould in properties?
  - (4) How many LAHC properties located in NN07 Newcastle zone were affected by mould, either named as mould or any other terminology as per Question 3, for each of the following years:
    - (a) 2011;
    - (b) 2012;
    - (c) 2013;
    - (d) 2014;
    - (e) 2015;
    - (f) 2016;
    - (g) 2017;
    - (h) 2018;
    - (i) 2019;
    - (j) 2020;
    - (k) 2021 (as at 6 May 2021)?

#### Answer-

#### I am advised:

- (1) The NSW Land and Housing Corporation (LAHC) has raised work orders with the maintenance contractor to address reports of rising damp or water leaks to resolve the issues. If required, the maintenance contractor will complete any associated works arising from damage caused by the rising damp or water leaks.
- (2) Yes.
- (3) Under the current Asset Maintenance Services Contract, mould is recorded under work classification "MPWMOULD".
- (4) There are no recorded orders relating to mould issued in the NN07 Allocation Zone.
- \* 5720 WORKING WITH CHILDREN CHECK FEES—Mr Clayton Barr to ask the Minister for Families, Communities and Disability Services—
  - (1) What income has been received from Working With Children Checks fees in each financial year since 2010-11 (to 6 May 2021)?
  - (2) Is the fee refundable if the Working With Children Check is refused?
  - (3) How many Working With Children Checks were issued each financial year since 2010-2011 for:
    - (a) Paid workers?
    - (b) Volunteers?

#### Answer-

#### I am advised:

Information about the revenue received by the Office of the Children's Guardian (OCG) and the number of Working With Children Check clearances is available in the relevant OCG Annual Report, publicly available at https://www.kidsguardian.nsw.gov.au/about-us/annual-reports.

Fees for paid worker checks that are refused are non-refundable. There is no fee for volunteers.

- \* 5721 COST OF PALLIATIVE CARE—Mr Clayton Barr to ask the Minister for Health and Medical Research—
  - (1) What is the average weekly assessed cost for patients who are at the palliative care stage of their illness to:
    - (a) Be treated and remain in a public hospital?
    - (b) Remain in their home and have palliative care nurses and personal care providers attend?

### Answer-

Calculating the average cost of palliative care is based on a patient's individual care journey, not on a weekly basis.

- \* 5724 MY COMMUNITY PROJECT FUNDING—Mr Clayton Barr to ask the Treasurer—
  - (1) Of the 248 successful projects funded in the My Community Project 2019 Program, how many projects:
    - (a) Were completed within the 12 month finalisation requirement?
    - (b) Requested and were granted an extension of this time frame?
    - (c) Are yet to be completed as at 6 May 2021?

- (i) Have each of these projects been inspected to discover the cause of the delay in completion?
- (i) If so, how many times?
- (ii) If not, why not?
- (d) Were any of the projects unable to be commenced?
  - (i) If so, was the next highest voted project provided with funding?

#### Answer-

Treasury has advised me as follows:

- (1) Of the 248 successful projects funded in the My Community Project 2019 Program:
  - (a) 134 projects were completed in the 12-month period. A further 15 projects were completed between January and May 2021.
  - (b) 96 projects have requested an extension of time.
  - (c) As at 6 May 2021, 99 projects are yet to provide all documentation evidencing completion.
    - (i) All projects that have not completed are required to submit regular progress reports and provide updates on any delays.
      - When a time extension is requested, projects are required to submit a strong rationale, supporting evidence and information on remedial action being taken in order to deliver the project in the new timeframe
    - (ii) Projects that are yet to be completed submitted progress reports in February 2021.
    - (iii) Projects are being actively monitored.
  - (d) Two projects have withdrawn as they were unable to proceed.
    - (i) In both instances the next highest voted project was allocated funding and has since been completed.
- \* 5725 WATER ADMINISTRATION MINISTERIAL CORPORATION—Mr Clayton Barr to ask the Treasurer—
  - (1) What has been the annual income declared for the Water Administration Ministerial Corporation (WAMC) in each financial year from 2010-11 to 2021-22 (to 6 May 2021)?
  - (2) What has been the annual expenditure declared for the WAMC in each financial year from 2010-11 to 2021-22 (to 6 May 2021)?
  - (3) In which financial years has the WAMC declared a loss since 1 July 2010 (to 6 May 2021)?
    - (a) What was the value of the loss in each of these years?

How many customers are simultaneously a Murray-Darling Basin Authority (MDBA) Customer and a Dumaresq-Barwon Border Rivers Commission (BRC) Customer as at 6 May 2021?

#### Answer-

There are two customers of both the Dumaresq-Barwon Border Rivers Commission (BRC) and the Murray-Darling Basin Authority (MDBA).

- \* 5727 WATER ADMINISTRATION MINISTERIAL CORPORATION—Mr Clayton Barr to ask the Minister for Water, Property and Housing—
  - (1) What has been the annual income declared for the Water Administration Ministerial Corporation (WAMC) in each financial year from 2010-11 to 2021-22 (to 6 May 2021)?
  - (2) What has been the annual expenditure declared for the WAMC in each financial year from 2010-11 to 2021-22 (to 6 May 2021)?
  - (3) In which financial years has the WAMC declared a loss since 1 July 2010 (to 6 May 2021)?
    - (a) What was the value of the loss in each of these years?
  - (4) In which financial years has the WAMC declared a surplus since 1 July 2010 (to 6 May 2021)?
    - (a) What was the value of the surplus in each of these years?

- \* 5728 WSP CEASE DATES—Mr Clayton Barr to ask the Minister for Water, Property and Housing—
  - (1) Considering the answer from Budget Estimates March 2020 Supplementary Question 283 advising a new cease date of 2030 for the Water Sharing Plans (WSPs) of the Murrumbidgee Regulated River, the Murray and Lower Darling Regulated River, the Upper and Lower Namoi Regulated River, the Gwydir Regulated River, the Lachlan Regulated River, the Macquarie and Cudgegong Regulated Rivers, the NSW Border Rivers Regulated Water Sources and the Peel River Regulated Water Sources; yet Budget Estimates March 2021 Supplementary Question 80 advises these WSPs do not have a cease date of 2030, what is the cease date of each of these WSPs?
  - (2) Why were these WSPs not replaced in 2020?
  - (3) When were these WSPs replaced?
  - (4) When were these plans audited during their first term?

#### Answer-

- (1) The cease date for the:
  - (a) Murrumbidgee, Murray and Lower Darling, Upper and Lower Namoi, Gwydir, Lachlan and Macquarie and Cudgegong regulated River WSPs is 2026 (the plans commenced in 2016).
  - (b) NSW Border Rivers regulated WSP is 2021
  - (c) Peel regulated River WSP is 2022.

If a plan is replaced at a date earlier than its cease date (which will be the case for the plans mentioned in la above), the replacement plan can be in force for ten years from the date it is remade, unless subsequently replaced or extended for up to two years by the Minister responsible for water.

- (2) The Regulated River WSPs were not replaced in 2020 due to wanting accreditation advice from the MDBA on regulated river water sharing plans.
- (3) These plans have not yet been replaced.
- (4) The Murrumbidgee, Murray and Lower Darling, Upper and Lower Namoi, Gwydir, Lachlan and Macquarie and Cudgegong WSPs were audited in 2009 and again in 2012. The Border Rivers WSP was audited in 2014 and the audit of the Peel WSP was completed in 2019. Copies of these audit reports are available in the Department website (Audits of water sharing plans under Section 44 of the Water Management Act 2000 Water in New South Wales (nsw.gov.au))
- \* 5729 INCIDENT INFORMATION MANAGMENT SYSTEM FOR THE MURRUMBIDGEE LOCAL HEALTH DISTRICT—Mrs Helen Dalton to ask the Minister for Health and Medical Research—
  - (1) How many complaints were registered in the Incident Information Management System for the Murrumbidgee Local Health District between 1 January 2020 and 31 December 2020?
    - (a) How many of these complaints related to bullying?
    - (b) How many of these complaints were resolved?
    - (c) What is the average time taken to resolve these complaints?
    - (d) How many complaints resulted in disciplinary action?

#### Answer-

Since October 2019, Murrumbidgee Local Health District has used ims+ to record incidents and consumer feedback. ims+ is the incident reporting system across the NSW Health System.

ims+ is not designed for reporting staff grievances

\* 5730 FLOODPLAIN HARVESTING—Mrs Helen Dalton to ask the Minister for Water, Property and Housing—

Will consideration be given to imposing an embargo on Floodplain Harvesting under Section 324 of the Water Management Act 2000 until floodplain harvesting is licenced and regulated?

#### Answer-

"Floodplain harvesting is the collection, extraction or impoundment of water flowing across floodplains, including rainfall runoff and overbank flow, but excluding the taking of:

- water under a water access licence that is not a floodplain harvesting access licence
- water under a basic landholder right, including water taken under a harvestable right
- water under an applicable water access licence exemption under the WM Act
- used irrigation water."

If the government were to implement a s324 order on floodplain harvesting, it would have to cover all of New South Wales, and would include rainfall run-off into tailwater dams and drains. A s324 order would have the effect of making it illegal for most irrigators to capture rain fall on their properties. Most irrigation corporations are also capturing rainfall runoff and would be impacted by the s324, putting their ability to function into question.

  - (1) How were the members of the Wamberal Sea Wall Taskforce selected?
  - (2) Did the terms of reference for the Wamberal Sea Wall Taskforce include any direction/scoping possibilities besides design and/or construction of a seawall?
  - (3) What is the breakdown of spending of the Coastal Zone Management funding by electorate?
  - (4) How will this funding be rolled over into the 2021-22 budget?
  - (5) How many times has Central Coast Council (CCC) sought approval for their Coastal Zone Management Plan at North Entrance?
  - (6) What provision/support has the Government's Coastal Zone Management provided to CCC to complete their Coastal Zone Management Plan?
  - (7) How many community consultation sessions were undertaken with the Wamberal community?
    - (a) How many attendees were at each of these sessions?

- \* 5735 GOSFORD DRIVING RECORDS—Ms Liesl Tesch to ask the Minister for Regional Transport and Roads—
  - (1) How many people within the Gosford electorate have had a clean driving record for;
    - (a) 50 years?
    - (b) 60 years?
    - (c) 70 years?
  - (2) How can a Member of Parliament access their names to present an award?

#### Answer-

#### I am advised:

- (1) The data below shows the number of individuals with an active New South Wales driver licence and no offences on the NSW traffic record with an original issue date of:
  - (a) 50-59 years ago: 832 individuals
  - (b) 60-69 years ago: 260 individuals
  - (c) 70 years ago or more: 28 individuals.

The data is current as of Monday 17 May 2021 and covers postcodes 2083, 2250, 2256, 2257, 2775.

(2) Transport for NSW (TfNSW) manages personal information of customers in accordance with the Privacy and Personal Information Protection Act 1998 (PPIP Act). TfNSW can only disclose the information to a third party if the disclosure is directly related to the purpose for which the information was collected. The PPIP Act does not provision the release of personal information for the purposes of presenting an award.

#### \* 5736 GOSFORD COVID-19 AND FLOOD RELIEF—Ms Liesl Tesch to ask the Treasurer—

In March 2019 Bingo became the owner of the site and the associated grant to complete construction of the facility. - Highest complexity cases will only be performed at The Children's Hospital at Westmead (CHW), and lower complexity cases will be performed at both the Sydney Children's Hospital, Randwick and CHW, with the appropriate supports in place.
- The Sydney Children's Hospitals Network executive and clinicians will work to determine the arrangements for medium complexity cases. The RACS recommendation for medium complexity cases stated: A multidisciplinary team meeting will be held to inform and consider which site is best placed to manage each case based on various factors including appropriate patient selection and availability of specialist resources.

Highest and lowest complexity cases were not defined by RACS and this is part of the work being progressed to implement the Model of Care. Work has progressed to define the range of cardiac surgical cases by the Cardiac Care for Kids Project Team in consultation with clinicians, with agreement on the following:

- High complexity cardiac surgical cases include Complex Congenital Heart Disease and Hypoplastic Left Heart Syndrome.

The Links to Learning Community Grants Program will cease at the end of the current funding cycle on 30 June 2021. Funded organisations and participating schools were advised of the cessation of the program on 18 December 2020.

The decision to cease the Links to Learning Community Grants Program on 30 June 2021 was based on a program evaluation, completed by the Department, that did not provide strong evidence of outcomes from the program. The Department will only support programs that are based on the latest evidence of what produces the right outcomes for students.

Schools are able to continue to work with and fund any organisation, including those involved in the Links to Learning Community Grants Program.

The Perfect Presence Pilot Program will target 25 Principal Networks across New South Wales with the highest number of students in Years 8, 9 or 10 with between two and four suspensions and an attendance rate between 70-90 per cent.

The Perfect Presence Program aims to support students showing early signs of disengagement so they feel stronger connections to school and learning. As part of the NSW Government's Behaviour Strategy, this program will play a critical role in supporting positive student behaviour through a proactive, preventative and student-centred approach. There are seven outcomes that providers will need to demonstrate they are working towards with students, which have been categorised into behavioural, cognitive and emotional outcomes.

The Perfect Presence Pilot will run for 18 months.

GPs up to 50 years of age are eligible to be vaccinated at the centre, as well as at any other NSW Health Pfizer clinic, and should use the COVID-19 Vaccine Eligibility Checker to make an appointment.

From 24 May 2021, NSW Health clinics are available for appointments to anyone over the age of 50.

In consultation with Aboriginal people, the Government has implemented a number of initiatives to address the overrepresentation of Aboriginal people in the criminal justice system, including increased opportunities for community supervision and tailored interventions proven to reduce reoffending.

I am advised that Corrective Services NSW continually seeks to improve correctional centre design and inmate management practices to address the risk of self-harm and suicide of inmates, and improving the identification of those risks.

New South Wales is a signatory to the National Agreement on Closing the Gap, which establishes socio-economic targets to eliminate the gap in outcomes between Aboriginal and non-Indigenous Australians. The Closing the Gap targets include two targets relating to reducing the number of Aboriginal and Torres Strait Islander adults and young people held in incarceration.

New South Wales is currently developing a Jurisdictional Implementation Plan, which will set out how priority reforms will be implemented and to contribute towards achieving the Closing the Gap targets.

The Government is also considering the Report of the Legislative Council Select Committee on The High Level of First Nations People in Custody and Oversight and Review of Deaths in Custody, and will provide a response shortly.

I am advised that in the 2021-22 Commonwealth Budget, delivered on 11 May 2021, the National Housing and Homelessness Agreement (NHHA) included a continuation of the Social and Community Services - Equal Remuneration Order (SACS-ERO) funding for 2021-22 and 2022-23.

As in previous years, New South Wales will pass on 100 per cent of funding it receives for SACS Equal Remuneration Order supplementation to eligible funded service providers. This includes Specialist Homelessness Service providers that also support women and children impacted by family and domestic violence.

\* 5759 COVID SUPPORT FOR BLUESFEST—Ms Janelle Saffin to ask the Minister for Jobs, Investment, Tourism and Western Sydney—

Would consideration be given to the Government providing a one-off COVID support grant for Bluesfest to enable festival organisers and participating small businesses to stage a rescheduled COVID-safe event later this year?

Answer—

The Government continues to work with the owners of Bluesfest after it was cancelled by a specific Public Health Order.

\* 5760 CLARENCE WAY UPGRADE—Ms Janelle Saffin to ask the Minister for Regional Transport and Roads—

Clarence Way is a Regional Road under the care and control of both Clarence Valley and Kyogle Shire Councils. All Councils determine the priorities and funding arrangements for works on their Regional Roads.

The section between the Bruxner Highway and Bonalbo is under the control of Kyogle Shire Council. In 2018, Kyogle Council received \$4.16 million in funding under the Government's Fixing Country Roads Program to upgrade and seal a 14.8 kilometre section of Clarence Way from the Bruxner Highway to the Clarence Valley Council area.

In the 2020-21 financial year, the Commonwealth Government is providing \$2 million in funding under the Heavy Vehicle Safety and Productivity Program to upgrade 9.75 kilometres of Clarence Way between the villages of Woodenbong and Urbenville.

In the 2020-21 financial year, Council also received \$3 million for further work on Clarence Way between Woodenbong and Urbenville under the Commonwealth Government and the Government's Stimulus Commitment Road Safety Program, Pavement Rehabilitation and Widening.

Transport for NSW understands Council is continuing to pursue funding for Clarence Way. Transport for NSW also supports Councils with their Regional Roads by providing funding under the Block Grant and REPAIR Programs.

In the financial years of 2020-21 and 2021-22, Transport for NSW has provided and will provide approximately \$1,064,000 in Block Grant funding and \$188,761 in REPAIR funding for Kyogle Council to direct towards its road network priorities.

#### Answer—

- (1) I meet regularly with the NSW Farmers Association on a range of matters.
- (2) Most broadacre cropping farmers already had permission to use zinc phosphide for in-paddock application. In summer 2020-21, the cotton industry successfully applied for a specific permit for use in cotton. In early 2021, NSW Department of Primary Industries (DPI) successfully applied for a permit to allow use of zinc phosphide on bare fallow paddocks to clarify an ambiguity with the current product label.
- (3) The zinc phosphide bait permit for most forms of broadacre cropping was already in place and has been for many years. The application for use on bare fallow paddocks was approved by the Australian Pesticides and Veterinary Medicines Authority (APVMA) on 6 April.
- (4) The Government has announced \$150 million in support packages to offer farmers, households and small businesses assistance to battle the mice plague. Under the package, households, small businesses and primary producers will be able to claim rebates for purchasing mouse bait from 1 February 2021. #### Answer-

- (1) Mice are always in the landscape and their numbers vary depending on seasonal conditions, availability of food and shelter, disease and control activities. The recent increase in mouse numbers in New South Wales has been due to good winter and summer cropsin 2020-21, providing a large amount of food and shelter from maturing crops, grain/seed left on the ground post-harvest and stored grain and hay.
- (2) There is no quantified scientific definition of a mouse 'plague'. However, the current situation is New South Wales is so significant and widespread that most people would refer to it colloquially as a 'plague'.
- (3) As mice are always in the landscape, the Department of Primary Industries (DPI) is in communication about their numbers throughout the year.
- (4) I meet regularly with DPI on a range of matters.
- (5) Zinc phosphide was already permitted to be used in most broadacre cropping situations prior to the current mouse event. DPI applied for a temporary permit to allow zinc phosphide to be used on bare fallows to clarify an ambiguity with the current label. The application was submitted on 23 March 2021 and approved on 6 April 2021.
- (6) There is no agreed quantified definition of 'plague numbers'.
- (7) As per previous answer, there are no quantified parameters for defining or declaring a significant 'mouse breeding event'.
- (8) Local Land Services (LLS) does not keep a log of all phone calls received.
- (9) The Government has announced \$150 million in support packages to offer farmers, households and small businesses assistance to battle the mice plague. The Bureau of Health Information provides quarterly updates on waitlist numbers by local health District and on elective surgery activity and performance.

Answer—

I am advised:

The Government is committed to improving outcomes for people with cognitive impairment in the criminal justice system. Over the next four years, \$28 million will be invested to continue the Justice Advocacy Service (JAS) state-wide and establish court-based diversion services in six local courts.

This commitment follows a positive independent evaluation of JAS, which has provided critical support in over 4,500 cases for victims, witnesses, suspects and defendants since July 2019. The evaluation can be found at <a href="https://www.justice.nsw.gov.au/diversityservices/Documents/evaluation-of-the-justice-advocacy-service-report.PDF">https://www.justice.nsw.gov.au/diversityservices/Documents/evaluation-of-the-justice-advocacy-service-report.PDF</a>.

The new court-based diversion service will build on the supports offered by JAS by providing more targeted assistance to people accused of low-level offences in need of treatment and support.

It will help defendants access a cognitive assessment, develop tailored support plans, connect them with relevant services like the National Disability Insurance Scheme and provide accurate and relevant information to assist magistrates with their decision making.

It will be informed by best practice and the independent evaluation of the earlier Cognitive Impairment Diversion Program (CIDP) pilot.

- \* 5775 RESIDENTIAL ELECTRIC VEHICLE CHARGING STATIONS—Mr Alex Greenwich to ask the Minister for Better Regulation and Innovation—

#### Answer-

- (1) The Strata Schemes Management Amendment (Sustainability Infrastructure) Act 2021 introduced new strata voting rules to assist with the installation of sustainability measures, including electric vehicle charging stations, into strata buildings. Information on the new measures is available for all strata residents, building owners and managers, on the strata sustainability upgrades page on the NSW Fair Trading website.
- (2) NSW Fair Trading does not provide advice to strata building owners and managers about building design as it relates to electric vehicle charging.
- (3) The Minister for Transport and Infrastructure and the Minister for Roads, Maritime and Freight announced the Government's Electric and Hybrid Vehicle Plan in January 2019. The Plan focusses on three key priority areas:
  - vehicle availability,
  - charging points, and
  - customer information.

#### Answer-

The Government COVID-19 hotel quarantine program's strong quality and safety focus continually works to minimise risk and improve the program for quarantined guests and hotel quarantine staff. I am advised that NSW Police-managed quarantine hotel rooms are undergoing air pressure assessments and if required, remediation.

NSW Health's Special Health Accommodation (SHA) manages all passengers confirmed COVID-19 positive. There has been no transmission to either staff or other patients at the SHA since the program commenced on 28 March 2020.

There are several strategies to increase capacity however they will be dependent on a number of variables such as vaccination supply, vaccination administration numbers and variants of concern.

I am advised:

- (1) The Transport Asset Holding Entity (TAHE) has majority ownership of the land comprising Tom Uren Place. The City of Sydney owns a section running through Tom Uren Place that was previously public road/laneway. In relation to Walla Mulla Park, this land is owned by TAHE.
- (2) Sydney Trains, acting on behalf of TAHE, have been in active and ongoing discussions with the City of Sydney Council regarding this area in Woolloomooloo. The issues of cleaning, waste management, mobile food services along with redesigning and installing controls, (e.g. signage, storage space and bollards), at this location have been discussed.
- (3) In early November 2020, Sydney Trains attended a meeting with the Chief Executive of the City of Sydney, with a follow-up meeting occurring in February 2021. Dialogue between the two organisations is ongoing. Sydney Trains as TAHE representatives also attended a Community meeting on 31 March 2021 convened by the City of Sydney at which the use of the area was discussed. Attendees at this meeting included representatives of a variety of community groups/charities, NSW Police, Department of Communities & Justice and the City of Sydney.

- (4) TAHE is committed to collaborating with the City of Sydney to reach an outcome to improve this space.
- (5) There are no firm plans at this stage, with the onus on the City of Sydney to develop a strategic proposal for discussion and consideration with Sydney Trains/TAHE.

The taxi licence transfer process is publicly available on the Point to Point Transport Commissioner's website.

As at 1 April 2021, the Passenger Service Levy has collected \$195.8 million. The levy funds the point to point industry adjustment assistance package. The Government has paid out, or has approved to pay out, more than \$145 million in assistance to the point to point industry to help it adjust following the implementation of the Government's response to the 2015 Point to Point Transport Taskforce Report.

In March 2020, the Minister for Transport and Roads and the Minister for Regional Transport and Roads commissioned Ms Sue Baker-Finch to undertake an independent review of the point to point transport industry.

The terms of reference for the review included considering whether there is a case for further industry assistance. The Government released Ms Baker-Finch's report on 24 February 2021.

On 9 June 2021, the Government provided its response to the Ms Baker-Finch's report, which supported in full, in part or in principle all 24 of the report's recommendations, including in relation to providing further assistance to taxi licences. The further assistance scheme will be developed in conjunction with input from key industry stakeholders.

These reforms will help to deliver point to point transport services that are customer focused, competitive, safe and accessible.

Answer-

On 4 July 2020, the Government announced that the Powerhouse Museum at Ultimo would be retained and renewed. The renewal of the Powerhouse Ultimo is subject to a Final Business Case, which was completed in December 2020, and is being considered by Government.

With the announcement of the retention of the Powerhouse Ultimo, the Government will deliver two worldclass museums for Greater Sydney. They will complement each other, with Powerhouse Parramatta focusing on science and technology and Powerhouse Ultimo on design and innovation.

Powerhouse Ultimo will provide spaces to continue to exhibit the much loved Boulton Watt, Locomotive One and the Catalina and many more objects from the collection never seen before including the extensive fashion, decorative arts and design collection.

The business case explored a range of options for Powerhouse Ultimo. This masterplan fully engages with the precinct around the site. A conservation management plan is being finalised to ensure the museum's heritage fabric is appropriately celebrated and conserved.

The business case is being considered as part of the budget process.

Considering the John Hunter and Calvary Mater Newcastle Hospitals are among the worst hospitals in the state for staph infections, what is being done to reduce the number of staph infections at the hospitals?

Answer-

Staph infections at John Hunter Hospital per 10,000 patient days have reduced by 25 per cent since 2010-11. Staph infections at Calvary Mater Newcastle have reduced over 80 per cent since 2010-11.

All infection events are investigated by the District's Infection Prevention and Control unit to examine preventable factors and/or deficiency in practice and to implement improvement processes. The District will continue to implement strategies to further reduce staph infection rates in hospitals, including enhanced staff training and hand hygiene compliance.

#### Answer-

The NSW Bureau of Health (BHI) Information Mortality following hospitalisation for Seven Clinical Conditions July 2015 – June 2018 Report, shows that John Hunter Hospital and Calvary Mater Newcastle perform in line with expectations for the treatment of stroke and heart attacks.

Patient outcomes are governed by the Agency for Clinical Excellence through a variety of initiatives including Hip Fracture Care initiative, the Hip Fracture Care Clinical Care Standard by the Australian Commission on Safety and Quality in Health Care and the Australian and New Zealand Guideline for Hip Fracture Care.

The State Cardiac Reperfusion Strategy includes piloting a virtual heart failure service in the John Hunter and Maitland Hospitals, updating the current fleet of ECG devices and transmission platform, and development of the National Cardiac Registry which will collect data on coronary interventions, Additionally, the establishment of a State-wide Telestroke service and a Telestroke Model of Care will connect a team of Stroke neurologists 24/7 across 22 sites across rural and regional areas in New South Wales.

These initiatives drive health outcomes that matter to patients, improve experiences of receiving care, increase opportunities of providing care, and effectiveness and efficiency of care.
