- * 6581 HEALTH AND MEDICAL RESEARCH—GENDER DYSPHORIA—Reverend the Hon. Fred Nile to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Health and Medical Research—
 - (1) Given that the Minister for Health confirmed on June 2, in an answer to an earlier question from the Hon Rev Fred Nile MLC that the Government "supports practice that is consistent with advice from the Royal Australasian College of Physicians (RACP) on care and treatment for children and adolescents with gender dysphoria":
 - (a) What contingencies has the government made to pay potential future compensation claims to people who later regret taking government-sanctioned childhood medical advice to have irreversible body and life-altering therapies performed by them?

Answer-

(1) Specialist and multidisciplinary assessment and support guides individualised decision making and care of children and adolescents with gender dysphoria who seek medical treatment.

As with all medical treatment, treatment for gender dysphoria can only be commenced after obtaining informed consent. Clinicians have a duty of care to obtain informed consent including disclosing material risks such as side-effects and long-term consequences.

Where there is disagreement amongst the child, their parents or the clinical team, the Family Court has jurisdiction to consider the matter, in the child's best interests. As with any medical treatment, if treatment is provided negligently (including where there is a failure to obtain informed consent), a patient may commence legal proceedings.

Answer—

- (1-16) Information on suicides in individual local health districts is published annually in the NSW Health Stats website, using Australian Bureau of Statistics data. Data for 2018-19 will be included in the next update. The NSW Suicide Monitoring System is using Police and Coronial data to develop earlier estimates of suicide rates, including rates for individual local health districts.
- (17-19)Data from 2018 on the number of mental health staff at state level are published via Mental Health Services in Australia (AIHW), and from 2013 in the Report on Government Services. No data is available prior to 2013.
- * 6583 WATER, PROPERTY AND HOUSING—WILCANNIA WEIR UPGRADE—Mr Justin Field to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Water, Property and Housing—
 - (1) In regards to the Wilcannia Weir upgrade, in July 2019 when Stage 1 was completed, the Minister announced that the project had been handed over to Water NSW for "rapid delivery" of the project. - (a) The concept design for the weir and fish passage has been completed along with concept cost estimates. Detailed environmental studies are well progressed, with the Environmental Impact Statement to be exhibited in November 2021.
- (b) Wilcannia Weir Replacement design and impact assessments milestones are currently well advanced and nearing completion, including the site investigations, concept design, and cost estimates.
- (c) As a result of the site investigations completed so far, the environmental assessment pathway has changed from a Review of Environmental Factors (REF), as was stated in the Business Case, to an Environmental Impact Assessment. Construction on site will commence once planning approvals are obtained.

* 6584 EDUCATION AND EARLY CHILDHOOD LEARNING—FORMER SHOALHAVEN ANGLICAN COLLEGE SITE—Mr Justin Field to ask the Minister for Education and Early Childhood Learning—

Answer-

During development of the project to relocate Budawang School to the former Shoalhaven Anglican School site the project team considered how the location of the school at the Milton site on Croobyar Road might cater for any future development of educational facilities. This is not unusual for school projects and is undertaken to ensure future proofing the area for education facilities.

However, there are currently no plans to build additional education facilities or a new school at this site.

(4) Demand for school infrastructure has to be assessed on a relative-need basis across the whole state. When planning for public education facilities, consideration is given to the needs of a local area or region, population and enrolment projections, and changes in land use and supporting infrastructure, to ensure that every child in NSW has a well-resourced local public school to attend.

(5) SINSW uses short term enrolment projections and long-term population projections to guide future investment decisions, including the location and scale of building works to meet service needs. These projections are informed by census data and dwelling population projections provided by the Department of Planning, Industry and Environment in conjunction with local councils. Projections and enrolment trends are regularly reviewed and updated and as such there is not one specific year after which education facilities are required to be updated.

SINSW will continue to monitor population trends in the Milton/Ulladulla area to ensure appropriate educational infrastructure is provided for the community.

All NSW public schools receive a school counselling service allocation based on student enrolment data and indicators of student need. This service allocation may be provided by a school counsellor(s) or school psychologist(s). All schools are also able to engage with the NSW Government's telepsychology service.

The current school counselling service allocation for all schools in the Murray Electorate is 14.35 FTE.

As part of an \$88.4 million investment by this government, every NSW public high school will have a full-time school counselling allocation, as well as a full-time student support officer by June 2023. These positions are being phased in over time.

The following high schools in the Murray Electorate already have a full-time (or above) school counselling allocation: Murrumbidgee Regional High School and Yanco Agricultural High School. The remaining full-time allocations will be in place by June 2023.

A full-time student support officer is in place at Coomealla High School, Deniliquin High School, Finley High School, Leeton High School, Murrumbidgee Regional High School, and Yanco Agricultural High School. Two additional support officer positions are under recruitment.

All NSW public schools receive a school counselling service allocation based on student enrolment data and indicators of student need. This service allocation may be provided by school counsellor(s) or school psychologist(s). All schools are also able to engage with the NSW Government's telepsychology service.

The current school counselling service allocation for all schools in the Kiama electorate is 9 FTE.

As part of an \$88.4 million investment by this government, every NSW public high school will have a full-time school counselling allocation, as well as a full-time student support officer by June 2023. These positions are being phased in over time.

The Government has already delivered on this commitment in the Kiama electorate, with all high schools having a full-time school counselling allocation.

I am advised:

(1)

(a, i-vi)The Department is aware drones may be able to survey kangaroo populations in the future. Broadscale kangaroo surveys by drone are not yet viable in NSW due to limited drone technology and operating conditions under Australian aviation laws.

The Department is also aware of heat sensing technology that can be used in conjunction with drones for animal surveys.

It is not investigating drone technology to detect and count kangaroos at this time.

(2)

- (a) Yes, the Department investigated the error.
 - (i) The document referred to had significantly lower population values for the years leading up to 2001 compared to the values in the published quota reports. The Department has removed this single page document from its website because it was misleading.
- (b) The error appears to have been administrative and occurred around 2001. The single page document was old and remained on the website without context, so it is difficult to determine the cause of the problem.

(c) A comparison of the quota values in the single page document with those in the published quota reports shows that the quotas were almost all correct when compared with the published full quota reports.

(a) My answer to 219 cited the 2020 quota report because there are no wallaroo population estimates (for any year) on page 6 of the *Commercial Kangaroo Harvest Management Plan 2017–2021*. The 2017 and 2020 quota reports present the wallaroo population estimates from the 2016 and 2019 aerial surveys of the Northern Tablelands respectively. They are on page 6 in both reports. The published version of the 2020 quota report is the only version that has been published. Both the 2017 and 2020 quota reports present population estimates for each of the three commercial zones (Glen Innes, Armidale, and Upper Hunter) with wallaroo harvesting and a total population estimate across the three zones.

(a)

(i-ii) These surveys were conducted in years with above average rainfall. As a result, food resources are expected to have been non-limiting. Consequently, populations could be increasing at close to their biological maximum rate (note that the approximate 10 per cent maximum figure is not accurate. There are many studies that have indicated rates of increase well above this figure).

Also, during the western plains fixed wing surveys, surveyors do not distinguish between western grey kangaroos and eastern grey kangaroos. The proportion of each species is calculated using ratios developed by Cairns in 1999–2000. When the two species' populations are considered together, the rates of increase are more modest, at 24 per cent from 2011 to 2012 and 49 per cent from 2013–2014.

(a) The Department plans to review its historic commercial kangaroo management data and then evaluate the need for an external expert review of any of the data.

(6)

(a-b) The Department's understanding is the maximum rate of increase of wallaroos can exceed 8-10 per cent per annum.

A 90 per cent increase over three years represents an annual rate of increase of 24 per cent. Also, the Department counts wallaroos during surveys primarily designed for precise eastern grey kangaroo estimates. This is likely to result in greater variation in the wallaroo population estimates between surveys.

(a) The Department has not produced 'transect reports' for any of its kangaroo surveys.

It also does not provide absolute clarity on who caused or perpetrated an assault, and in particular, does not identify 'other visitors in the workplace'.
