Funding for two projects under the Regional Digital Connectivity (RDC) Program were announced in the 2021/2022 Budget. Details of these programs can be found in the Budget papers.

The Department of Regional NSW is currently working with the Commonwealth and State agencies to inform locations, timeframes and solutions to deliver improved digital connectivity for regional communities.

Answer—

I am advised:

- (1,10,12,13) Corrective Services NSW and Youth Justice NSW COVID vaccination programs are managed by the Justice Health and Forensic Mental Health Network (Justice Health). The Honourable Member should direct his questions to the Hon Brad Hazzard MP, Minister for Health and Medical Research.
- (11) In consultation with Justice Health and NSW Health, CSNSW will assess current quarantine processes in place for fresh reception inmates.
- (14) To date there have been no confirmed cases among Corrective Services staff at any NSW prison. A health care worker at Long Bay Hospital was diagnosed with COVID-19 on 28 March 2020.

No inmate has contracted COVID-19 while in custody in NSW.

Corrective Services received one positive COVID-19 inmate on 26 July 2020, after his arrival in NSW from Victoria. At all times the inmate was treated as a suspected case. The inmate was isolated appropriately, and, on confirmation of positive status, transferred to the Metropolitan Remand and Reception Centre Isolation Hub. The inmate was transferred out of the Isolation Hub on 21 August 2020 after a negative test result and clearance from Justice Health. There have been no other confirmed cases among inmates since.

(15) Corrective Services implemented a range of initiatives to address the impact of the suspension of in person visits and other COVID related precautionary measures. Corrective Services did not pursue COVID related 'lockdowns' in response. To mitigate disruption to family relationships caused by the suspension of visits, correctional centres took action to increase inmate access to free telephone calls with up to three free calls permitted a week (up to 8 January 2021). AVL technology was increasingly made available for family visits. To date, more than 250,000 video visits have been facilitated for inmates.

"Stop the Spread" posters and flyers were distributed to inmates on hygiene practices to help protect themselves and staff. Where Corrective Services

Industries employment ceased, inmates continued to receive an average wage for up to six weeks. The inmate weekly buy-up limit was temporarily increased to \$150 a week and the monthly deposit limit into an inmate's account was temporarily raised to \$800.

Corrective Services also provided support for inmates required to be isolated due to displaying COVID like symptoms. This included inmates receiving well-being and activity packs in-cell, prioritising mental health referrals, keeping them informed about COVID-19 and ensuring they had access to services where possible.

Corrective Services continues to work with Justice Health to ensure that the needs of those who may be more at risk are considered. Justice Health has identified and monitors inmates at increased risk.
