- \* 6844 ENERGY AND ENVIRONMENT—INVESTIGATION OF RURAL LAND CLEARING JERVIS BAY ROAD—Mr Justin Field to ask the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts representing the Minister for Energy and Environment—
  - (1) Regarding Question without notice by Justin Field MLC on 12 May 2021 and answered by The Hon. Don Harwin MLC on 2 June 2021 regarding 'Land Clearing" and relating to rural land clearing

at corner of Jervis Bay Road and the Princes Highway — specifically lot 3, DP 24495 in the Shoalhaven local government area.

The answer indicated that as a result of a review requested by Local Land Services of the Native Vegetation Regulatory Map, the land was reclassified and remapped from Category 2 Sensitive Regulated Land to Category 2 - Regulated Land and that "The Department followed the standard practice to review the available recent and historical aerial imagery and had found clear evidence of past logging on the site was visible in 30 imagery in 2009 and 2014" and that "past disturbance and the amount of regrowth trees meant the site no longer met the definition of old growth forest":

- (a) Please provide (in electronic form) the 'reclassification assessment' report completed as part of this review request?
  - (i) If the report cannot be provided, please explain why?
- (b) Please outline the "standard practice" referred to in the answer?
- (c) What is the definition of "old growth forest" used in making this assessment?
- (d) Did any Department of Planning and Environment (DPIE) officials visit the site as part of this assessment process before making the determination to remap the area?
  - (i) If yes, what were the dates of the visits?
  - (ii) What are the qualifications of the DPIE officials who visited the site?
- (e) Please provide the imagery relied on in making the review judgement?
- (f) Did DPIE make a judgement about when historical logging/clearing on the site had occurred?
  - (i) If yes, when did it consider that recent clearing/logging had occurred on this site?
  - (ii) Did any of these findings trigger consideration of an investigation into potentially illegal land clearing under the previous Native Vegetation Act?
  - (iii) Did any of these findings trigger consideration of an investigation into potentially illegal land clearing under the current laws?
- (g) Did DPIE liaise with any agencies/organisations, other than Local Land Services, as part of this assessment?

Answer—

I am advised:

(1)

- (a) The report contains private personal information and as such cannot be released.
- (b) The *Local Land Services Act 2013* (LLS Act) contains provisions which allow the Environment Agency Head to re-categorise land if they obtain new or improved information about historical vegetation cover or land use for a particular landholding.

Section 60L of the LLS Act provides that relevant landholders may request that the Department of Planning, Industry and Environment(DPIE) review a decision related to the categorisation or re-categorisation of land on the Native Vegetation Regulatory map.

Clause 120(1)(b) of the Local Land Services Regulation 2014 requires landholders seeking review to specify the information the landholder is relying on in seeking a particular

categorisation of the land, including but not limited to, which provision in Part 5A of the LLS Act authorises the categorisation sought and any information relevant to determine whether or not the land meets the requirements for categorisation specified in that provision.

Upon receipt of an application, DPIE checks that it is a valid application and if so, the application is accepted. Qualified experts in DPIE then review relevant information including aerial imagery to first assess whether a determination can be made. If the determination cannot be made based on this, field assessment may occur.

- (c) The definition of old growth forest used was from "Private Native Forestry Code of Practice Guideline No 2: Protocol for re-evaluating old-growth forest on private property, published in August 2007 by the then Department of Environment and Climate Change". The definition includes ecologically mature forest where the effects of disturbance are now negligible that have an area of forest greater than five hectares where:
  - the overstorey is in late to over-mature growth stage with the presence of relatively large old trees (many containing hollows and often with the presence of dieback or dead branches in the crown), and
  - □ the age (growth) structure of the stand measured as relative crown cover consists of less than 10 per cent of regeneration and advance growth, and more than 10 per cent of late to overmature (senescent) growth, and
    - the effects of unnatural disturbance are now negligible.
- (d) No.
- (e) Imagery cannot be interpreted without using high resolution 3D digital photogrammetric tools. Expert training is required for accurate interpretation. Specifically, 2009 and 2014 3D images were used in making the original assessment.
- (f) Not specifically. Expert assessment identified that historical logging occurred at an unknown time prior to the 2009 aerial image reviewed, and therefore the effects of the logging disturbance were still present between 2009 and 2014. This addressed Criterion 3 of the Private Native Forestry Code of Practice Guideline No 2, which was the statutory purpose of the assessment.

Evidence of historic logging can still be seen via image interpretation many years after the logging event has occurred. This could include tracks that were cut through the forest to pick up logs, gaps in the forest canopy and evidence of regrowth following the logging.

Historic logging may have occurred long in the past prior to regulation of vegetation, or it may have occurred between 1995 and 2009 under legal provisions.
