Answer-

(1)

- (a) Yes. I have written to the Hon David Littleproud MP, Minister for Agriculture and Northern Australia requesting that the National Farmers Federation (NFF) be invited to present the results of their recently completed report on income protection options (Future-Proofing Farming, Collaborating to manage risk and build resilience) to all jurisdictions at a future meeting of the Agriculture Ministers Meeting.
- (b) NSW DPI has raised the report and its recommendations with the Secretary of the Department of Agriculture, Water and the Environment and at the Agriculture Senior Officers Committee (AGSOC). The report will be further discussed at a future AGSOC meeting.

Answer-

- (1) Comparison of year on year expenditure as annual research and development expenditure is subject to seasonal conditions, identical to that of the primary producers we support. As such, during the period in question, NSW DPI incurred in excess of \$1 billion in costs as detailed in the relevant budget papers.
- (2) As above, the level of investment in R&D also creates fluctuations in staffing levels. During the period in question, NSW DPI has maintained scientific and technical staff levels in excess of 600 plus staff (800 when considering casuals and contractors).
- (3) Both the budget and actual allocation for Research and Development can be found in Budget Paper 2 Outcome Statement 2021-22.

Answer-

I am advised:

(1) The purpose of the NSW mobile speed camera program is to deter motorists from speeding at all times, not only when they see speed enforcement.

Best practice evidence shows that this is achieved through less visible enforcement, operating randomly across a large number of locations. This unpredictability of speed enforcement that could occur any time or anywhere, encourages drivers to comply with speed limits at all times. This reduces the risk of a speed-related crash across the entire road network, and associated trauma.
