 - Dealing with identity information with the intention of committing, or facilitating the commission of an indictable offence.
 - Fraud – Dishonestly obtains financial advantage, or causes financial disadvantage by deception.
 - Knowingly dealing with the proceeds of crime with intent to conceal that it is proceeds of crime.
 - Knowingly dealing with the proceeds of crime.
 - Recklessly dealing with the proceeds of crime.
 - Participating in a criminal group.
