I am informed NSW Health data indicates that three people in NSW have been re-infected with COVID-19 since the start of the COVID-19 pandemic.

Some 40,000 Pfizer doses were reallocated from NSW Health vaccination clinics to assist in the public health response to vaccinate HSC students in Local Government Areas of concern. On 5 August 2021, the Australian Government announced that NSW would receive 180,000 Pfizer doses that have been used to reinstate all bookings that were cancelled.
