- * 7179 EDUCATION AND EARLY CHILDHOOD LEARNING—SEGREGATION OF STUDENTS—The Hon. Mark Latham to ask the Minister for Education and Early Childhood Learning—
 - (1) Why did the Milton Public School segregate Aboriginal and non-Aboriginal students in its Olympics parade last month, with the students marching under different 'national' banners of Aboriginal and Australia?
 - (a) Is the Minister concerned that this segregation will encourage students to think of:
 - (i) Aboriginal as a separate country that should raise its own taxes and solve its own problems?
 - (ii) Each other as divided on the basis of race?
 - (2) Will the Minister now instruct Milton and other government schools not to segregate their students on the basis of race?

Answer—

I am advised that on 24 June 2021, students at Milton Public School enjoyed a celebration of the Olympic ideals and activities during a Special Events Sports Day.

The opening ceremony involved an Acknowledgement of Country, Olympic Oath, National Anthem and the presenting and flying of the Olympic, Australian and Australian Aboriginal flags by representative student leaders. Student leaders who were part of the official party walked into the ceremony behind these flags. These students then joined their class groupings – which were aligned to countries other than Australia – to compete in the activities after the opening ceremony.

NSW public schools are places of inclusion. It is incredibly disappointing that the intended purpose of the opening ceremony – to promote the Olympic ideals and spirit of inclusive activities – has been misconstrued.

- * 7180 CUSTOMER SERVICE—SERVICE NSW APP DATA SAFETY—Reverend the Hon. Fred Nile to ask the Minister for Finance and Small Business representing the Minister for Customer Service, and Minister for Digital—
 - (1) In 2020 more than 104 000 users of the Service NSW app had their data stolen through a cyber attack:
 - (a) Will the data gathered by the COVID Safe Check-In be deleted once the lockdowns and associated public health regulations are withdrawn?
 - (b) What assurances will the Minister provide users of the Service NSW app that their private details are actually safe?

Answer-

(1)

- (a) Service NSW holds check-in data (from the COVID Safe Check-in Tool) for a period of 28 days, from the date it was collected. If an individual's contact details are not required by NSW Health, they are deleted at the end of the 28-day period in accordance with data purging process controls. No back-up copies of this data are retained.
 - For reporting purposes only Service NSW retains aggregate and de-identified headcount information relating to the time at which a person has entered a premise. This is to assess a participating COVID Safe venue's compliance with COVID-19 rules.
- (b) Service NSW takes reasonable security measures to protect all personal information we hold from loss, unauthorised access, use, modification, disclosure or other misuse this includes the Service NSW app. Service NSW ensures that personal information is stored securely, not kept longer than necessary, and disposed of appropriately. Strong data encryption

mechanisms are also used to protect personal information during data transmission and storage.

Using the COVID Safe Check-In tool via the Service NSW app means that customers don't need to repeatedly provide personal information at each check-in – customers can access this by logging in with their MyServiceNSW Account or registering to use the tool as a 'guest'. Service NSW only collects an individual's contact details (including name, email address and phone number) as well as the details of the premise the individual attended and the time and date of their attendance. All check-in data held by Service NSW is stored in an encrypted database and is accessible only by NSW Health through a restricted authenticated interface for the purposes of COVID-19 contact tracing.

As noted above, if a customers' contact details are not required by NSW Health, the contact details are deleted by Service NSW at the end of the 28-day period in accordance with data purging process controls and no back-up copies of this data are retained. The Privacy Collection Statement for the COVID Safe Check-in outlines the data storage, retention and deletion requirements for the check-in tool, in detail. This is publicly available on the Service NSW website.

 - (1) Has an independent inquiry commenced into the Parklea Correctional Centre riots that occurred on Monday, 12 July 2021?

 - (b) What is the reporting timeline for the inquiry?
 - (2) If an independent inquiry into the Parklea Correctional Centre riot that occurred on Monday, 12 July 20201 has not commenced:

Answer-

As at 13 August, I am advised:

The NSW State Coroner has jurisdiction under Part 3.3 of the Coroners Act 2009 to hold an inquiry concerning the fire at Parklea Correctional Centre. Corrective Services NSW is awaiting the Coroner's direction under the Act as to whether she will conduct an inquiry.

Internal reviews of the incident by Corrective Services NSW and also Management & Training Corporation Pty Ltd and Broadspectrum (Australia) Pty Ltd (MTC-BRS), as the private operator of the Parklea Correctional Centre, are currently underway.

As contractually required, the operator has engaged a senior correctional administrator with extensive operational and corporate experience across several Australian correctional jurisdictions, including New South Wales, to formally investigate the incident at Parklea Correctional Centre. Corrective Services NSW is awaiting the findings and results of the formal investigation, where any recommendations will be reviewed and implemented where necessary.

- * 7184 FAMILIES, COMMUNITIES AND DISABILITY SERVICES—COVID-19 VACCINATION PROGRAM YOUTH JUSTICE CENTRES—The Hon. Tara Moriarty to ask the Minister for Sport, Multiculturalism, Seniors and Veterans representing the Minister for Families, Communities and Disability Services—

Answer-

I am advised:

Vaccinations are being pursued across Youth Justice.

Vaccinations are of upmost importance, which is being stressed to all staff across Youth Justice.

A directive has been issued to all Youth Justice staff, emphasising that vaccination remains our number one strategy for protecting young people, staff and their loved ones against serious complications that can arise from COVID-19 infection.

Youth Justice and NSW Health have provided, and continue to provide, regular opportunities for all staff to be vaccinated.

Information regarding vaccinations and the need to get vaccinated is also provided directly to Youth Justice detainees.

Medical experts from Justice Health continuously engage with the broader Youth Justice workforce, to prioritise vaccinations and safety.

Justice Health experts also lead all discussions with detainees on these matters.

- * 7185 TRANSPORT AND ROADS—MOBILE SPEED CAMERAS—Reverend the Hon. Fred Nile to ask the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts representing the Minister for Transport and Roads—
 - (1) I refer to the answer provided by the Minister in answer to Question on Notice 6940 which suggests that the randomness and unpredictability of mobile speed cameras saves lives, given that we are in lockdown and road volume is drastically diminished:
 - (a) What relevant evidence is the Minister basing his answer on?
 - (b) Does the Minister stand by a panopticon-style approach to road safety?

Answer-

I am advised:

Speed camera enforcement is one of the most effective, evidence-based measures to reduce speeding, save lives and prevent injuries.

Research and evaluation evidence has established that randomness/unpredictability is a key principle in the effective deployment of mobile speed cameras. A review of good practice regarding mobile speed cameras is publicly available on the NSW Centre for Road Safety website.

Between March and July 2020, while significant travel restrictions were in place for COVID-19, 54 per cent of all fatalities had speed as a factor. By comparison prior to COVID-19, speed was a factor in 35 per cent of fatal crashes for the same period in 2019. During the first 51 days of the current lockdown period, 32 people have died on roads, with speed-related fatalities at 31 per cent.

Pleasingly most people are doing the right thing and more than 98 per cent of drivers who are passing a mobile speed camera are not caught speeding.

Answer-

Racing NSW is established by the Thoroughbred Racing Act 1996 (the Act) as the controlling body for thoroughbred racing in this State. It does not represent the Crown and is not subject to control or direction by the Government.

Racing NSW's responsibilities under the Act and the Rules of Racing (Rules) include controlling, supervising and regulating thoroughbred racing, investigating and enforcing penalties for breaches of the Rules and initiating, developing and implementing relevant policies.

As such, these questions should be directed to Racing NSW.

- * 7187 ENERGY AND ENVIRONMENT—EMERALD BEACH—The Hon. Mark Pearson to ask the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts representing the Minister for Energy and Environment—
 - (1) In regards to the case with Fiddaman Road at Emerald Beach:
 - (a) How is it that a nature reserve and NSW National Parks and Wildlife Service (NPWS) defined wildlife corridor has been allowed to be desecrated through the common use of an unofficial, ungazetted road to the extent the road and surrounds is now being considered for a significant infrastructure project?
 - (b) Can the Minister explain the responsibilities of the Department in ensuring nature reserves and wildlife corridors, such as those at Emerald Beach, are kept free from human use as far as possible?
 - (c) Please explain what efforts have been made to protect this specific area to date?
 - (d) How is it legislatively possible for infrastructure of this nature (i.e. a playground) to be built in a nature reserve, particularly when NPWS itself considers the area a wildlife corridor?
 - (2) Given the current work on the Coffs Harbour Bypass (part of the Pacific Highway Upgrade):
 - (a) Was the Department contacted about the impact of this upgrade on wildlife?
 - (i) If so, what correspondence took place?
 - (ii) What infrastructure is being established to allow the free movement of native animals?

Answer-

I am advised:

(1)

- (a) The Hon. Mark Pearson MLC in his question on Fiddaman Road is referring to existing public facilities in Emerald Beach day-use area in Coffs Coast Regional Park. The day-use area is highly used by the local community and visitors to the coastal village with existing picnic facilities, playground, toilets, access road, parking and beach access tracks. Recently a master plan to replace and improve these facilities was exhibited through Coffs Harbour City Council's 'Have Your Say' website. Fiddaman Road provides access to the day-use area and beach. The road has existed for over 50 years and, as the road is on national park estate, there is no requirement for the road to be 'gazetted' or in a road reserve. In 2019, a survey of all 1000 properties in Emerald Beach indicated strong community support for the road to remain. From the 400 responses received, 74 per cent wanted the road to remain open.
- (b) Emerald Beach day-use area is in Coffs Coast Regional Park and not in a nature reserve. Regional parks in NSW tend to be more modified and provide more recreational facilities than other types of reserves managed under the *National Parks and Wildlife Act 1974*, such as national parks and nature reserves. The site of the day-use area has had a long history of farming and recreational open space and is a highly modified environment. Moonee Beach Nature Reserve is located adjacent to the regional park and includes the nearby Dammerel and Look At Me Now headlands. The nature reserve is primarily managed to conserve ecosystems, species and natural processes. The nature reserve only contains a carpark and paved walking tracks, designed and constructed to protect threatened species.
- (c) Implementation of the exhibited master plan to improve facilities in the day-use area will assist in the protection of coastal vegetation through limiting where cars can drive and park. Creating more space on the eastern side of Fiddaman Road will enable enhancement of the dune vegetation. Walking paths are being designed to limit trampling of sensitive vegetation and the planting of coastal tree species, such as banksia and tuckeroos, throughout the day-use area will improve visitor amenity and provide environmental benefits. In addition, the National Parks and Wildlife Service (NPWS), supported by Coffs Harbour City Council, undertakes an extensive annual program of environmental projects in Coffs Coast Regional Park including bush regeneration, pest control, fauna monitoring and fire management.

NPWS staff, contractors and 10 Landcare volunteer groups undertake these works to protect coastal vegetation and threatened species.

(d) Emerald Beach day-use area is part of Coffs Coast Regional Park. Facilities, such as playgrounds, picnic areas, toilets, roads, walking tracks and car parking are appropriate facilities for a regional park. The *National Parks and Wildlife Act 1974* and the adopted plan of management for the regional park permit these types of facilities. Many of the existing facilities are degraded after high levels of use over many years. The proposed replacement and upgrade of existing facilities aims to provide contemporary facilities that meet safety standards and community needs. Community feedback from the exhibition of the master plan has indicated strong community support for the proposed plan. Implementation of the master plan will include protecting and enhancing existing coastal vegetation providing benefits to wildlife.
