- * 7197 LOCAL GOVERNMENT—COUNCIL DISSATISFACTION—Reverend the Hon. Fred Nile to ask the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts representing the Minister for Local Government—
 - (1) The Snowy Valley Council's Community Satisfaction Survey only had 14 per-cent of residents from all over the Snowy Valleys Council area who rated the performance of the council as "good" or "very good" whereas 62 per-cent responded 'highly dissatisfied' with management of the council:
 - (a) The Snowy Valley Council has rated below the New South Wales Regional Council average and is the lowest performing Council in the database:
 - (i) What actions does the Minister intend to take to address the dissatisfaction of the constituents in the Snowy Valley Council?
 - (ii) Will the Minister consider changing direction by following the Independent Boundaries Commission's findings and recommend that the Snowy Valleys Council be demerged?

Answer-

I am advised:

Under the *Local Government Act 1993* councils are largely independent and self-governing bodies with rights and powers conferred by law. Ultimately, councils are accountable to their communities for their performance and the decisions they make, with voters casting judgement at the local government elections on 4 December 2021.

The NSW Government remains committed to supporting councils across the state to deliver and improve infrastructure, services and facilities for local communities. Since 2010-11, the Government has provided over \$11 billion in funding to local councils. This significant contribution recognises the role councils play in providing vital services and infrastructure for their local communities.

The reports received from the Local Government Boundaries Commission on this proposal did not provide a clear consensus on the issue of demerging and did not provide me with the necessary confidence to make a recommendation to the Governor that the proposal be implemented.

I made the decision on this proposal after finalising my consideration of the reports, as required under the *Local Government Act 1993*. The decision provides both the council and its community with certainty and a plan for the future.

I have also announced an independent statutory review into the Local Government Boundaries Commission.

The review will examine the effectiveness of the membership composition, functions and processes of the Local Government Boundaries Commission.

- * 7198 LOCAL GOVERNMENT—REGIONAL COUNCIL MERGERS—Reverend the Hon. Fred Nile to ask the Special Minister of State, and Minister for the Public Service and Employee Relations, Aboriginal Affairs, and the Arts representing the Minister for Local Government—
 - (1) The Independent Boundaries Commission recommended to demerge Snowy Valleys Council after a 3 year process involving three separate proposals, public hearings, a record number of public submissions, and overwhelming community support for the demerger: 88 per-cent in the former Tumbarumba Shire, and 51 per-cent in Tumut:
 - (a) Why has the Minister refused to accept the independent Boundaries Commission recommendations to demerge Snowy Valleys Council?

- * 7199 HEALTH AND MEDICAL RESEARCH—NSW HEALTH FUNDING ADVICE ON SEX TOYS AND ANAL SEX—Reverend the Hon. Fred Nile to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Health and Medical Research—
 - (1) I refer the Minister to the NSW Health Website entitled 'Play Safe'- playsafe.health.nsw.gov.au. This website provides advice on Covid-19 safe sex, mutual masturbation and sex toy cleaning advice. Additionally, there is a public forum with such topics as 'what is your favourite sex toy' and 'flavoured condoms yay or nay'. A government moderator on this forum also provides advice on how to perform anal sex:
 - (a) Is the Minister aware of this website?
 - (b) How much has this website cost the New South Wales taxpayer?
 - (c) Who approved this website?
 - (d) What provisions has NSW Health taken to prevent minors from accessing this material?
 - (e) Will the Minister remove this website as a matter of urgency?
 - (f) What safety provisions are in place to prevent paedophiles from accessing this forum designed for young Australians?

- (a-f) I am aware of the Play Safe website, which was approved and funded by NSW Health. The forum requires a date of birth on registration and is targeted at young people aged 15-29. This section of the community has the highest rates of notifiable sexually transmissible infections, including Chlamydia. Moderators adhere to a detailed risk management strategy, which includes specific strategies to ensure the safety and well-being of young people.
- * 7200 AGRICULTURE AND WESTERN NEW SOUTH WALES—SHOALHAVEN ZOO—The Hon. Emma Hurst to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Agriculture and Western New South Wales—
 - (1) In answers to questions on notice published on 9 August 2021, the Minister indicated that, at a recent audit of Shoalhaven Zoo, corrective action was raised in respect to the 'nutrition, hygiene and health' and 'records and procedures':

 - (iii) The specific corrective action that Shoalhaven Zoo was required to undertake?
- (d) With respect to the corrective action raised relating to 'records and procedures', please provide details of:
 - (i) the specific non-conformances that the DPI found at the audit?
 - (ii) whether the corrective action request was classified as 'minor', 'major' or 'critical'?
 - (iii) the specific corrective action that Shoalhaven Zoo was required to undertake?
- (e) How long have Shoalhaven Zoo been given to undertake the corrective action?
- (f) When is the next inspection of Shoalhaven Zoo expected to take place?
