(1-2) The Energy Accounts Payment Assistance (EAPA) scheme helps NSW households experiencing financial hardship due to a sudden financial crisis or emergency to pay their electricity or natural gas bills. The EAPA scheme is a parameter-driven program with customer approvals based on meeting eligibility criteria. Vouchers are not limited by location.

To be eligible, customers must be the energy account holder, have (or be applying for) a residential address in NSW and be experiencing financial hardship due to a sudden financial crisis or emergency. Eligible customers can receive one or more \$50 vouchers from energy retailers to help them pay their current energy bill. Customers can receive up to two transactions per financial year. Customer eligibility is assessed by EAPA Providers.

The Department of Planning, Infrastructure and Environment does not report the number of households that receive EAPA vouchers per LGA or state electorate. This is to protect customers' privacy in low population areas.

In the last two months, EAPA Providers have delivered a total of \$2,318,200 in EAPA vouchers to 8,563 eligible customers

During the period 1 July 2021 – 24 August 2021, the LGA of Canterbury Bankstown had 4,477 total EAPA voucher applications which represents \$\$223,850 in assistance provided to households.

The NSW Government's EAPA Assessment Team is being scaled up to manage the increased demand for EAPA and support the response to the COVID-19 Delta Outbreak. On 5 August 2021, the NSW Government announced it would increase the maximum EAPA transaction limit per fuel type from \$300 to \$400. EAPA applications from Service NSW surged from an average of 150 to 600 per day.
