The 'gift test' is additional guidance and helps inform whether a gift should be accepted or declined.

Sydney Trains has temporarily reduced staff at a number of its smaller train stations in response to the COVID-19 pandemic and associated Public Health Orders.

No employees have been stood down and station employees have not been reallocated to perform new duties. Instead, station employees have been utilised within their current role descriptions across the network.

(1-2) The Department of Education continuously monitors population and development trends so that it can plan to meet enrolment needs in government schools across NSW. Longer term projections are informed by census data, as well as dwelling and population forecasts, provided by the Department of Planning Industry and Environment (DPIE) in conjunction with local councils. DPIE prepares and releases these population projections to NSW Government agencies, and other organisations including Councils, to ensure a consistent view of the future NSW population. This enables NSW Government agencies to work with an agreed set of projections for proposals, business plans and strategies.

The Department's NSW student population projections are based on the NSW Population Projections. School Infrastructure NSW produces a range of investment cases and major projects for increasing supply, which are Cabinet in Confidence until approved by the NSW Government.

Numerous strategies are used in the short to medium term to manage fluctuating enrolment demand, such as reviewing school intake areas, enforcing the Department's enrolment policy, and the use of demountable buildings. The utilisation of demountable buildings also allows the Department to be highly responsive to school enrolment needs. In cases of sustained and longer term enrolment growth, capital works interventions may be considered.

(1-5) Since March 2020, the NSW Government's response to COVID-19 has been flexible and scalable to respond to the evolving situation. The NSW Government has committed to help transform our healthcare system to increase its capacity and ensure it is well placed to manage the ongoing impacts of COVID-19.

NSW Health monitors Intensive Care Unit (ICU) utilisation and capacity in real time and can significantly expand ICU beds if required. Additional ventilators and other necessary equipment have been purchased to meet increased demand for ICU services.

Local health districts and speciality health networks have developed workforce surge and demand management plans to ensure there is sufficient capacity across NSW to manage both non-COVID-19 patients and patients with COVID-19.

I am advised:

A clearer, simpler pathway for delivering new seniors housing is being introduced as part of the proposed Housing State Environmental Planning Policy. The proposed policy was recently exhibited for public comment and is expected to be finalised before the end of 2021.

The seniors living design guide is also being reviewed to ensure that housing for seniors and people with disability is designed to meet the needs of residents.

Regulatory analysis is currently being undertaken by the Australian Building Codes Board regarding options for potential minimum accessibility standards for housing applied through the National Construction Code.

Landcom's Housing Affordability and Diversity Policy targets apply to projects that commenced between the 2017 and 2021 financial years.

Landcom released a total of 432 dwellings in scope with the Universal Housing target from 2017-2021, and met its target of 20% dwellings with a minimum of 'silver level' standard (86 dwellings).

The NSW Land and Housing Corporation (LAHC) is responsible for social housing delivery and applies a minimum Liveable Housing Australia Silver Level rating to all of its new social housing properties where level (step-free) access is available, including ground level and dwellings serviced by a lift. Where properties comprise upper level dwellings without a lift, LAHC applies a Silver Level equivalent rating to the internal spaces.

The NSW Apartment Design Guide (the Guide) currently includes a benchmark of 20 per cent of apartments to incorporate Silver Level universal design features. Local council planning rules can require apartment developments to consider and apply these standards, and take the Guide's benchmarks into consideration when assessing apartment development applications.

The Guide is currently under review as part of the development of the new Design and Place State Environmental Planning Policy, and an updated draft Guide will be exhibited for public comment later this year. This Guide will form part of any future universal housing design guide, and is structured to enable alignment of future design guidance for other housing types.

The NSW Government introduced a new comprehensive housing strategy in

May 2021 that sets a strategic vision and holistic approach to delivering good housing outcomes across for pillars of supply, diversity, affordability and resilience.

While Housing 2041 outlines the long-term vision and objectives for housing in NSW, inaugural actions for delivery in the first two years have been outlined within the first Action Plan, for delivery in 2021-2022.

Teams within the Department of Planning, Industry and Environment (the Department) are facilitating the delivery of the following action items within the Housing Strategy Action Plans:

- 2.5.1 Develop a unified housing design guide, that will include the principles of intergenerational living and universal design (Government Architect NSW)
- 2. 7.1 Consider the proposed changes to the National Construction Code to increase the accessibility of housing for all people (Department of Customer Service in partnership with other NSW Government agencies)
- 2.7.2 undertake further research to assess the cost-benefit of introducing, potentially, mandatory universal design requirements in NSW (Housing and Property)
- 2.7.3 Prepare new universal design guidance to ensure NSW Government takes the lead (Housing and Property and Department of Communities and Justice). Note that this action item has been part completed as the Disability Inclusion Action Plan Guideline has been updated to reference universal design.

The NSW Apartment Design Guide is currently under review as part of the development of the new Design and Place State Environmental Planning Policy, and an updated draft Guide will be exhibited for public comment later this year. This Guide will form part of any future unified housing design guide, and is structured to enable alignment of future design guidance for other housing types.

Work to understand the costs and benefits associated with 2. 7.2 is underway, with ongoing collaboration between the Department of Planning, Industry and Environment and the Department of Customer Service to understand the state wide and national implications of future universal housing design requirements in NSW.

(a-b) COVID-19 is a highly contagious and potentially fatal condition. Restrictions on movement and gathering have been implemented throughout the pandemic to keep people safe and prevent transmission of the disease, particularly to at-risk and vulnerable people. Restrictions are reviewed on a regular basis and will be eased as soon as it is safe to do so.

NSW Government agencies are working in partnership with local Aboriginal organisations and health services to deliver culturally appropriate COVID-19 public health responses that are informed by community need.

NSW Health has collaborated with the Australian Government and local primary care, including the Aboriginal Medical Services, to boost access to COVID-19 vaccines for communities in the Western NSW Local Health District, including pop-up vaccination clinics and mobile teams in over 30 communities to date.

(a) To deal with the public health risk of COVID-19 and its possible consequences, the Minister for Health and Medical Research has made a number of Orders, under section 7 of the Public Health Act 2010, which are aimed at protecting all NSW citizens including the NSW Aboriginal community. These orders are aimed at keeping community safe and protecting Elders, and include restrictions of the movement of people into regional areas.

Aboriginal Affairs NSW has been working directly with Aboriginal communities to ensure their voice is heard and they have input about decisions impacting their communities.

- (b) While the NSW Government is aware of the impact of disconnection from country and kin has on Aboriginal peoples, the priority remains ensuring that all communities are kept safe through compliance with Public Health Orders.
- * 7559 HEALTH AND MEDICAL RESEARCH—FRIENDS BUBBLE—The Hon. Rod Roberts to ask the Minister for Mental Health, Regional Youth and Women representing the Minister for Health and Medical Research—

Answer-

Encouraging adults to get vaccinated against COVID-19 reduces their risk of severe illness, hospitalisation, and death. This helps to keep people, their families, and the whole community safe, including children under 12 years of age that are not yet eligible for COVID-19 vaccination.

Restrictions will be eased further when NSW passes the 70 per cent double dose COVID-19 vaccination target for adults. The four-step National Plan agreed by National Cabinet outlines Australia's planned transition to post-vaccination settings focused on public health management of COVID-19, consistent with other infectious diseases.
