* 6324 RURAL RESILIENCE PROGRAM—Mr Roy Butler to ask the Minister for Agriculture and Western New South Wales—

- (1) Will Resilience NSW continue to offer the same services as previously offered by the Rural Resilience Program?
- (2) Have staff who were previously employed under the Rural Resilience Program been re-employed under Resilience NSW?
- (3) Can you provide a summary of services provided by the previous program?

Answer—

- (1) Resilience NSW will be building on the success of the Rural Resilience Program by capturing and sharing the common principles, approaches, and emerging evidence of what works across a range of past and present community resilience-building programs and activities. Resilience NSW will continue to invest in and support delivery of outcomes-focused and evidence-informed resilience-building programs and services.
- (2) All on-going Rural Resilience Program staff were provided with the opportunity to transfer to Resilience NSW, alongside other options.
- (3) The Rural Resilience Program provided the following services:
 - Link individuals, families & businesses with support programs and assistance packages
 - Assist community to run events or skill building activities as identified by communities as resilience building initiatives
 - Provide support to existing Rural Service Support Networks which connect community, industry, and the public and private sector to collaborate and achieve shared initiatives
 - Provide support to the Department's emergency response efforts and recovery following natural disasters
 - Provide support to animal owners involved in stock welfare panels to link them with support services including Rural Financial Counsellors.

* 6325 BANKSIA MENTAL HEALTH UNIT—Mr Roy Butler to ask the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—

- (1) How many patients attended the Banksia Mental Health Unit by town or Local Government Area annually since 2010?
- (2) Is the predictive population, used as the basis for the modelling of future regional and Tamworth mental health facility requirements, supplied by the Department of Planning?
 - (a) Is this number less than the planning number used by Tamworth Regional Council's Tamworth Regional Blueprint 100, the Moree Special Activation precinct and the Narrabri Shire Inland Port for future population predictions?
- (3) Is the new Tamworth regional mental health (Banksia) facility being planned using adequate population projections?

Answer—

- (1) From 2010 to December 2020, there were 4117 patients admitted to the Banksia Mental Health Unit from more than 60 Local Government Areas, including in New South Wales and other states.

- (2-3) The new Banksia Mental Health Unit is being planned using the National Mental Health Services Planning Framework - a nationally endorsed population based mental health planning model. The Framework utilises official NSW Department of Planning, Industry and Environment population projections developed for NSW Health.

The Framework is one of several sources of information used to support New South Wales mental health planning. Planning is also informed by community consultation, analysis of local demographics, analysis of health services' activity data, resource and infrastructure availability, as well as models of care, service structures and expert local knowledge.

The New South Wales population numbers used in the Framework's Planning Support Tool are NSW Health population projections based on data from the NSW Department of Planning, Industry and Environment (DPIE).

(2) What date will the air purifiers be installed in the aforementioned schools and fully operational?

Answer—

The Government is delivering a \$100 million air quality assurance program to support ongoing improvements to air quality in New South Wales schools.

The vast majority of spaces in schools are adequately ventilated through natural and mechanically assisted ventilation.

Air purification is only recommended where air quality is compromised by bush fire smoke or where natural ventilation cannot be achieved. The Department of Education will provide air purifiers to schools as required.

The department's approach to ventilation in schools is strongly supported by expert advice.

* 6327 BARDIA PUBLIC SCHOOL TRAFFIC LIGHTS—Mr Anoulack Chanthivong to ask the Minister for Planning and Public Spaces, and Minister for Transport and Roads—

(1) In relation to the planned traffic signals at the intersection of MacDonald Road and Arthur Allen Drive, Bardia:

(a) Has Dahua Group submitted modified plans to Transport for NSW for approval?

(i) If yes, when were they submitted?

(ii) If no, when will they be submitted?

(b) What, if any, consideration will be made to fast-track the traffic lights to improve pedestrian safety at this intersection?

Answer—

I am advised:

Transport for NSW is yet to receive modified plans for the signalised intersection. Transport for NSW will review the modified plans once submitted by the developer. Approval for the project will be given subject to all relevant guidelines being complied with and the developer entering into a Works Authorisation Deed with Transport for NSW.

* 6328 ELIGIBLE FORMS OF TRANSPORT FOR IPTAAS SUBSIDY—Mrs Helen Dalton to ask the Minister for Health and Medical Research—

Given the Isolated Patients Travel Accommodation Assistance Scheme (IPTAAS) allows eligible people to claim a subsidy towards private vehicle travel, public transport (trains, buses, ferries and taxis), air travel (in special circumstances), accommodation, and the cost of having an escort/carer support a person during their treatment, but does not cover other forms of transport, will consideration be given to allow the IPTAAS subsidy to be used for similar forms of transport to those eligible, such as nonemergency community transport?

Answer—

A patient may be eligible for a travel subsidy if the community transport provider does not receive government funding.

* 6329 DOMESTIC AND STOCK WATER EXTRACTIONS—Mrs Helen Dalton to ask the Minister for Water, Property and Housing—

(1) Has the Government ever published 'reasonable use guidelines' and/or an upper extraction limit for domestic and stock water rights under the Water Management Act 2000?

- (2) Are extractions for domestic and stock purposes required to be metered and measured?
- (a) If not, how are domestic and stock extractions regulated, and the Water Management Act 2000 enforced?

Answer—

- (1) No
- (2) Water taken for domestic and stock purposes under a Basic Landholder Right under the Water Management Act 2000 does not to be licensed and is exempt from the non-urban water metering rules. Further, water taken under a domestic and stock access licence, for pumps less than 100mm or bores less than 200mm diameter, will be exempted under new regulations, provided the water supply work is not used for other types of licensed take and required to be metered according to non-urban water metering rules, or under other licencing or approval conditions.
- (a) Domestic and stock rights may only be used for domestic consumption and stock watering purposes, as defined by the Water Management Act 2000.

The Natural Resources Access Regulator (NRAR) is responsible for enforcing natural resources management legislation, including the Water Management Act 2000. NRAR's Regulatory Policy and Prosecution Guidelines set out the approach to enforcement and prosecution.

- * 6330 ZERO EXTINCTIONS IN THE SNOWY CATCHMENT—Mrs Helen Dalton to ask the Treasurer, and Minister for Energy and Environment—

How does the Government reconcile its policy of zero extinctions with the fact that Snowy 2.0 has an extremely high certainty - approaching a probability of 1 over the longterm - of introducing Climbing Galaxias into Tantangara Reservoir, thereby threatening the likely extinction of Stocky Galaxias?

Answer—

There are a range of measures in place to give effect to the National Parks and Wildlife Service Threatened Species Framework, including its goal of zero extinctions across the national park estate.

Service NSW does not have a location breakdown for phone calls, all are anonymous.

- * 6332 SUPPORT FOR YOUTH IN GREATER SYDNEY—Ms Julia Finn to ask the Minister for Health and Medical Research representing the Minister for Mental Health, Regional Youth and Women—

What has the Government done to support young people in the area identified as Greater Sydney in the public health orders during the COVID-19 pandemic?

Answer—

The Government has provided a record investment during the pandemic to support young people, including those in the Greater Sydney Area.

The Government package of initiatives to strengthen mental health services during the COVID-19 pandemic has focussed on children and young people and will improve not only their immediate needs but also their needs in the long-term. In July 2021, as part of a joint Commonwealth and New South Wales Government package worth \$17.35 million, New South Wales provided \$5.1 million for a range of mental health services across. Key funding targeting young people in this joint package includes:

- \$7 million for headspace outreach support to parents and young people across greater Sydney
- \$3 million to support Culturally and Linguistically Diverse communities, with a focus on communities in South West and Western Sydney.
- \$2 million for Primary Health Networks across New South Wales to increase their mental health services across all areas
- \$1.5 million for Lifeline to boost crisis counselling services
- \$300,000 for Kids Helpline to extend online wellbeing sessions to secondary schools
- \$300,000 for the Butterfly Foundation to provide additional support for young people with, or at risk of, an eating disorder, and their carers.

On 17 October 2021, the Government also announced they were investing a record \$130 million to provide access to support for anyone whose mental health has been impacted by the COVID-19 pandemic. This includes additional funds to headspace services in areas particularly impacted by COVID-19 to decrease wait times, increased opening hours and engaging more staff to support more young people.

This is on top of the 2020-21 \$89.38 million over four years (2021-22 to 2024-25) committed in the 2020-21 budget to continue the additional specialist mental health clinicians recruited in response to COVID-19. These clinicians significantly enhance service capacity to provide care to people with mental health issues in the community.

* 6337 WESTERN SYDNEY LOCAL HEALTH DISTRICT VACCINATION HUBS—Ms Julia Finn to ask the Minister for Health and Medical Research—

- (1) How many requests were received by Western Sydney Local Health District to establish COVID-19 vaccination hubs?
 - (a) How many requests were agreed; and which locations?
 - (b) How many requests were not agreed; and which locations?

Answer—

As of 8 November 2021, the Western Sydney Local Health District is operating two main COVID-19 vaccination clinics – one at The Granville Centre and the other at Blacktown Hospital - as well as a number of mobile outreach clinics that are established in partnership with community stakeholders including local councils and community leaders. In addition, the Commonwealth Government has over 340 COVID-19 vaccination providers operating in the District through general practices and community pharmacies.

* 6338 COVID-19 CONTACT TRACERS—Ms Julia Finn to ask the Minister for Health and Medical Research—

- (1) Since the outbreak of the COVID-19 pandemic (to 13 October 2021), how many people were contacted each month by contact tracers in the:
 - (a) Granville electorate?

Answer—

- (1) NSW Health routinely collects COVID-19 data by Local Government Area (LGA). Health information is not collected on the basis of electorate.

The specific information requested is not centrally available. However, I am advised that between 1 July 2021 and 30 September 2021, on average over 3,000 people per month confirmed to have COVID-19 were contacted across the Cumberland and Parramatta LGAs.

I am further advised that in addition to the above figures, NSW Health notified on average three to four close contacts for each confirmed cases and lists of people from venues where there may have been a risk of COVID-19 transmission.

- (2-3) Confirmed COVID-19 cases receive a text message from NSW Health as soon as a positive result is reported by private and public laboratories. This contains advice for them to continue to isolate, and for their household contacts to get tested and isolate. A link to information resources and a phone number is also provided. The text message also prompts people to seek medical care if they are unwell.

NSW Health Public Health teams attempt to phone all COVID-19 cases and prioritise people who do not have a mobile phone number, who do not respond to a message or who have recently attended a high-risk venue.

NSW Health also engages people with COVID-19 in medical care, and works with other agencies to ensure they have suitable accommodation and their basic needs are met during their isolation, including food and medications.

Answer—

Since early in the pandemic, COVID-19 case locations have been listed on the NSW Health website (<https://www.health.nsw.gov.au/Infectious/covid-19/Pages/case-locations-and-alerts.aspx>) and Government website (<https://www.nsw.gov.au/covid-19/stay-safe/case-locations>) when they are identified, including on public transport.

NSW Health collects data to monitor and respond to the evolving COVID-19 situation, but does not routinely collate data on the total number of exposures identified in transport settings or use Opal data to support contact tracing.

The Government recognises that personal mobility devices, including electric scooters, have the potential to improve access to public transport and to reduce congestion. However, the potential advantages of electric scooters must be balanced against the safety of all road users in New South Wales.

For electric scooters to be legalised or trialled for use on the road network, they must be able to be used in an appropriate regulatory environment and in locations that manage safety risks on roads and road-related areas.

Transport for NSW is currently reviewing its policy relating to electric scooters against these and other key considerations.

- 4,059 doses of vaccine administered at the Marrickville PCYC pop-up clinic

The Government is delivering a \$100 million air quality insurance program to support ongoing improvements to air quality in New South Wales public schools.

The vast majority of spaces in schools are adequately ventilated through natural and mechanically assisted ventilation.

Air purification is only recommended where air quality is compromised by bush fire smoke or where natural ventilation cannot be achieved. The Department of Education will provide air purifiers to schools as required.

Tresillian, in conjunction with the District, offers day services for women and their babies requiring support for the transition to parenting, and parenting beds in Macksville for help with a range of early parenting difficulties including sleeping and settling and feeding issues.

Two new state-wide specialist mental health mother-baby units in the Sydney (Royal Prince Alfred Hospital) and Western Sydney Local Health Districts, will be open to women residing in Northern New South Wales next year. Clients who require specialist perinatal psychiatry hospital care can access transport and accommodation subsidies for travel to/from these new units.
