\* 6405 AIR CONDITIONING PUBLIC SCHOOLS—Ms Jenny Aitchison to ask the Minister for Skills and Tertiary Education representing the Minister for Education and Early Childhood Learning—

Answer—

- (1) 1,058 public schools in New South Wales have at least one building with more than one storey.
- (2) The recent audit of 150,000 areas at the more than 2,200 New South Wales public schools inspected the function of more than 650,000 windows. The purpose of the audit was to ensure that the windows could be opened to provide effective natural ventilation.

Window frames painted or screwed shut, and windows above ground floor level fitted with restrictors have required rectification works and the Department of Education has worked with schools to address these matters as part of the Government's \$100 million investment in an air quality assurance program for New South Wales public schools.

Sealed schools that have no openable windows are fitted with mechanical ventilation systems to provide fresh air.

Answer—

- (1) In March 2019, a new cleaning contract was implemented by Public Works Advisory. The cleaning standards adopted in the new contracts are identical to those in the previous contracts. The cleaning contracts are designed to be more equitable for all schools and include a reduction in cleaning hours at some schools in line with a benchmark applied across all schools. School principals at impacted schools were kept informed during the process.
- (2) Under the cleaning contract, contractors are responsible for employing cleaners on all sites.
- (3) Cleaning hours required for each school are calculated on the basis of the total square metres by floor covering type and industry standard cleaning rates. The same methodology is used for every school, so that the approach is transparent. It is also more equitable as past cleaning hours were based on historic numbers rolled over from previous contracts. Contractors currently deliver 2,145 hours per week in the Maitland electorate, which includes additional cleaning in response to the COVID-19 pandemic.

- (5) Additional cleaning measures introduced in Term 2, 2020 in response to the pandemic are continuing in Term 4, 2021 at all New South Wales public schools. These measures are in addition to the standard cleaning hours for each school and focus on supplementary cleaning of high touch surfaces - for example, handrails, light switches and door handles - and high use areas – for example, toilet facilities and bubblers.

Answer—

The Government is delivering a \$100 million air quality assurance program to support ongoing improvements to air quality in New South Wales schools. Under the program, the Department of Education will provide air purifiers to schools as required.

The vast majority of spaces in schools are adequately ventilated through natural and mechanically assisted ventilation.

Air purification is only recommended where air quality is compromised by bush fire smoke or where natural ventilation cannot be achieved.

This approach is strongly supported by expert advice.

I am advised:

The Government's Electric Vehicle Strategy commits to a number of initiatives to support the roll out of further charging infrastructure, including investment of \$171 million over the next four years to ensure widespread electric vehicle charging coverage across metropolitan and regional

locations in the state. As part of this investment, the Government will provide grants to small tourism businesses to boost charging infrastructure at regional tourism destinations for the next three years.

The Government consulted with the electric vehicle industry on the development of the charging initiatives contained within the NSW Electric Vehicle Strategy. The procurement approach is still being finalised. Businesses, including service stations, will have an opportunity to be part of that process.

The Government has also released an electric vehicle charging masterplan to help providers and planners develop future fast-charging infrastructure. The masterplan's interactive open-access map has been created to help investors identify optimal locations for electric vehicle fast charging infrastructure and help the Government assess applications for electric vehicle charging grants.

The Government is assisting the most vulnerable in the community by building 184 new social homes in the region since 2011. There are also a further 25 social homes currently under construction in Maitland.

In July 2021, the Government established a Regional Housing Taskforce in response to increasing pressures on the supply and affordability of housing in Regional New South Wales. The Taskforce's focus was to investigate the technical planning barriers that prevent new housing being delivered within the strategic context of the work being undertaken under the NSW Housing Strategy – Housing 2041.

- (1) Land and Housing Corporation (LAHC) has built 184 social homes and purchased 17 properties in the NN03 allocation zone since 2011, and construction is underway on a further 25 social homes. In regards to LAHC owned social properties, 53 residential dwellings and 19 land lots were sold in the NN03 allocation zone between July 2010 and June 2021. Sale prices totalled \$9.355 million. Addresses of the properties are not disclosed as it is personal information in accordance with the Privacy and Personal Information Protection Act 1998 (NSW).
- (2) LAHC continually reviews the suitability of the properties it owns. Proceeds from the sale of assets are re-invested to build more modern homes that are fit for purpose and capital maintenance.

Community housing providers report on vacancies as part of their regulatory reporting, which is administered by the Registrar of Community Housing. Under the funding agreement, EnergyAustralia will offer to buy enough green hydrogen for the equivalent of over five per cent of the plant's fuel use from 2025 (200,000 kilograms of green hydrogen per year).

School counselling and wellbeing staff will continue to work together to provide mental health and wellbeing support for students as they return to school following the learning from home period. The cruise industry is an important part of the New South Wales and Australian economy, which has been significantly impacted by the pandemic.

The decision regarding the lifting of the Biosecurity (Human Biosecurity Emergency) (Human Coronavirus with Pandemic Potential) (Emergency Requirements for Cruise Ships) Determination 2020, which places restrictions on the entry of cruise vessels within Australian territory, sits with the Commonwealth Minister for Health.

The priority for New South Wales is to ensure strong safeguards are in place to minimise the risk of COVID-19, including to regional areas. Careful planning is being undertaken to ensure Government and industry are well prepared to respond to outbreaks should they occur.
