- (1) Yes
- (2) Western Sydney Airport (WSA) has approached industry with a Request for Information and subsequent Expression of Interest to understand air cargo volumes, which will indicate freight vehicle activity.
- (3) The Northern Road will be the key access point for freight, providing landside access to a proposed WSA dedicated air cargo facility.
 - (a) The M12 was approved for construction in April this year and is planned for completion prior to the airport opening in 2026.
