- \* 8058 DISABILITY SERVICES—FUNDING OF DISABILITY AND OTHER COMMUNITY SERVICES— The Hon. Mark Latham to ask the Minister for Families and Communities, and Minister for Disability Services—
  - (1) Has the Government placed a condition on its funding of disability and other community services such that organisations are only eligible if all their staff are COVID double vaccinated?
    - (a) If so, what risk assessment was undertaken prior to the introduction of this mandate?

Answer-

I am advised:

The government has not placed a condition on its funding that staff in disability and community services organisations must be vaccinated for COVID-19.

The Public Health (COVID-19 Care Services) Order (No 3) requires a disability services worker who provides services to people with disability to be vaccinated. - \* 8063 LOCAL GOVERNMENT—LIVERPOOL CITY COUNCIL—The Hon. Mark Latham to ask the Minister for Families and Communities, and Minister for Disability Services representing the Minister for Local Government—
  - (1) Is the Minister aware that Liverpool City Council has reclassified itself as a 'business' to ban unvaccinated citizens from all Council facilities, in defiance of the new State Government policy introduced on December 15?
    - (a) Has the Council acted legally?
    - (b) By what NSW Health Order or other law is Liverpool Council allowed to enforce this ban?

Answer-

I am advised:

Any conditions of entry or use that councils choose to put in place in relation to vaccination status are a matter for the Council to determine in line with the relevant legislation and their own risk assessment. This is consistent with all other industries and services.

There is no legislative requirement that prevents councils from imposing conditions of entry beyond those in the Public Health Order with regard to vaccination, so long as they are consistent with other legislation and their own risk assessments.

Concerns about the rules and how they apply within a specific local government area should be directed to the individual council concerned.

Answer-

I am advised:

Any conditions of entry or use that councils choose to put in place in relation to vaccination status are a matter for the Council to determine in line with the relevant legislation and their own risk assessment. This is consistent with all other industries and services. Councils across NSW have taken a range of approaches to any such conditions consistent with their status as independent bodies and their own risk assessments.

Where councils impose conditions of entry for access to services, they are strongly encouraged to put in place alternative means for accessing the services provided, where practicable. Many councils have done this, for example offering click and co erv es for library services or virtual meetings with council staff.

- (2-5) The Transport for NSW COVID-19 policies are informed by ongoing, cluster-wide consultation. This consultation is consistent with the requirements under NSW work health and safety legislation.

- \* 8070 HEALTH—COVID-19 HOME TREATMENT RATES—The Hon. Courtney Houssos to ask the Minister for Women, Minister for Regional Health, and Minister for Mental Health representing the Minister for Health—
  - (1) Can you please provide the number of people with COVID-19 being treated at home under the Hospital in the Home program, for each day since 1 December 2021, to current? (if daily data is not available, please provide weekly data).
  - (2) Can you please provide the number of people with COVID-19 being treated at home under any other hospital-managed program, for each day since 1 December 2021, to current? (if daily data is not available, please provide weekly data).

## Answer-

NSW Health manages patients with COVID-19 who require clinical monitoring but do not require admission to hospital either through the Hospital in the Home (HITH) program or other COVID-19 care in the community program through community care teams.

The number of people being cared for through the Hospital in the Home program or other COVID-19 care in the community program varies from day to day. I am advised that during the period 1 December 2021 to 24 January 2022 this number ranged from approximately 2,000 people to approximately 13,000 on any given day.

- (a) Vaccination data for all staff in the Aged Care sector is managed by the Australian Government. The Commonwealth publishes daily vaccination numbers and statistics including residential aged care at:

- (b) NSW Health holds staff vaccination data for employees who are vaccinated by a NSW Health service. Staff who choose to be vaccinated by providers external to NSW Health are not required to disclose their third dose vaccination and these records may not be captured. As at 18 January 2022, data available to NSW Health identifies that 35.1% of clinical staff and 29.7% of non-clinical staff have had their third covid vaccine recorded. Vaccination data for health care workers employed in the private or other sectors outside of NSW Health is not held.
- (c) This is a matter for the Department of Education.

(1) My portfolio office, the Office of Local Government (OLG) monitors the financial performance of all councils in NSW.

The Cootamundra Gundagai Regional Council has sought an extension of time for the lodgement of Council's 2020-21 financial statements. When those statements are received from Council they will be considered by the OLG.

Under the Local Government Act 1993 councils are largely independent and self-governing bodies with rights and powers conferred by law. It is the responsibility of the governing body to ensure as far as possible the financial sustainability of the council.

Since 2010-11, the Government has provided over \$11 billion in funding to local councils. This significant contribution recognises the role councils play in providing vital services and infrastructure for their local communities.

The Government will continue to work with all the merged councils to ensure they are delivering for their local communities.
