Transport for NSW was responsible for the catastrophic collapse of an Endangered Ecological Community at Bullaburra. The design for Medlow Bath does not address the risk of detrimental adverse impacts to threatened ecological communities and their associated threatened species such as the Blue Mountains Swamps, Blue Mountains Water Skink and Giant Dragonfly. What strategies will be put in place to preserve these communities and their threatened species?
