  - (c) I refer the Member to the response provided at LA 1931, and further note that the feasibility of maintaining the property for the District's use as well as for car parking was considered.

- (1) I am aware that the former Minister considered the reports from the Boundaries Commission and decided not to recommend either proposal. That was a decision for the former Minister. Any future demerger proposals will be considered in accordance with the provisions of the Local Government Act 1993 (NSW).
- (2) The NSW Government has no ability to require councils to either hold a referendum or poll. This is a matter for individual councils. Any future demerger proposals will be considered in accordance with the provisions of the Local Government Act 1993 (NSW).
