- * 8707 LANDS AND WATER—SPORTING LOCATIONS FOR TRIAL BIKE RIDERS CROWN LANDS— The Hon. Rod Roberts to ask the Minister for Aboriginal Affairs, Minister for the Arts, and Minister for Regional Youth representing the Minister for Lands and Water, and Minister for Hospitality and Racing—
 - (1) In New South Wales there is a significant number of people who enjoy the sport of trail bike riding:
 - (a) What Crown Lands are accessible to residents of New South Wales to lawfully pursue the sporting and recreational activity of trail bike riding?
 - (b) What Crown Lands traditionally accessed by trail bike riders have been blocked or prohibited since 2011?
 - (c) What is the Government doing to ensure residents of this state who wish to pursue the sport and recreational activity of trail bike riding can do so in lawful and dedicated locations?

Answer-

The Department of Planning and Environment - Crown Lands does not maintain specific data for "trail bike" use in NSW or maintain data on other Crown Land managers such as local councils, where such activities are authorised on Crown land under their control.

The information provided is limited to 'motorsports" or "motorcycles", as follows:

(1)

- (a) Registered trail bikes may lawfully use any Crown land, including a Crown road where registered motor vehicles are authorised. Other Crown land may be used for trail bike riding where it is aligned with the purpose for which the land is reserved or dedicated, and the Crown land manager authorises the activity.
- (b) Crown Lands does not maintain data on areas where access to trail bikes or other motorised vehicles has been restricted.
 - Some Crown land is not accessible to all forms of motor vehicles, including trail bikes, to protect environmental or cultural assets, protect infrastructure such as fire trails and minimise land use conflict e.g. noise or public safety. This is achieved by a combination of signage and/or access management structures (e.g. fencing) and can be implemented by Crown Lands or the Crown land manager.
- (c) The Crown Reserves Improvement Fund provides funds to support the maintenance and improvement of Crown land to benefit the community. Crown land managers can apply for funding which may be used to support sport and recreational uses of Crown land, including trail bike riding.
 - Crown land 2031: State Strategic Plan for Crown land outlines the NSW Government's priorities for the management of Crown land over the next decade. A key priority is strengthening community connections with Crown land, including improved approaches to ensure Crown land assets are accessed, activated and sustained. The work associated with this priority will maximise the public value of Crown land for various purposes, including sport and recreation.

 - (1) In regards to the Government's announcement in April 2022 that it will provide free Rapid Antigen Tests (RATs) for people with disability, how many RATs will be available per person per visit to a designated location?
 - (2) What is the criteria to determine eligibility?
 - (a) Is eligibility limited to National Disability Insurance Scheme (NDIS) participants?
 - (i) If so, does the Government plan to extend the program to include all individuals with disability who are not NDIS participants?
 - (b) Is there an age limit for those eligible?
 - (c) Does the program include immunocompromised individuals?
 - (3) Who will be conducting the review after the initial four months of the trial?
 - (a) Will the results of this review be made public?
 - (b) Does the Government plan to extend this trial after the four month duration?

- (5) Does the Government intend to implement the Disability Liaison Officer model or similar to support people with disability to access health services during the pandemic, as is currently operating in Victoria and which has been recommended by several peak disability organisations?
- (6) In regards to individuals who test positive on a free RAT provided by the Government, will they be provided accessible information and self-care kits to safely monitor COVID-19 at home?
