The educational needs of Government students living in the vicinity of Box Hill are currently being met by schools including Rouse Hill, Oakville and Maraylya Public Schools and Rouse Hill and Windsor High Schools.

Furthermore, the Government has allocated funding to deliver a new primary school in Gables as part of the 2022-2023 New South Wales Budget.

The Department of Education continually monitors population and development trends so that it can plan to meet enrolment needs in schools across New South Wales. To do so, the Department regularly consults with relevant departments and agencies such as the Department of Planning and Environment and local councils.

The Government is aware of growth in Box Hill and the broader North West Growth Area. The Department of Education's planning for school infrastructure has been focussed on long-term future enrolment demand and it has been progressing options including site investigations, which involves identification of site requirements, to meet the anticipated primary and secondary enrolment demand.

In the interim, the existing system will continue to be monitored to ensure it operates effectively. The local SINSW office is keeping the Principal updated as this matter progresses.

In addition, the 2022-2023 Budget allocated funding to deliver a redevelopment of Gillieston Public School as part of the Government's historic \$17.7 billion school building program.

School Infrastructure NSW (SINSW) is conducting detailed studies that focus on access, transport connections to and around the proposed school site, projected population data and integration with the Council's long-term urban development plan for the area. Further consultation with key stakeholders

including Blacktown City Council, the Department of Planning and Environment (DPE) and Transport for NSW has also been conducted. This is to ensure the new school aligns with the long-term plans for the region and adds maximum benefit for future students and the community.

- (1) As at 24 June 2022, 51 teachers who are non-compliant with vaccination requirements are on alternative duties pending the outcome of the independent risk assessment following the expiry of the Public Health Order.
 - (a) Examples of alternative duties for teaching staff who are non-compliant with vaccination requirements include creating units of work, creating teaching resources to address student literacy and numeracy needs, and professional learning aligned to their role description.

(1-4) I am advised:

NSW Ambulance employees who are authorised clinicians possess, use and administer methoxyflurane. These clinicians undertake an assessment of the patient, which includes identifying any contraindications that may require clinicians to consider alternate medications.

Persons with a current occupational first aid certificate issued by WorkCover are also permitted to possess and use methoxyflurane, as allowed in Appendix-C, Clause 9, Poisons and Therapeutic Goods Regulation 2008.

Answer-

(1) Vehicle access to national parks is managed in accordance with the National Parks and Wildlife Service's Vehicle Access Policy. This is consistent with the longstanding collaborative campaign, 'No Licence, No Rego, No Ride', involving all public land managers and NSW Police.

The Vehicle Access Policy does not use the term 'single-track', but states that private vehicles may not be driven off-road except in limited circumstances.
