- \* 8365 NEWCASTLE INNER CITY BYPASS—Ms Jenny Aitchison to ask the Attorney General representing the Minister for Metropolitan Roads, and Minister for Women's Safety and the Prevention of Domestic and Sexual Violence—
  - (1) When will the successful tender for the Newcastle Inner City Bypass works be announced?
    - (a) Is construction still on track to commence in the second half of 2022?

Answer-

The contract was awarded to Fulton Hogan Construction on 21 July 2022 with construction expected to commence in late 2022.

- \* 8366 TAXI TRANSPORT SUBSIDY SCHEME—Mr Clayton Barr to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—
  - (1) With regards to the Taxi Transport Subsidy Scheme:
    - (a) How many applications have been received from residents of the Cessnock electorate annually from 1 July 2017 to 30 June 2021?
    - (b) How many applications were approved for residents of the Cessnock electorate annually from 1 July 2017 to 30 June 2021?

\* 8367 PUBLIC HOUSING RENTAL INCREASE CAP—Mr Clayton Barr to ask the Minister for Corrections representing the Minister for Families and Communities, and Minister for Disability Services—

With regards to public housing rentals:

- (1) Does New South Wales have a rental increase cap on rent rises?
  - (a) If yes, when?
  - (b) If no, why not?

Answer-

I am advised:

Under the new and fairer system, public housing market rent valuations are set in reference to the rent received in comparable private properties in the area. This means that the new rent levels better match the rent that would be paid for a similar property in the private rental market.

The new market rent calculation only impact public and Aboriginal Housing Office tenancies who do not receive a government subsidy because their income is too high. Currently only approximately 7 per cent of all Department of Communities and Justice (DCJ) managed tenancies pay market rent with approximately 93 per cent of all DCJ managed tenancies in receipt of a rental subsidy.

The process is not just about increasing rents - some market rents increase and others decrease. The 2022 market rent review resulted in 2,293 tenancies that already pay market rent receiving a decrease in their rent of \$5 to \$230 per week. The DCJ has applied a cap of \$50 for increases to market rents for 2022.

\* 8368 DINE AND DISCOVER VOUCHERS—Mr Roy Butler to ask the Treasurer, and Minister for Energy—

Considering not all rural towns or villages within Barwon have attractions for redeeming a Discover NSW voucher, leaving those constituents disadvantaged - especially the aged - would you consider having a combined voucher that allows the constituent to choose their preference; whether to Dine NSW or Discover NSW, thereby giving everyone a choice and supporting their local community?

Answer-

The Dine & Discover NSW program closed on 30 June 2022 and the Government is not considering reinstating this program.

- \* 8369 RENAL DIALYSIS AND CHEMOTHERAPY CHAIRS AT NARRABRI HOSPITAL—Mr Roy Butler to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—
  - (1) Can the Minister confirm the establishment of a renal dialysis and chemotherapy unit at Narrabri Hospital?
  - (2) Can the Minister provide a date for when these services will be operational?

#### Answer-

(1) - (2)

A chemotherapy service has been established at Narrabri Hospital. The chemotherapy service is operational, with its first patients treated in February 2022.

The District's Renal Service utilises a care model that places individuals with chronic kidney disease on home dialysis wherever possible. Home support is provided by the renal outreach team. Patients who do travel to receive dialysis treatment at either Moree or Tamworth may be eligible for financial support through the Isolated Patient Travel and Accommodation Scheme.

- \* 8370 PROSTATE SCANS IN DUBBO—Mr Roy Butler to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—
  - (1) In relation to the Western Cancer Centre in Dubbo, can the minister confirm if routine prostate scans are available at the centre?
    - (a) If not, will the minister explain why this test is not available to men in the Western area?

#### Answer-

(1) Diagnostic Computerised Tomography (CT) and Magnetic Resonance Imaging (MRI) scans are available at the Imaging department of the Dubbo Health Service. CT scans for planning for radiotherapy treatment are available at the Western Cancer Centre, Dubbo.

The Positron Emission Tomography (PET) capability on the CT/PET machine does not currently enable prostate-specific membrane antigen (PSMA) PET scans to be performed. PSMA PET scans require a specialised isotope. There are plans for the equipment that performs these scans to be purchased, installed and commissioned towards the end of the 2022-23 financial year. Staff training will also be undertaken.

- \* 8371 EXCESSIVE NOISE PENALTIES ISSUED BY POLICE—Ms Yasmin Catley to ask the Minister for Customer Service and Digital Government, Minister for Small Business, and Minister for Fair Trading representing the Minister for Finance, and Minister for Employee Relations—
  - (1) How many excessive noise penalties were issued in New South Wales between 7 June 2021 and 7 June 2022 by NSW Police?
  - (2) How many excessive noise penalties were issued in the Newcastle Local Government Area (LGA) between 7 June 2021 and 7 June 2022 by NSW Police?
  - (3) How many excessive noise penalties were issued in the Lake Macquarie LGA between 7 June 2021 and 7 June 2022 by NSW Police?
  - (4) How many excessive noise penalties were issued in the Central Coast LGA between 7 June 2021 and 7 June 2022 by NSW Police?

#### Answer—

- (1) 14 noise related fines were issued by NSW Police in 2021/22 with a face value of \$3,850.

  - (1) How many excessive noise penalties were issued in New South Wales between 7 June 2021 and 7 June 2022 Local council rangers?

- (2) How many excessive noise penalties were issued in the Newcastle Local Government Area (LGA) between 7 June 2021 and 7 June 2022 by Local council rangers?
- (3) How many excessive noise penalties were issued in the Lake Macquarie LGA between 7 June 2021 and 7 June 2022 by Local council rangers?

#### Answer-

- (1) A total of four noise related fines were issued by Local Councils in New South Wales with a face value of \$1,200 in 2021/22.

  - (1) How many customers visited The Entrance Motor registry in the 2015/16 financial year?
  - (2) How many customers visited The Entrance Motor registry in the 2014/15 financial year?
  - (3) How many customers visited the Belmont Motor registry in the 2015/16 financial year, noting the registry closed in October 2015?

#### Answer-

- \* 8374 FISH CLEANING FACILITIES—Mr Tim Crakanthorp to ask the Minister for Agriculture, and Minister for Western New South Wales—
  - (1) Has Transport for NSW explored opportunities for the installation of fish cleaning facilities at Horseshoe Beach in Newcastle?
  - (2) Does Transport for NSW have any plans for the installation of fish cleaning facilities at Horseshoe Beach in Newcastle?

#### Answer-

- (1) DPI has determined that Horseshoe Beach and the adjacent land is owned by Transport for NSW but is maintained by Newcastle City Council as a visitor area. DPI is liaising with Council and Transport for NSW regarding the feasibility of a fish cleaning table at Horseshoe Beach and a potential specific location, if deemed feasible. Information on grant funding opportunities from the Recreational Fishing Trust is also being provided to Council and Transport for NSW.
- (2) That is a matter for Transport for NSW, however DPI will continue discussions with Transport for NSW and Newcastle City Council regarding the feasibility of a fish cleaning table at Horseshoe Beach and a potential specific location, if deemed feasible.

\* 8375 INTERSECTION OF CITY ROAD AND ALICE STREET—Mr Tim Crakanthorp to ask the Attorney General representing the Minister for Metropolitan Roads, and Minister for Women's Safety and the Prevention of Domestic and Sexual Violence—

Does Transport for NSW have any plans to improve traffic flow and congestion issues at the intersection of City Road and Alice Street, Merewether?

Answer-

I am advised:

The NSW Government is investigating improvements at the intersection of City Road and Scenic Drive, Merewether to improve safety, travel time and reliability.

\* 8376 FASTER RAIL—Mr Tim Crakanthorp to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—

What will be the reduction in travel time on the Central Coast and Newcastle Line as a result of the Government's \$500 million investment in this intercity line?

Answer-

I am advised:

The NSW Government's \$500 million commitment in the 2022-23 NSW Budget will go to the first stage of the Northern Corridor of the Fast Rail Network. The funding is subject to agreement with the Australian Government.

When completed, Fast Rail is expected to bring Newcastle within an hour of Greater Sydney. Travel to the Central Coast is expected to take around 35 minutes from Newcastle and 25 minutes from Greater Sydney.

\* 8377 ISOLATED PATIENTS TRAVEL AND ACCOMMODATION SCHEME—Mrs Helen Dalton to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—

Will the Government apply special consideration for people of the Balranald region, a region with no public transport and no taxi service, who have to travel to Swan Hill Hospital for essential treatment, which does not qualify for Isolated Patients Travel and Accommodation Assistance Scheme (IPTAAS) support as each way is 98kms, 2kms short of the required 100kms in distance, to be eligible for IPTAAS support?

Answer-

Yes. IPTAAS policy, guidelines and processes allow for discretionary payments to be made where the most direct route is 95km one way or 195km cumulative distance travelled.

\* 8378 WORKING COOPERATIVELY WITH VICTORIA IN BIOSECURITY MEASURES—Mrs Helen Dalton to ask the Minister for Agriculture, and Minister for Western New South Wales—

What plans do you have in place for working cooperatively with Victoria when it comes to planning and resourcing fruit fly protection, Varroa Mite, and other potential biosecurity outbreaks across the border communities?

Answer—

NSW maintains strong linkages with other jurisdictions and the Commonwealth in the coordinated response and management of threats from pests, weeds and diseases.

NSW is a signatory to the Intergovernmental Agreement on Biosecurity (IGAB) which is an agreement between all Australian governments. This Agreement sets out commitments for the Australian Government, and state and territory governments; outlines the agreed national goals and objectives; and

clarifies roles, responsibilities and governance arrangements. The agreement came into effect on 3 January 2019.

NSW is also a member of the National Biosecurity Committee (NBC), which was formally established under the Intergovernmental Agreement on Biosecurity. The NBC advises Agriculture Minister's Meeting on IGAB implementation and minimising the impact of pests and diseases on Australia's economy, environment and the community.

Additionally, NSW Department of Primary Industries (DPI) is involved in networks for collaboration between jurisdictions that have been established at the Chief Plant Protection Officer, Chief Veterinary Officer and chief plant health manager, market access, preparedness and surveillance manager levels to facilitate the timely and accurate exchange of information. Committees and working groups with representatives from each jurisdiction are constantly working on market access, preparedness and surveillance objectives so timely and harmonised responses can be stood up at the earliest detection of an outbreak of an exotic pest, weed or disease.

These networks have provided a forum for inter-jurisdictional information sharing, discussion and development of strategy during the current Varroa mite emergency response.

Some examples of cross-jurisdiction collaboration include:

- A recent exercise to prepare for an outbreak of Mediterranean fruit fly in Sunraysia involved Agriculture Victoria staff to ensure a joint eradication campaign could be activated and resourced in a timely manner. Contact with Victorian based businesses were included in the exercise to ensure resources would be available and readily accessed in the event of an outbreak in either or both states.
- A Mediterranean fruit fly eradication response would be based on operating procedures which mirror the National Fruit fly protocols and ensure harmonisation of activities between New South Wales and Victorian government and stakeholders.
- NSW Department of Primary Industries (DPI) has worked closely with Agriculture Victoria to assure that risk mitigation strategies are in place that will allow business continuity for industries affected by the Varroa mite outbreak.
- DPI has been liaising with Agriculture Victoria regarding Phylloxera detection, surveillance and management. There are ongoing discussions on current phylloxera research, identifying phylloxera symptoms and damage in the field, up to date methods for detecting phylloxera, best practice for movements of host materials within a Phylloxera Infested Zone (PIZ) and general hygiene and standard operating procedures. DPI will continue to work with Agriculture Victoria regarding Phylloxera and its ongoing management and response preparedness activities.
- \* 8379 PHOTO CARDS AS IDENTIFICATION FOR SENIORS—Mrs Helen Dalton to ask the Minister for Customer Service and Digital Government, Minister for Small Business, and Minister for Fair Trading—
  - (1) Are elderly people who can no longer obtain a driver's license, and who are given a Photo Card by the Government instead, able to use their Photo Card for proof of identity to access essential services such as those through Service NSW?
    - (a) If not, why?

#### Answer—

A NSW Photo Card may be used as photo identification if a customer doesn't have a NSW Driver Licence. It is accepted in most places that a driver licence is recognised, including services provided through Service NSW. However it cannot currently be used as a form of identification for some online applications.

There currently isn't a process that allows for the NSW Photo Card to be digitally verified. However, Service NSW is working with its partners at Transport for NSW (TfNSW) to allow for the digital verification of the NSW Photo Card.

- \* 8380 FIREFIGHTER PLACEMENTS IN ORANGE—Mr Philip Donato to ask the Minister for Environment and Heritage—
  - (1) Having regard to the 2022/23 budget, will any of the announced additional 200 firefighters be placed in any of the fire stations located within the Orange electorate?
    - (a) If so, which stations?
    - (b) How many firefighters will be located at each of these locations?

#### Answer-

- (1) The 2022-23 State budget included funding for 200 National Parks and Wildlife Service firefighters. These roles will be located in National Parks and Wildlife Service offices and depots across NSW.
  - (a) None of these positions will be located in fire stations.
  - (b) Funding for these positions will commence on 1 July 2023. The locations of the 200 firefighters are currently under consideration.

The NSW Government will continue to work with all Australian governments and assess the evidence from New Zealand and other countries to best achieve further reductions in tobacco use and smoking.

The NSW Government is committed to further reducing tobacco-related harm. NSW Health delivers public education campaigns about quitting tobacco use, smoking cessation support, strong tobacco and smoke-free laws, and targeted programs for groups with high smoking rates.

icare has carefully considered the McKell Institute's report.

While the limited sample size and survey methodology for the report means the experiences reported are not necessarily representative of all injured workers, icare is always ready to listen to injured workers to learn how to improve its services.

To that end, icare has met with the Secretary of Unions NSW, its campaign team and members of the Injured Workers Campaign Network (IWCN) to hear directly from them about their experiences. An action plan has been established and icare will meet regularly with the IWCN to provide an update on that plan. icare is also working directly with Unions NSW and others to improve the system, most recently through the development of the new claims model and the ongoing dialogue with union officials as standing members of the Nominal Insurer (NI) Advisory Committee.

The underlying claims performance of the NI has stabilised, and Return To Work (RTW) rates have been improving with the four week rate improving by 6.3 per cent, the 13 week by 2.1 per cent and the 26 week rate by 1.7 per cent since April 2022. The decline in RTW rates has not been isolated to icare but is occurring across Australian and international workers compensation jurisdictions, with a number of impacting external factors.

Positive steps are being taken by icare to improve RTW through commissioned research, operational initiatives to support early intervention and at-risk claim cohorts, and ensure claims models and frameworks are in place to promote RTW.

icare has also realised gross cost savings target \$100 million over two years. It should be noted that icare's costs comprise of operating expenditure for all the schemes it administers, inclusive of several New South Wales public sector schemes, which were not part of the former WorkCover.

icare has commenced work on 170 recommendations following various independent reviews of the NSW Workers Compensation Scheme, including the McDougall and Governance Accountability and Culture (GAC) reviews. A comprehensive program of reform is currently underway and is driving improvements.

Later in 2022 icare will launch a Mental Health Hub that will provide a public facing set of new online tools and training resources for employers, injured workers, treatment providers and case managers that will build understanding of a specialised approach to psychological injuries across both the NI and Treasury Managed Fund schemes.

icare has recently made a detailed submission to Parliament, outlining the wide scale mental health pressures in the community and explaining through detailed data how that affects workplaces and government agencies. The submission outlines a range of responses that icare, government agencies and community groups can adopt to help lower risks and create psychologically safe environments at work.

icare is also changing the way it manages claims, releasing a Request for Proposal (RFP) for claims management services. The new model aims to create a competitive marketplace, more choice, innovation and continuous improvement to support injured workers and offer better support for business.

There is an ongoing Tolling Review led by NSW Treasury and supported by Transport for NSW, which is considering options to reform the current tolling arrangements in NSW.

The review is considering a number of factors including how to optimise the road network and reduce congestion.

Recommendations from the Review are due later this year and will be considered by the NSW Government.

- \* 8393 SMALL BUSINESS SUPPORT—Mr Alex Greenwich to ask the Minister for Customer Service and Digital Government, Minister for Small Business, and Minister for Fair Trading—
  - (1) Noting ongoing COVID impacts on Central Business District (CBD) small businesses during the latest Omicron wave, what action has the Government taken to prevent financial impacts?
  - (2) What further support will the Government provide to CBD small businesses affected by COVID infections, work from home and similar impacts?

#### Answer-

- (1) As the pandemic continues to evolve, the Government will undertake assessments of the need for targeted COVID-19 support, particularly for vulnerable communities. There are currently several ongoing COVID-19 response and recovery programs which provide support across New South Wales. Service NSW is helping businesses impacted by COVID-19 by administering financial and other support available from the NSW Government.
- (2) The Alfresco Restart rebate provides up to \$5,000 for small or medium food and beverage businesses wanting to create, expand or improve their outdoor dining areas. Claims are open until 30 September 2022. The Parents NSW and Stay NSW voucher programs are open until 9 October 2022.

Service NSW for Business provides free, personalised support to business owners as they start, run and grow their businesses, and as they adapt and recover in times of crisis. Businesses can contact a Business Concierge to receive personalised support or connect with a Business Connect Advisor. Policy on Government financial support for small businesses in response to COVID-19 is set by the NSW Treasury. Programs on the visitor and night-time economy are led by the Department of Enterprise, Investment and Trade. Questions on these matters are best directed to the relevant portfolio Minister.

- \* 8394 REMNANT NATIVE FOREST TUCKERS NOB PLANTATION—Mr Alex Greenwich to ask the Minister for Agriculture, and Minister for Western New South Wales—
  - (1) Given Tuckers Nob plantation contains significant areas of remnant native forest, old growth rainforest, and rare and threatened species, and it is an important koala corridor between the coast, the mountains and Bindarri National Park:
    - (a) What methods are used by the Department of Primary Industries and Forestry Corporation NSW to ensure native forest remnants are properly mapped?
    - (b) How is this data independently validated?
    - (c) To what extent are native forest remnant areas set aside from extraction before operations commence?
    - (d) How does the Department of Primary Industries and Forestry Corporation NSW ensure the process of mapping and exclusion is based on independent science?
    - (e) What controls has the Government put in place to ensure that neither the Department of Primary Industries or Forestry Corporation NSW has influence over the mapping and exclusion process to ensure native forest remnants are protected before operations commence?

#### Answer-

(1)

- (a) The Department of Primary Industries Plantations Regulation Unit (PRU) only authorises an existing plantation where there is conclusive evidence that the area is a plantation as defined by the Plantations and Reafforestation Act 1999 (Act). For example, when authorising an existing plantation, PRU officers require evidence that the land was previously cleared and planted and/or sown. This can include historical aerial photos/ imagery, and field notes and plans held by the owner/manager. Officers also undertake a field assessment of the plantation. If there is not sufficient evidence, the application is refused.
- (b) The PRU is an independent regulator that implements and enforces compliance with the Plantations and Reafforestation Act 1999 and Code by all plantation owners/managers in NSW.
- (c) Timber plantations are authorised following a comprehensive assessment process to correctly identify the plantation area and native forest remnant areas in line with the requirements of the Plantations and Reafforestation Act 1999 and the Plantations and Reafforestation (Code) Regulation 2001.
- (d) The PRU uses best available data and information for assessment of plantations at the time of authorisation. Ideally, all retained native vegetation areas are identified at the time of authorisation. PRU officers are trained and highly experienced in identifying remnant native vegetation and other features of environmental or ecological significance that are required to be protected under the legislation. Forestry Corporation NSW implements a Standard Operating Procedure for mapping of hardwood plantations that has been developed in consultation with the PRU to ensure it meets the requirements of the Act and Code.
- (e) The PRU is the independent public regulator established by the NSW Government to administer and enforce the Plantations and Reafforestation Act 1999 and the associated Code. Plantation owners/managers, such as the Forestry Corporation NSW, have no influence over the mapping and exclusion process except in so far as they are able to provide historical evidence of the status of the land over a relevant period.
- \* 8395 MASK ENFORCEMENT—Mr Alex Greenwich to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—

The mandatory mask rule on public transport is enforced by the NSW Police Force. Questions regarding enforcement measures should be referred to the Minister for Police.

While Transport for NSW is not empowered to enforce directions made under the Public Health Act 2010, Transport for NSW has funded a dedicated media campaign throughout August to remind commuters on public transport that masks are mandatory.

- \* 8396 PYRMONT PUBLIC TRANSPORT NEEDS—Mr Alex Greenwich to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—

- (1) An additional ferry stop in the Pyrmont area at Pirrama Park would require additional fleet and would impact on the existing ferry service.
- (2) Transport for NSW and the local bus operator have reviewed the opportunity to introduce additional bus stops on route 389 in Pyrmont Street, Pyrmont, and York Street, Sydney. Existing kerbside traffic restrictions and operational considerations preclude the introduction of additional bus stops at this time.
- (3) and (4) Future enhancements to bus services in the Pyrmont area, including linking existing destinations such as Broadway shopping centre, the new Fish Market, and linking the Bays Precinct and the Eastern Suburbs, will be considered as part of future planning activities.
- (5) Existing light rail services on the L 1 Inner West Line already provide frequent services operating from early morning until around midnight seven days a week. Alternative transport services operating to destinations such as Pyrmont, Glebe and Haberfield operate until around 3am on Saturday and Sunday mornings.

Transport for NSW considers a range of factors when planning bus services including feedback received from customers, bus operators and other stakeholders. We assess this against current and future growth in the wider region, as well as current and emerging travel patterns drawn from Opal data

Commuters travelling from Pyrmont to Broadway to access shops, banks, education and health facilities, and can catch frequent bus or light rail services to Central and transfer to numerous frequent Parramatta Road services to reach their desired location.

#### I am advised:

(1) & (2)

In 2020-21, Specialist Homelessness Services (SHS) supported 2,774 women over the age of 55 years in New South Wales.

Over the period 2015-16 to 2020-21:

• The rate of older women accessing SHS in New South Wales increased by an annual average of 3.8 per cent, compared to the national annual average rate of change at 3.2 per cent.

The rate of older women accessing SHS in New South Wales is higher than the increase for all SHS clients for the same period (0.2 per cent).

The Specialist Homelessness Services Collection does not provide information on the income levels of older women seeking assistance from SHS (Australian Institute of Health and Welfare, Specialist homelessness services 2020-21. Supplementary tables - Historical tables SHSC 2011-12 to 2020-2) (<a href="https://www.aihw.gov.au/reports/homelessness-services/specialist-homelessness-services-annual-report/data">https://www.aihw.gov.au/reports/homelessness-services-annual-report/data</a>).

(3) Under the NSW Homelessness Strategy 2018-23, the Government is implementing a range of tailored accommodation solutions to support identified at-risk groups, including older women.

In October 2021 the Government announced it would invest:

- \$30 million for approximately 80 new small-scale social housing, primarily in Western Sydney and regional New South Wales. This includes new co-living homes for older women, as part of the current NSW Homelessness Strategy.
- \$52.5 million over four years towards the Community Housing Innovation Fund (CHIF)
  partnership with the community housing sector, to provide approximately 200 sustainable,
  social and affordable housing dwellings for women experiencing domestic and family
  violence, including older women.
- \$426.6 million over four years to expand Core and Cluster to deliver and operate nearly double the existing women's refuges in New South Wales.
  - As of 30 June 2022, the \$1.1 billion Social and Affordable Housing Fund (SAHF) had delivered 3,020 of a total of 3,486 additional social and affordable dwellings across New South Wales expected to be delivered by the end of 2024. A total of 1,414 dwellings are targeted to older people and an additional 232 dwellings targeted specifically for older women.
- (4) The Government routinely assesses and incorporates the latest evidence from research reports into its housing and homelessness responses
  - The recommendations of the 'Older Women in the Private Rental Sector: Unaffordable, Substandard and Insecure Housing' report around investing in social housing and supporting tenancies are consistent with the Department of Communities and Justice's (DCJ's) existing policies and initiatives.

Recommendations relating to the NSW Residential Tenancy Act 2010, and to the Jobseeker allowance and rent assistance should be referred respectively to the Minister Fair Trading and to the Commonwealth Government.

- (5) The Government provides support to eligible low income households through its private rental assistance products, including the Rent Choice and Rentstart Bond Loan programs. These programs are designed to assist people to access and maintain a tenancy, identify suitable accommodation, and pay for bonds. Further information is available at <a href="https://www.facs.nsw.gov.au/housing/help/ways/renting-private-market">https://www.facs.nsw.gov.au/housing/help/ways/renting-private-market</a>
- (6) Housing 2041 sets a long-term vision and objectives for better housing outcomes across New South Wales. The strategy will benefit people across the housing spectrum, from those temporarily without a home to those seeking housing that better suits their needs. Housing 2041 approaches housing solutions holistically, looking at population patterns, economic and environmental effects, and other trends that affect the way we live. The strategy also acknowledges that people and households move back and forth along the housing spectrum depending on life events, aspirations and capacity.

The NSW Homelessness Strategy is a comprehensive approach to prevent and improve the way we respond to homelessness. It is a framework for action enabling government agencies, the non-government sector, and the community to collaborate and act to reduce the impact of homelessness on individuals, and improve outcomes for people and families.

Future Directions for Social Housing is the government 10 year vision for social housing in New South Wales. It has three areas of focus: more social housing, a better social housing experience and more opportunities, support and incentives to build housing independence.

Under the framework of these strategies, the Government responds to changing circumstances. In response to COVID-19, additional funding was made available for SHS to meet the emergency accommodation needs of clients impacted by COVID-19 and to meet additional staffing and other costs.

In response to stay at home orders, DCJ increased the initial Temporary Accommodation entitlement and temporarily removed the cap on assistance. Further support was given to rough sleepers to find and sustain longer-term housing. A short term six-month private rental subsidy was made available to assist clients in Temporary Accommodation to access the private rental market.

The government also invested \$177.5 million in the Together Home program to support over 1,000 people with a history of rough sleeping, with leases and wrap around supports over two years. The program is also acquiring or building more than 230 dwellings in partnership with Community Housing Providers to enable the transition of clients into long-term housing.

(1) Currently, the NSW Government is collaborating with the City of Sydney to promote active transport through an electric bike loan scheme, free cycling courses and other initiatives. The electric bike trial scheme allows users to try an electric bike for a month and the subsequent option

to purchase it at the end. Under this arrangement Transport for NSW is providing funding to the City of Sydney to deliver active transport outcomes identified in the Green Square Travel Demand Management Strategy. Transport for NSW also funds the project management of this collaboration.

Electric bikes are available for hire from private operators and suppliers, for instance as a shared service, while a number of organisations such as Transport for NSW provide salary sacrificing options for electric bikes as part of their employee benefit scheme.

- (2) Due to the relatively recent commencement of the UK cycling loan scheme, no assessment of the programme has been undertaken to date by Transport for NSW.
- (3) The NSW Government is currently developing a Net Zero Cities Action Plan. Opportunities for e-bikes may be considered as part of the scope of actions.

Transport for NSW's Cycling Design Toolbox, released in December 2020, has been prepared taking into account a wide range of electric-powered personal mobility devices, including electric bikes, to ensure that infrastructure is adaptable to accommodate innovations in micromobility.

- (1) An evaluation of the NSW Washing Machine Replacement Trial is being undertaken, now that the program has closed.
- (2) The trial locations were initially selected based on the estimated number of eligible households to test the program and its delivery. Locations were selected based on the number of freestanding NSW Land and Housing Corporation and Aboriginal Housing Office properties with larger households and higher water usage and therefore potentially higher water savings. Additional funding was approved to extend the program in June 2022, at which time eligibility was extended to include all social housing across NSW, including City of Sydney and Woollahra Municipal Council areas.
