\* 8388 WESTERN SYDNEY CITY DEAL ANNUAL REPORT 2021—Ms Julia Finn to ask the Premier—

- (1) In relation to the following Liveability projects identified by the Western Sydney City Deal Annual Report 2021:
  - (a) \$39.515 million for Fairfield Council
  - (b) \$28.752 million for Camden Council
  - (c) \$27.106 million for Wollondilly Shire Council
  - (d) \$24 million for Penrith City Council
  - (e) \$18.764 million for Blue Mountains City Council
  - (f) \$22.850 million for Liverpool City Council
  - (g) \$31 million for Campbelltown City Council
    - (i) How much Government funding has been provided to date (9 August 2022)?
    - (ii) How much Commonwealth Government funding has been provided to date (9 August 2022)?
    - (iii) What is the estimated completion date of each project?
    - (iv) What projects are already finalised?

#### Answer—

This matter is best directed to the Minister for Enterprise, Investment and Trade.

- \* 8422 FAMILY ENERGY REBATE—Ms Tania Mihailuk to ask the Treasurer, and Minister for Energy—
  - (1) How many families have applied for the 2021-22 Family Energy Rebate in the Canterbury Bankstown Local Government Area (LGA)?
    - (a) How many applications have been processed?
    - (b) What is the total quantum of the rebate that has been paid to families residing in the Canterbury Bankstown LGA?

Answer-

I am advised:

(1) This data is not yet available. The Office of Energy and Climate Change will publish the 2021–22 NSW Energy Social Programs Annual Report (the Report) in early 2023 on its website.

The Report will provide data on the total number of customers and total amount of rebates paid for the Family Energy Rebate by Local Government Area in 2021–22.

The 2020–21 Energy Social Programs Annual Report indicates that in the Canterbury-Bankstown LGA, 2664 customers received the Family Energy Rebate with a total value of \$245,000.

- \* 8423 LOW INCOME HOUSEHOLD REBATE—Ms Tania Mihailuk to ask the Treasurer, and Minister for Energy—
  - (1) How many families have applied for the 2021-22 Low Income Household Rebate in the Canterbury Bankstown Local Government Area (LGA)?
    - (a) How many applications have been processed?

(b) What is the total quantum of the rebate that has been paid to families residing in the Canterbury Bankstown LGA?

Answer—

I am advised:

(1) The number of families that have applied for the Low Income Household Rebate is not available, as energy retailers that co-deliver the energy rebates are not required to report on applications received but not eligible.

The Office of Energy and Climate Change will publish the NSW Energy Social Programs Annual Report 2021–22 in early 2023 on its website. The report will include data on the number of Low Income Household Rebate recipients and the total amount paid in rebates in 2021–22, broken down by Local Government Area.

The NSW Energy Social Programs Annual Report 2020–21 shows that 45,454 customers in the Canterbury-Bankstown LGA received the Low-Income Household Rebate with a total value of \$11,129,000.

#### (Paper No. 164)

- \* 8450 IPTAAS SUBSIDY FOR DENTAL SERVICES—Mr Roy Butler to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—
  - (1) Can the Minister advise what Dental Services are currently covered by the Isolated Patients Travel and Accommodation Assistance Scheme (IPTAAS)?
  - (2) Why are orthodontic patients ineligible for IPTAAS unless the procedure is performed in an operating theatre of an approved hospital?
  - (3) How many IPTAAS approved orthodontic procedures have been performed in an approved hospital theatre in 2021-2022?

Answer—

- (1) Patients attending the following dental services can claim for IPTAAS if they meet the patient eligibility criteria, and the services are performed by an eligible Australian Health Practitioner Regulation Authority (AHPRA) registered practitioner for:
  - (a) Oral surgery
  - (b) Oral and maxillofacial surgery
  - (c) Cleft lip and cleft palate services.

Additionally services provided in highly specialised, publicly funded oral health clinics are now covered including endodontics, oral medicine and pathology, oral and maxillofacial surgery, orthodontics, paediatric dentistry, periodontics, prosthodontics relative analgesia and special needs dentistry.

- (2) From 1 August 2022, orthodontic patients are eligible for IPTAAS if their treatment is provided by NSW publicly funded oral health clinics. These services do not have to be performed in an operating theatre of an approved hospital.
- (3) In 2021-22, IPTAAS approved 19 applications for patients seeing practitioners registered with an orthodontic specialty of Accredited Orthodontist (cleft palate) or Orthodontist. IPTAAS does not record if a patient is undergoing an orthodontic procedure by a practitioner registered with a different specialty such as an oral surgeon. Additionally, IPTAAS does not capture where procedures take place.

#### 8451 BUILDING CERTIFICATION AND INSPECTION SERVICES—Mr Roy Butler to ask the Minister for Local Government—

- (1) Considering Local Councils have historically recruited staff with combined Health, Building and Planning qualifications, recruiting multi-skilled staff is becoming increasingly difficult, and Building Certification and Inspection services do not warrant a full time position in remote communities since many regional New South Wales towns receive on average only 1-2 applications a month for Building Certification, what would be your recommendation for Councils to provide affordable inspection services, without initiating an additional cost for rate payers?
- (2) Considering that in regional and rural areas of New South Wales the implementation of a collaborative Council approach is not financially viable, particularly with the rise in fuel and accommodation costs, will the Minister investigate and provide specifically formulated options for regional areas?

#### Answer—

I am advised:

- (1) Where there is no sufficient demand for building certification and inspection services to warrant a full-time role, regional and rural councils can utilise their engineers to certify building works. Changes to building certifier approvals also allows certain services to be conducted through private certifiers.
- (2) The Office of Local Government is working with Local Government NSW, Education and the Veterans Employment Programs to identify opportunities in areas of skills shortages in councils through simpler and supported vocational education programs. This is in addition to a range of entry level pathways to attract local residents to council jobs through apprenticeships, traineeships and cadetships. Formal and informal council relationships are also in place, where regional and rural councils request and receive specific skills, advice and assistance from metropolitan councils to enable peer learning and career development between metropolitan and regional and rural councils.
- \* 8452 CANTERBURY HOSPITAL WAITING TIMES—Ms Sophie Cotsis to ask the Minister for Health—

Answer—

(1 - 8)

Canterbury Hospital provides a broad range of outpatient services to meet the health needs of the local population, using the skills of many health care specialists from a range of disciplines, sometimes during the same consultation. Services may be provided on a regular or as-needs basis, and can change according to population requirements. Wait times are dependent on clinical assessment.

Discussions on how to best collect waiting times for specialist outpatient clinics are being undertaken at a national level.

Information on wait times for surgery is publicly available on the Bureau of Health Information website.

\* 8453 REFERRAL OF CANTERBURY HOSPITAL PATIENTS TO OTHER HOSPITALS—Ms Sophie Cotsis to ask the Minister for Health—

(1) According to the Sydney Local Health District's Renal Dialysis Plan, of the residents in the district getting treatment in hospitals in other parts of Sydney, two-thirds were from the Canterbury Local Government Area (LGA) in 2011/12. Can you provide a more up to date figure on the number of patients from the Canterbury area travelling to areas outside the Sydney Local Health Districts?

Answer-

The movement of patients across catchment borders for a range of services is common in our highly networked health system. Residents within the catchment of a District commonly access services in neighbouring or other Districts for various reasons. For example, residents on the border of two Districts may find it easier to access services provided in the neighbouring District, choice of doctor, and family support.

I am advised that around 20% of Canterbury LGA residents receiving renal dialysis treatment did so at St George Hospital, outside the Sydney Local Health District.

- \* 8454 CANTERBURY HOSPITAL DEVELOPMENT—Ms Sophie Cotsis to ask the Minister for Health—
  - (1) Considering Canterbury Hospital in its 2019-2024 Strategic Plan said its "major future priority" was a full redevelopment of the hospital due to ageing infrastructure and population pressures, have any additional funds been allocated for a scoping study or assessment of a potential redevelopment of Canterbury Hospital following the plan prepared in 2013?

Answer—

I refer the Member to the response provided at LA 6997.

- \* 8455 FACILITIES AT CANTERBURY HOSPITAL—Ms Sophie Cotsis to ask the Minister for Health—
  - (1) Did the Minister directly respond to a letter from 60 senior doctors, on behalf of the medical staff council at Canterbury Hospital, on 24 December 2020 which outlined the facilities at the hospital?
    - (a) If so, what was the Minister's response?

Answer-

- (1) A response was provided by the former Secretary, NSW Health.
  - (a) The response acknowledged the concerns raised by the Medical Staff Council of Canterbury Hospital, while stating that the Ministry of Health regularly reviews healthcare services available in NSW, and plans for the future needs of communities.

It outlined that in the Sydney Local Health District 2018 Asset Strategic Plan, the redevelopment of Royal Prince Alfred Hospital was identified as Priority 1 and redevelopment of Canterbury Hospital as Priority 2.

It was noted that \$750 million had been committed by the NSW Government to the Royal Prince Alfred Hospital redevelopment and any future capital funding for redevelopment of Canterbury Hospital would be assessed against statewide priorities and as part of the annual state budget process.

\* 8456 CANTERBURY HOSPITAL OUTPATIENT SPACE—Ms Sophie Cotsis to ask the Minister for Health—

- (1) How much floor space is currently under lease for outpatient and other services by Canterbury Hospital, such as the Arthritis and Osteoporosis Centre on Canterbury Road?
  - (a) At what addresses does Canterbury Hospital lease space?
  - (b) How much extra space has been leased to house outpatient and other services by Canterbury Hospital over the past 2 years?
  - (c) How much is being spent each year to lease space for the provision of outpatient and other services by Canterbury Hospital?

Answer-

I am advised that the total floor space under lease by Canterbury Hospital for outpatient and other services and associated information is commercial-in-confidence.

- \* 8457 DOMESTIC VIOLENCE POLICING—Mr Tim Crakanthorp to ask the Deputy Premier, Minister for Regional New South Wales, and Minister for Police—
  - (1) How much of the \$5.5 billion investment in the NSW Police force will go towards improving the Core Operational Policing System (COPS)?
  - (2) What recommendations from the NSW Audit Office's Performance Audit, Police Response to domestic and family violence, 4 April 2022 have been implemented?
    - (a) How many recommendations are scheduled to be implemented?
  - (3) What actions have been put in place, or will be put in place, by the Government to address the noncompliance identified in the Audit report?
  - (4) What is the NSW Police doing to improve domestic violence prevention and policing?
  - (5) What does NSW Police plan to do to address the results of the 'People Matter Employee Survey' over previous years and why are 2021 results not published in its annual report?

Answer-

I am advised:

(1)

Due to the recent loss of vendor in the Integrated Policing Operating System (IPOS) project (and to which the phasing out of the Core Operational Policing System (COPS) falls under), the NSW Police Force is unable to provide this information at this stage.

(2) to (4)

The NSW Police Force accepted all of the eight recommendations arising from the Auditor General's report on 'Police responses to domestic and family violence'. Work has begun on developing organisational change process to improve and innovate the response to Domestic and Family Violence offending, which continues to be a priority for the NSW Police Force.

In June 2022, the Commissioner of Police's Executive Team endorsed the establishment of a Steering Committee to remedy and respond to the recommendations.

Additionally, nine key working groups are currently being established to develop organisational change process to improve and innovate the response to Domestic and Family Violence offending.

The Steering Committee and working groups will commence meeting shortly and facilitate organisational change as part of the Domestic and Family Violence Reform Project over the next two years.

- (5) The NSW Police Force relies on the NSW Treasury's Annual Reporting Compliance Guidelines and Checklist to ensure the organisation is meeting its annual reporting obligations. There is currently no statutory requirement to provide information relating to the People Matters Employee Survey for the organisation. Survey results are used internally by the NSW Police Force to assist in discussing results, engaging with staff and addressing any issues of concerns, as appropriate.
- \* 8458 POLICE, CITIZENS AND YOUTH CLUB IN DARETON—Mrs Helen Dalton to ask the Deputy Premier, Minister for Regional New South Wales, and Minister for Police—

Will the Government support the establishment of a Police, Citizens and Youth Club (PCYC) within the Wentworth Shire, which already has strong community support, and Shire and Police endorsement?

Answer—

I am advised:

All new Police, Citizens and Youth Club (PCYC) propositions are subject to consideration and development by the PCYC Board. New PCYC proposals can then be raised with the NSW Police Commissioner.

\* 8459 SPORTING GROUNDS WITHIN BALRANALD SHIRE—Mrs Helen Dalton to ask the Minister for Local Government—

Considering three sporting grounds within the Balranald Shire have been deemed unusable, could you please advise as to how community members can continue to use the Council and community valued Balranald Cricket Oval, Balranald Racing Club and Euston Sporting Oval?

Answer—

I am advised:

Lack of use and disrupted maintenance as a result of COVID-19 has impacted sports grounds in Balranald Shire.

Currently all facilities are open and Council is working with various sporting associations to ensure that the facilities remain available for use.

\* 8460 NURSE COORDINATOR PROGRAM IN SCHOOLS—Mr Ryan Park to ask the Minister for Health—

- (1) In relation to the Wellbeing and Health In-reach Nurse Coordinator program, how many of 100 nurses are employed?
- (2) What are the school locations?

- \* 8463 SCHOOL COUNSELLORS—Mr Ryan Park to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—
  - (1) As at 9 August 2022, how many school counsellors are in schools located in the electorates of:
    - (a) Heathcote?

- (b) Keira?
- (c) Wollongong?
- (d) Kiama?
- (e) Shellharbour?
- (2) Are there plans to have one school counsellor per 500 students as requested by the NSW Teachers Federation and NSW Parents and Citizens Federation?

Answer—

- (1) All NSW public schools receive a school counselling service allocation. The school counselling service allocations for all schools in the Heathcote, Keira, Wollongong, Kiama and Shellharbour electorates is:
  - (a) Heathcote: 7.5 FTE
  - (b) Keira: 11.65 FTE
  - (c) Kiama: 9.3 FTE
  - (d) Wollongong: 9.3 FTE
  - (e) Shellharbour: 12 FTE
- (2) The Department of Education has significantly expanded the school counselling service since 2016, increasing the total full-time equivalent positions from 790 to 1,240.

The Department continues to expand the holistic wellbeing and mental health support available to students with over 2,000 wellbeing roles in NSW public schools, including school counselling staff but also including student support officers, wellbeing nurses and school chaplains.

\* 8468 MANDATORY MASK WEARING ON PUBLIC TRANSPORT—Mr Ryan Park to ask the Deputy Premier, Minister for Regional New South Wales, and Minister for Police—

- (1) In relation to mandatory mask wearing on public transport, who is responsible for enforcing this requirement?
- (2) How many penalties for breaching public health orders on mask wearing have been issue this year as at 9 August 2022?

Answer—

I am advised:

- (1) The NSW Police Force has the responsibility of enforcing Public Health Orders and can issue fines or Court Attendance Notices to individuals and businesses which fail to comply with the provisions of the Order.
- (2) From 1 January 2022 to 9 August 2022, there were a total of 427 legal actions issued for people breaching Public Health Orders on mask wearing on public transport.

- \* 8474 ERADICATION OF ROADSIDE WEEDS—Ms Jenny Aitchison to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—
  - (1) What is the quantum of funding by Transport for NSW for the eradication of roadside weeds on New South Wales regional and state roads in 2022-23?
  - (2) What was the quantum of funding spent in each of the following years:
    - (a) 2021-2022?
    - (b) 2020-2021?
    - (c) 2019-2020?
    - (d) 2018-2019?

Answer-

I am advised:

Transport for NSW does not allocate a budget for roadside maintenance of roads in regional NSW. As such, weed management is incorporated into a single amenity maintenance projects budget. This budget includes day-to-day maintenance activities and services that are required to keep the roadway system operational and presentable.

However, through Regional Road Block Grant agreements, funding is provided for the maintenance of roads. Roadside maintenance, including grass cutting and weed removal, forms part of that agreement.

For state roads, Transport for NSW is responsible for the area between kerbs or table drains, where there is no formed shoulder to the road. Transport for NSW also manages vegetation, including weeds, at state-managed rest areas.

- \* 8476 AMBULANCE SHIFTS IN THE HUNTER—Ms Jenny Aitchison to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—
  - (1) Since 1 January 2022, how many Ambulance shifts in the Hunter have not operated at full staffing level capacity? Please aggregate by month and Station.
  - (2) Since 1 January 2022, how many Ambulance officers have retired or resigned in the Hunter? Please aggregate by month and Station.

(3) Since 1 January 2022, how many Ambulance officers have been recruited and assigned to stations in the Hunter? Please aggregate by month and Station.

#### Answer-

Paramedics are a mobile workforce and usually respond from one patient to the next across the state, regardless of whether they are located at a hospital, an ambulance station or another location. Vehicles and their paramedic crew are moved throughout their shift to provide geographical coverage of ambulance resources across NSW. NSW Ambulance monitors factors such as demographics and population growth when planning for future service provision, as well as proximity to existing services and general ambulance coverage.

- \* 8477 MAITLAND HOPSITAL SITE—Ms Jenny Aitchison to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—
  - (1) What is the current status of the old Maitland Hospital site?
    - (a) What parts of the old site are still being used?
    - (b) How many staff are working at the site?
  - (2) When will community consultation be conducted on the future use of the site?
    - (a) What will community consultation entail?
  - (3) What are the monthly ongoing costs for the site?
  - (4) When will the temporary fencing be removed?
  - (5) Is there any ongoing maintenance of the site?
    - (a) If so, who is responsible for the maintenance?
    - (b) How often is maintenance conducted?
    - (c) What does maintenance entail?
  - (6) Has there been any significant damage to the site such as an internal roof falling in?
    - (a) Has there been any other major damage?
  - (7) Has there been any pest control issues (e.g. rats/mice/cockroaches)?

Answer-

(1 - 7)

The campus is still in use by a small number of community and mental health teams who provide care for communities in the Lower Hunter. These teams will remain onsite until the new \$22 million Maitland Integrated Community and Community Mental Health Services building, announced in the NSW Government 2022-2023 budget, is built at the Maitland Hospital campus in Metford.

The future-use of the old Maitland Hospital campus is being assessed by Property & Development NSW to recommend a strategy in line with government guidelines and policies. Once the remaining services have vacated, the old Maitland Hospital campus will be disposed of by Property & Development NSW, allowing the property to serve the community in a new way.

A full preventative maintenance schedule and pest control program continues to be carried out by the Maitland Hospital maintenance department. Maintenance is conducted in line with the schedule or on an as-needs basis.

- \* 8478 MARINE RESCUE LEVY—Mr Clayton Barr to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—
  - (1) With regards to the Marine Rescue Levy:

- (a) When was the Levy first introduced?
- (b) Since its introduction, what has been the size of the Annual Levy, per licence and/or boat registration, each financial year?
- (c) Since its introduction, what is the total annual quantum of the Levy collected each financial year?
- (d) For each financial year since the introduction of the Levy, what percentage of the total Levy collected has been invested into Marine Rescue NSW?

I am advised

(1)

(a) The marine rescue contribution was first introduced as a component on boating licences and registrations on 1 September 2010. The contribution was introduced on every adult general and Personal Watercraft (PWC) boat licence, and all vessel registrations except PWC.

- (b) This amount has been increased annually in line with CPI and has risen from \$7.50 in 2010 to \$9.52 in 2022. Licence holders under 16 years of age and licence holders with a valid concession card will pay 50 per cent of the fee.

Community preschools and long day care services co-located on school sites are not operated by the Department of Education and do not receive funding from the school budget. These services may receive funding under Start Strong.

Start Strong for Community Preschools funding is provided for operating expenses, including salary and wages. Start Strong Long Day Care funding is provided to purchase resources, develop an early childhood education program based on the Early Years Learning Framework, including associated staffing costs, and/or to develop staff, including upgrading qualifications from a diploma to a four-year degree and associated staffing costs.
- (c) The NSW Department of Education is the Regulatory Authority in NSW responsible for regulating early childhood education and care services in NSW. Will the Government conduct an independent freight handling study to assist in determining how the rail corridor between the Port of Newcastle and the Inland Port of Narrabri can be improved in order to allow farmers, processors and businesses to clear the backlog of goods?

Answer-

NSW's Port Policy is outlined in the NSW Freight and Ports Plan 2018-2023, State Infrastructure Strategy 2018-2038 and the Future Transport Strategy 2056.

The development of a container terminal at the Port of Newcastle would require road and rail infrastructure upgrades to address increased transport demand associated with the movement of containers into and out of port.

Further, the rail line between Narrabri and Newcastle is part of the Hunter Valley network that is currently leased to the Australian Rail Track Corporation (ARTC). ARTC proposes to upgrade approximately 35 kilometres of track between Narrabri and Turrawan, which currently has mass constraints and limitations resulting from the aging rail track and poor track geometry.

- \* 8490 HUNTER VALLEY BUSES CANCELLATIONS—Mr Tim Crakanthorp to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—
  - (1) Is the Minister aware that many Hunter Valley buses are being cancelled without warning?
  - (2) Is the Minister aware commuters including school children are being left stranded because of the cancelled services?

Answer-

Transport for NSW is aware of recent media surrounding service disruptions across the Hunter region. Local bus operators have various ways of keeping communities informed of service changes, including through social media, text message services and dedicated school hotlines.

I am advised that when a trip is cancelled, operators prioritise school services and provide replacement services, where possible, to reduce the overall impact on commuters.

It is important to note that under the contracts between Transport for NSW and bus operators, it is the operator's responsibility to employ bus drivers and carry out any attraction and retention initiatives. I am advised that Hunter Valley Buses is actively recruiting drivers and has increased its intake of drivers to provide additional coverage and reduce potential impacts on commuters.

Transport for NSW is working with the local bus operators to assist in providing additional support to reduce the impacts on commuters.

\* 8491 NEWCASTLE BUS CANCELLATIONS—Mr Tim Crakanthorp to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—

- \* 8492 NEWCASTLE TEACHER SHORTAGE—Mr Tim Crakanthorp to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—
  - (1) How many classes at Newcastle schools have not been taught due to the teacher shortages?
  - (2) How many sick days have not been replaced at Newcastle schools due to no casual teachers being available?
  - (3) What is the Minister doing to work with the teaching profession to find strategies to address the immediate crisis and help end the disruption to teaching and learning for current cohorts of students?

Answer-

- (1) Sometimes when casual teachers are unable to be sourced at the last minute, including as a result of COVID-19 or other illness, classes are merged to ensure continuity of education for students. The Department of Education does not have a central system through which this information is captured across multiple schools in a uniform or consistent way.
- (2) COVID-19, influenza, and related health impacts have created an exceptionally difficult operating environment for schools in NSW. Figures for Newcastle schools are not available, however across the state, instances of sick leave to June 2022 are up by around 60 per cent on 2019 figures and are 38 per cent higher than 2021.

Contingency arrangements instigated by schools to cover teacher absences, as a result of COVID-19 or other illness, may include the use of the casual teaching workforce, teachers from nearby schools, accredited teachers working for the Department of Education in non-teaching roles, recently retired teachers and conditionally accredited final year university students, where required. Schools are using these contingency arrangements when needed.

(3) On some occasions there may be difficulty for some schools in accessing sufficient casual teachers to fully replace all teachers on leave for that day, particularly where there is a significant number of staff absent. In these situations, principals make appropriate decisions to manage staff allocations to ensure student safety and wellbeing.

A number of initiatives are in place across the State to support access to casual and temporary teaching staff for NSW schools:

- Interim Approval to Teach Since 2019, final year students have been eligible for a 12 month interim approval to be available for casual or temporary teaching earlier in their final year of study.
- ClassCover recruitment tool ClassCover connects casual teachers with schools, streamlining the casual teacher recruitment process. Currently 2,023 schools are registered with ClassCover, which is over 90 per cent of all NSW public schools. All 19 schools in the Newcastle electorate are registered with ClassCover and are active users of the platform.
- JobFeed service The Department's JobFeed service is a place to advertise temporary teaching opportunities and reaches thousands of casual and temporary teachers each week.

In response to staff leave related to COVID-19, the Department has also prepared its Non-School-Based Teaching Service (NSBTS) staff and corporate staff who are accredited to teach to be allocated to schools.

Of the 19 schools in the Newcastle electorate, the Department's COVID Workforce Deployment team received requests for assistance from two schools for teaching shifts in Term 1, Term 2 or to

date in Term 3. Hunter School of Performing Arts requested 15 teaching days of which the deployment of NSBTS were able to backfill 12 of those teaching days, and Callaghan College Waratah Campus requested three teaching days of which all three were backfilled by NSBTS.

- (2) NSW TrainLink has contracted security guards at both Newcastle Interchange and Hamilton

Station during these hours and adequate lighting and CCTV cameras have been installed.

In the late evenings and early hours, train crew can request a taxi to convey them to and from the parking area at Hamilton where there are no available train services.

- \* 8494 STOCKTON CENTRE—Mr Tim Crakanthorp to ask the Minister for Corrections representing the Minister for Families and Communities, and Minister for Disability Services—
  - (1) Is the Minister aware that there is a high number of people experiencing homelessness in Newcastle?
  - (2) Has consideration been given to using the former Stockton Centre for temporary or transitional housing for people experiencing homelessness?

- In 2020-21, Specialist Homelessness Services assisted more than 70,000 people across NSW experiencing homelessness or at risk of homelessness, including 2,004 people who identified they were from Newcastle.
- (2) The Department of Communities and Justice advise that the former Stockton Centre is not suitable for crisis and transitional accommodation. The site is disconnected from the medical facilities, allied health professionals, schools, transport and other critical care and community services that individuals in need of crisis and transitional accommodation depend on.
- (3) The infrastructure and associated services at the former Stockton Centre are old and in some areas beyond economical repair.
- (4) In 2022-23, the NSW Government will invest \$1.2 billion in homelessness and social and affordable housing programs through the Stronger Communities cluster.

This includes \$394.8 million in 2022-23 to deliver a range of homelessness services across NSW, including Specialist Homelessness Services and NSW Homelessness Strategy initiatives.

- There is \$8.6 million allocated for homelessness services in Newcastle local government area this year.
- There are three women's refuges that provide services to women and children experiencing homelessness as a result of domestic and family violence in the Newcastle area. These are operated by Jenny's Place, NOVA Women's Accommodation and Support in Newcastle and Warlga Ngurra Women's and Children's Refuge.
- St Vincent De Paul Society NSW delivers the Newcastle and Lake Macquarie Men's Homelessness Support Service, also known as the Matthew Talbot Homeless Service.

Anyone who is homeless or at risk of homelessness can call Link2home on 1800 152 152 to receive information and referrals to local accommodation and support.

Development applications approved by planning panels will require conditions of development consent to be followed, including mandatory requirements for accessibility under the Building Code of Australia.

  - (a) The Government uses satellite data to detect annual vegetation cover change. The Government also undertakes compliance and enforcement actions to prevent and respond to unlawful clearing of native vegetation and unauthorised harm to protected and threatened animals, plants, communities and their habitat.

An Early Change Monitoring Program was implemented in August 2020, which enables detection of woody vegetation clearing within weeks of its occurrence, helping to prevent some instances of unauthorised large-scale clearing.

The Government encourages and incentivises private land conservation, helping to protect native vegetation. The Biodiversity Conservation Trust is currently managing 2208 private land conservation agreements with landholders over 2.315 million hectares, representing more than 2.8 per cent of the landmass of NSW.

The Government has also committed \$206.2 million for a Sustainable Farming Program which will accredit farmers who take action to improve biodiversity and reduce carbon emissions, while enhancing their productivity.

Since March 2019, more than 600,000 hectares have been secured for addition to the national park estate.

- (b) Invasive species is a matter for the Minister for Agriculture and Minister Western New South Wales.
- (c) Climate Change mitigation is a matter for the Treasurer and Minister for Energy. In addition, under the Environment and Heritage portfolio:
  - The National Parks and Wildlife Service (NPWS) has a stated public commitment to action on climate change becoming 'Carbon Positive by 2028'.
  - On 8 September 2022, the EPA released its draft EPA Climate Change Policy and Action Plan, available for comment on the Government's Have your say website until 3 November 2022.
  - In April 2022, the Government released its draft NSW National Capital Statement of Intent for consultation. This sets the ambition for, and approach to, sustainably managing natural capital in the state.
- (d) In 2021-22, over 1250 gigalitres of water for the environment was delivered to support NSW's river and wetland systems. This is equivalent to almost three Sydney harbours. A detailed outcomes report will be released in late November 2022. The report will provide examples of outcomes from environmental water activities.

The Environment and Heritage Group (EHG) monitors rivers and streams in NSW national parks to assess aquatic health and provide evidence to support management actions and investment decisions to improve river health.

EHG supports the EPA in investigating the impacts of natural disasters and pollution incidents on the water quality within NSW rivers providing evidence to support management actions to mitigate the impacts of these events.

(e) The Government, earlier this year, announced a commitment of over \$180 million over the next six years to continue delivering on the 10-year NSW Marine Estate Management Strategy.EHG, in partnership with the Department of Primary Industries, is delivering programs that support the sustainable management and conservation of coastal estuaries and lakes in NSW. Reported

progress on these programs for the period November 2021 to February 2022 is available at <u>https://www.marine.nsw.gov.au/strategy-implementation/reporting-progress</u>

In collaboration with local councils, EHG monitors and reports on the health of NSW estuaries and coastal lakes to assess the condition of estuarine ecosystems, understand where research is needed and support management decisions. The monitoring program is implemented through the NSW Marine Estate Management Strategy and project agreements with individual councils. The monitoring program supports local councils to prepare coastal management programs for coastal estuaries and lakes and provides councils with evidence to support investment decisions and management actions to improve water quality.

The 2022-23 State Budget includes \$18.5 million over 10 years to expand Beachwatch program statewide to support NSW councils to monitor their swim sites.

As outlined in the NSW Generation STEM Deed of Endowment, the Council is composed of persons:
  - with recognised high levels of expertise and experience in the field of research and the training of students in scientific research, particularly in the areas of science, technology, engineering and mathematics (STEM); or
  - who hold or have held leadership positions in the areas of science, industry, education or innovation; and
  - with such other attributes determined by the Trustee from time to time.

As far as reasonably practicable, the Council shall comprise not less than five members, a majority of which may not be employees of either the Donor (NSW Government) or CSIRO. The Trustee may include two persons for membership of the Council nominated by the Donor, or from NSW state entities (including departments).

The EPP consists of eight initiatives including targeted 'wrap-around services' for under 17year-old students studying at TAFE NSW, and fee free 'test and try' Vocational Education and Training (VET) units of competency for high school students through Group Training Organisations (GTOs).

Since Day 1, Term 1 2022, the EPP is operational in 145 secondary public schools in the Illawarra, New England and North West, Newcastle, Lake Macquarie and Hunter Valley, Central Coast, Southern Highlands and Shoalhaven, as well as Western Sydney suburbs of Parramatta and Blacktown.

The EPP has been very successful since it was introduced in 2020, with a 75% increase in school-based apprenticeships and traineeships (SBATs) across the 145 schools involved in the program since the beginning of 2022.

The NSW Government budget for specialist disability services now forms NSW's contribution to the National Disability Insurance Scheme (NDIS). The NSW contribution to the NDIS in 2022-23 is \$3.75 billion, with the balance of NDIS costs met by the Commonwealth. The NDIS is administered by the Commonwealth, and therefore questions regarding funding for disability services providers in the Fairfield electorate should be directed to the Commonwealth Minister responsible for the NDIS.

The NSW Government funds individual, systemic and representative advocacy for people with disability under the NSW Disability Advocacy Futures Program (DAFP). Approximately \$13 million is budgeted for this program in 2022-23.

18 organisations are funded to support people with disability in NSW to access NSW Government funded and delivered mainstream services. Many of the funded advocacy organisations provide state-wide coverage. People with Disability Australia Incorporated is funded to provide individual advocacy services in the South Western Sydney region, which covers the Fairfield electorate.
