 - (b) How many nurses moved interstate?
 - (c) How many nurses left a role in New South Wales public health?
 - (d) How many nurses otherwise left the New South Wales public health system?

- * 9513 HEALTH—LOST PARAMEDICS—The Hon. Courtney Houssos to ask the Minister for Women, Minister for Regional Health, and Minister for Mental Health representing the Minister for Health—
 - (1) Can the Minister provide, for every year since 2010:
 - (a) How many paramedics were made redundant in New South Wales?
 - (b) How many paramedics moved interstate?
 - (c) How many paramedics left a role in New South Wales public health?
 - (d) How many paramedics otherwise left the New South Wales public health system?

- * 9514 EDUCATION AND EARLY LEARNING—INGLEBURN PUBLIC SCHOOL CANTEEN CLOSURE—The Hon. Mark Latham to ask the Minister for Education and Early Learning—
 - (1) Did Ingleburn Public School close its canteen on 17 August 2022, forcing students to access their food solely through a NAIDOC fundraiser?
 - (a) If so, why?
 - (2) Has the school received any parental complaints about this decision?
 - (a) If so, how has the school responded to these parental complaints?
 - (3) What is the Education Department's policy on giving parents and students choices at school for those who do not wish to participate in political fundraising events?

Answer-

On 17 August 2022, the Ingleburn Public School P&C Canteen was opened for recess as usual. The regular menu was replaced at lunchtime with a sausage sizzle menu option. This was not a fundraiser. The lunch menu was changed due to limited canteen staff availability to offer both a sausage sizzle option and standard lunch menu option on this day.

The school has not been made aware of any parental complaints relating to the P&C Canteen's decision to offer a sausage sizzle option for lunch on 17 August 2022.

Parents and students who did not wish to purchase a sausage sizzle at the Ingleburn Public School P&C Canteen on 17 August 2022 did not have to do so. This was not a political fundraising event.

- * 9525 ENVIRONMENT AND HERITAGE—SHARK MESHING PROGRAMS—The Hon. Emma Hurst to ask the Minister for Aboriginal Affairs, Minister for the Arts, Minister for Regional Youth, and Minister for Tourism representing the Minister for Environment and Heritage—
 - (1) In relation to the "Joint Management Agreement between the Minister for Primary Industries and the Chief Executive of the Office of Environment and Heritage for the NSW Shark Meshing (Bather Protection) Programs NSW" (hereafter, the JMA):
 - (a) Why was the JMA made with the Chief Executive of the Office of Environment and Heritage, rather than the Minister for Environment?
 - (b) What is the status of the JMA given that the Office of Environment and Heritage (OEH) no longer exists?
 - (c) The JMA states at clause 11.3 that "This Agreement may be terminated by OEH giving 14 days written notice to the Department of Primary Industries if the Agreement is not achieving the objectives in clause 6":
 - (i) Given OEH no longer exists, who has the power to terminate the JMA under this clause?
 - (ii) Does the Minister for Environment and Heritage have the ability to terminate the JMA?
 - (d) Has a review of the JMA taken place, in accordance with clause 9 of the Agreement, given five years has now passed?
 - (i) If so, what were the findings of the review?
 - (ii) If so, will the review be made public?
 - (iii) If not, why not?
 - (e) Were shark nets put in place on 1 September 2022?

- (i) If so, was this done in the absence of the review required under clause 9 of the Agreement?
- (f) Could the Shark Meshing (Bather Protection) Program continue to operate without a JMA in place?

Answer-

- (1) I am advised:
 - (a) At the time it was made, the Chief Executive of the Office of Environment and Heritage had delegated authority under an instrument of delegation to enter into the Joint Management Agreement.
 - (b) The Joint Management Agreement continues regardless of machinery of government changes to the former Office of Environment and Heritage.
 - (c) The Joint Management Agreement remains in force between the parties until terminated. The machinery of g_overnment changes resulting in administrative changes to the names of entities does not affect the agreement.
 - (i) The agreement may be terminated in accordance with the termination clauses by either the Environment and Heritage Group or the Minister for Agriculture.
 - (ii) The Minister for Environment and Heritage can liaise with the Environment and Heritage Group regarding any steps towards termination.
 - (d) A review of the Joint Management Agreement has commenced and is continuing. If the review finds changes should be made to the agreement, there will be a public consultation phase.
 - (e) Shark nets were installed on 1 September 2022. The review of the Joint Management Agreement does not affect the timing of the shark netting season.
 - (f) No. The Joint Management Agreement provides a defence to a prosecution for offences under both the *Biodiversity Conservation Act 2016* and the *Fisheries Management Act 1994*.
