Public dental services are provided according to criteria that prioritises emergency situations, as well as patient groups in most need and at highest risk of disease. The NSW Health Policy Directive 'Priority Oral Health Program and Waiting List Management' outlines recommended maximum waiting times for dental care based on oral health needs.

Wait time data is regularly updated and available on the NSW Health website.

(2. – 3.)

Dental services exist in a networked system across the District so that patients can attend the facility closest to them. Dental clinics are located on site at a number of hospitals across the District, as well as co-located within some community health services.

(4. - 7.)

The District issues vouchers to registered providers under the NSW Oral Health Fee for Service Scheme. Unredeemed vouchers are reinvested back into the Scheme for additional patient care.

8561 THORNTON PUBLIC SCHOOL—Ms Jenny Aitchison to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—

- (1) When will the Government upgrade Thornton Public School?
- (2) What is the capacity of Thornton Public School's permanent classrooms?

Answer-

- (1) Thornton Public School is currently managing its enrolment demand through a mix of permanent and demountable teaching spaces. In cases of sustained and stable growth, the Department of Education will consider the need for additional permanent teaching spaces.
- (2) Every eligible student who wishes to attend a NSW government school will be able to attend their local school. Thornton Public School is able to adapt to fluctuating enrolments though the use of a combination of temporary and permanent teaching spaces.
- (3) Thornton Public School has nine demountable classrooms in 2022.
- (4) As at 23 September 2022, the current enrolment of students at Thornton Public School is 758.
- (5) and (6) Student population projections are not publicly available. Answer—

(1)

(a) The data requested regarding minimal supervision and merged classes is not centrally held by the Department of Education. In practical terms, schools do not maintain a central log of minimal supervision and merged classes across a school year, nor is there a consistent, reliable and repeatable system level method to do so.

Minimal supervision does not mean students miss out on a lesson. Sometimes when casual teachers are unable to be sourced at the last minute, including as a result of COVID-19 or other illness, classes are merged to ensure continuity of education for students.

(b) Whilst the Department has a database of casual teachers employed at any given site on any given day, this does not necessarily correlate to individual cases of teacher absences at that school. This data has also never been a requirement for schools to collect and record.

Schools make local decisions on how to best cover classes as a result of teacher absences including the hiring of casuals and/or reallocating staff from other programs or areas.

Schools may also utilise the services of ClassCover which connects casual teachers with all categories of schools in Australia, streamlining the casual teacher recruitment process. All 21 public schools in the Maitland Principals Network are registered with and are users of ClassCover.

Additionally, the Department continues to expand its pool of casual teachers through a variety of different pathways to maintain the safe operations of schools and the continuity of face-to-face teaching and learning, in addition to the existing initiatives in place across the State to support access to casual and temporary teaching staff for NSW public schools.

(c) Education systems across the country and abroad are working on issues around teacher shortages, which are pronounced in some locations and subjects.

The Gallop Inquiry was undertaken by a former Labor Premier and based on survey responses from union members. The NSW Government approach is informed by independent evidence and comprehensive workforce data on teacher supply.

The NSW Government is progressing well on the Teacher Supply Strategy, and data in the Government submission to the PC3 Inquiry into Teacher Shortages in NSW clearly demonstrates that we have adequate teacher supply in NSW.

The NSW Government is also working with other states and territories on the National Teacher Workforce Action Plan, with many initiatives already in place in NSW now being considered by other jurisdictions.

(d) The NSW Government has invested \$125 million in the Teacher Supply Strategy. Building on our existing successful pipeline of teachers, the Strategy will deliver 3,700 teachers with the right subject qualifications placed in locations of need over the next 10 years. 1,600 of these teachers will be delivered over the first five years of the Strategy. In addition, NSW Government is on track to reduce time spent on low-value administrative tasks by 20% by the end of 2022 for public school teachers, principals and support staff. We have already exceeded the 2022 target for principals (we have saved 191 hours per principal, per year) and support staff (we have saved 60 hours per staff member, per year). We are on track for teachers, with 29 hours saved per teacher per year saved as at September 2022, towards a target of 40 hours.

* 8564 CHILDCARE PLACES IN BROKEN HILL-Mr Roy Butler to ask the Premier-

- (1) Considering the recent announcement of a \$5 billion funding boost for the childcare sector over the next decade is based on subsidising centres that expand or hire more staff in areas with a critical shortage of places, can you define the determinants of a "critical shortage"?
- (2) Considering Broken Hill currently has 1 available childcare space for every 7.45 children in the age range requiring early childhood education and care, will this funding benefit the childcare sector in Broken Hill?
- (3) If so, how much of this funding will be directed to addressing the shortage of childcare places in Broken Hill?

Answer-

* 8565 STRUCTURED APPROACH TO DROUGHT ASSISTANCE AND RECOVERY—Mr Roy Butler to ask the Minister for Agriculture, and Minister for Western New South Wales—

- (1) When will the Government create a clear threshold for when drought/drought recovery assistance is required for agriculture and agriculture dependent communities specifying;
 - (a) The trigger points for regional New South Wales entering meteorological, hydrological and socio-economic drought and associated supports?
 - (b) The trigger points for regional New South Wales drought recovery and associated supports?

Answer—

In June 2021, the NSW Government released the \$64 million Future Ready Regions Strategy which sets out the Government's commitments to supporting regional communities through times of drought, to achieve sustainable, secure and health water resources, build strong primary industries that are prepared for drought.

Under the Strategy, the Enhanced Drought Information System (EDIS) continues to be advanced, supporting farmers to make more informed decisions related to the climatic conditions. A key feature of EDIS is the Combined Drought Indicator, which combines meteorological, hydrological and agronomic definitions of drought using indices for rainfall, soil water and plant growth.

In addition, the NSW Government is delivering the Farm Business Resilience Program, co-funded by the Future Drought Fund, which aims to improve primary producers' capability to manage business risks, and help regional economies be better able to anticipate, withstand and adapt to the impacts of drought.

* 8566 CROWN RESERVES IMPROVEMENT FUND—Mr Roy Butler to ask the Minister for Lands and Water, and Minister for Hospitality and Racing—

Given the increase in price for raw building materials and supply chain issues, due in part to COVID-19, when will the Minister consider top up funding for projects approved under the 2021-22 round of the Crown Reserves Improvement Fund?

Answer—

There were 257 projects worth \$15,233,349 funded via the 2021-22 Crown Reserves Improvement Fund (CRIF) grants round. Many of these projects have already been completed successfully on time and on budget.

While it is normal practice for large grants to have included an amount for contingencies as part of their application, the Department has acknowledged that some grant recipients will be challenged by recent price increases for building materials and trades.

The Department has made public, via the CRIF webpage, the following options for consideration for grant recipients to achieve the best outcome for their projects:

- de-scoping the project, removing non-critical elements that will not alter the fundamental amenity of the project
- phasing the project over multiple years and applying for further funding to complete the project in the future
- seeking alternative top-up funding from another grant program
- running community fund raising events and/or crowd funding where appropriate
- seeking cash or in-kind support from local councils.

If the above options are not viable or have been exhausted, then the Department will consider reasonable requests for variations or extensions to previously funded projects. Each request will be considered on its own merit.

* 8567 ESSENTIAL ENERGY—Mr Roy Butler to ask the Treasurer, and Minister for Energy—

(1) On three occasions IPART has sought independent reports into Essential Energy's excessive corporate costs. These were in 2010, 2014 and 2019. In the 2019 report Aither said "the lack of information to justify changes in operating expenditure is a consistent theme for Essential Water and a concern looking forward". In 2022 Essential Water, part of Essential Energy, plan to further increase the price of untreated water by 49.5%. This will make the cost of raw river water almost that of treated water. Can the Minister advise how much of these Essential Energy corporate overheads are paid for by residents of Broken Hill using the services of Essential Water?

Considering the weather events that have taken areas of the far west of New South Wales by surprise over the last year, due partly to the gap in radar coverage over that part of the state, when will the Government commit funds for the installation of a Doppler radar which will provide better coverage and weather predictive capabilities for Broken Hill, Central Darling Shire and Unincorporated New South Wales?

- * 8569 SUPPRESSOR PERMIT APPLICATIONS—Mr Roy Butler to ask the Deputy Premier, Minister for Regional New South Wales, and Minister for Police—
 - (1) Considering permit applications for suppressors under the NSW Firearms Act often sit indefinitely without progressing, which leads to irreparable hearing damage and unnecessary disruption to livestock, will the Minister ensure that the provisions of the NSW Firearms Act are followed and access to suppressors to law abiding firearms owners is ensured.

Answer-

Public safety is always the paramount consideration for the NSW Police Force when determining firearms matters. The assessment of general permits, and in particular suppressor permits, is subject to a dedicated project team within the Firearms Registry, whose role is to ensure that the safety of the public and the wellbeing of the potential licence holders is not compromised.

- * 8570 LEACOCK AND EDMONDSON REGIONAL PARKS FUNDING—Mr Anoulack Chanthivong to ask the Minister for Environment and Heritage—
 - (1) Are Leacock Regional Park and Edmondson Regional Park allocated funding separately?
 - (2) Have there been any incidents where funds allocated to Leacock Regional Park have been reallocated or shared with Edmondson Regional Park?

(5) Funding is yet to be finalised for 2022-23.

(a) It is expected funding will be similar to 2021-22 for park maintenance and lawn mowing activities. A budget of \$30,000 is likely to be available for weed control.

- * 8572 LEACOCK REGIONAL PARK MAINTENANCE—Mr Anoulack Chanthivong to ask the Minister for Environment and Heritage—
 - (1) How many complaints regarding maintenance at Leacock Regional Park were received in the 2021-22 financial year?
 - (a) What was the response to those complaints?
 - (2) How many complaints regarding maintenance at Leacock Regional Park have been received so far in the 2022-23 financial year?
 - (3) How often is maintenance on the walking tracks in Leacock Regional Park carried out?
 - (4) What weeds are known to grow in Leacock Regional Park?

Answer-

- (1) Six.
 - (a) Where possible, and under COVID-19 red zone restrictions, staff attended to the matter.
- (2) Nil.
- (3) Lawn mowing is carried out each month, which includes the edge of the walking paths. In 2022, there have been delays with park maintenance due to ongoing flooding and the grounds being too wet to support machinery. General maintenance of walking tracks is completed weekly and includes pruning of trees and rubbish collection along paths.

(4) The main weeds are African olive, privet, lantana, wild tobacco, balloon vine and ludwigia peruviana.

(a) Most weed control is through cut stump, followed by application of herbicide. Other methods include high volume spray and splatter gun application.

(b) The National Parks and Wildlife Service's weed control program commences in spring when weed control is carried out several times per month.

(c) The weed management plan for the park is updated as the weed situation changes. The park is split into zones, where a range of control techniques is carried out for different species. This includes management considerations and treatment information.

(5) There are no rubbish bins in the park, with all rubbish collected being scattered litter along the interface with the Hume Highway. Rubbish collection and removal is generally undertaken once a week.

(a) Approximately two 200 litre Otto bins of rubbish are collected each week but this can increase with instances of illegal rubbish dumping.

- (6) Recent bush regeneration has been irregular due to the flooding and muddy conditions.

Funding for accessibility upgrades continues under TAP in the 2022 budget, including 13 station upgrades in Greater Sydney: Clarendon, Denistone, Doonside, Erskineville, Killara, Normanhurst, Pymble, Redfern, St Peters, Stanmore, Thornleigh, Turrella and Waitara. All 13 station upgrades are currently in construction. Five stations are also receiving accessibility upgrades as part of the Sydney Metro City & Southwest project: Punchbowl, Wiley Park, Canterbury, Hurlstone Park and Dulwich Hill.

On 17 August 2022, the Minister for Indigenous Australians secured the support of all state and territory Ministers for Indigenous Affairs to implementing the Uluru Statement from the Heart.

- (3) Preliminary discussions with the NSW Closing the Gap non-government partners and Local Decision Making groups on proposals for Voice mechanisms have been occurring since the Co-Design Group's Interim Report was released in January 2021. In early 2021, the Australian Government, supported by Aboriginal Affairs NSW, held consultations in 12 locations across NSW as part of the national consultations on the Interim Report. As the Final Report was released in December 2021, further detailed conversations are still underway.
- (4) As the Indigenous Voice implementation is being led by the Federal Government, the NSW Government continues to enter into bi-lateral conversations which will inform Government consideration to establish an Indigenous Voice. This will include engaging comprehensively with Aboriginal Communities and groups across NSW. - (a) Single course distance education such as that offered by NSW School of Languages provides a curriculum safety net for students to meet credentialing requirements for the NSW Education Standards Authority. Single course distance education is available only to students who are enrolled in Years 9 to 12 and are attending a registered secondary school.
- (b) NSW Education Standards Authority administers the provisions of the Education Act 1990 for home schooling registration. Under the Act a child is to be enrolled at and attend a government or registered non-government school, or be registered for home schooling. There is no provision for part-time home schooling registration where a child is enrolled in a school for a portion of their educational program. In home schooling parents/carers are responsible for developing teaching and learning programs for their children.

The average number of patients awaiting residential aged care facility placement or NIDIS placement for September to date is 47.

Local Health Districts are funded by activity rather than bed numbers.

(3. - 4.)

Nursing Hours Per Patient Day varies from week to week.

The District's nursing separation rate is comparable to health industry averages.

(5. - 7.)

145 GradStart nurses have been employed across the District.

All clinical placements for GradStarts have a Clinical Nurse Educator who works within the service to support their orientation and ongoing education during their placement. With the increased numbers in 2022 of graduate registered nurses, additional clinical education resources were made available across all sites and services for the first 6 months of the program. No Clinical Nurse Educators have full time patient loads.

(8. – 9.)

The District's separation rate is consistent with the health industry average. Further information on staff movements is available in Local Health District reports, which can be found on the CCLHD website.

(10. – 11.)

Information about emergency department presentations is available in the NSW Health Annual report.

(12. – 13.)

Bed numbers do not reflect the volume and quality of health services delivered to patients in hospital or in the community. Bed numbers also do not reflect the new innovative models of care NSW Health has implemented to provide integrated care outside of the hospital, closer to patients' homes and utilising new technologies such as virtual health and the Hospital in the Home program.

(16.)

The Primary School Mobile Dental Program was launched in 2019 in the five local health districts; the Central Coast, Mid North Coast, Nepean Blue Mountains, South Western Sydney and Western Sydney to provide free basic dental care to primary school children. The program was recommenced in February 2022, following suspension since July 2021 due to COVID-19 Stay at Home Orders and school closures. All 54 public primary schools on the Central Coast have the opportunity to access the program and I am advised there is a strong uptake of the program by schools in the local health district.

Answer—

(1) Under the current policy, the three education sectors have responsibility as Authorised Providers for accrediting teacher professional development courses for their own teachers and NESA has responsibility for assessing applications from all other 'non-authorised' providers.

As at 23 September 2022, there are currently eight NESA staff involved in the assessment of teacher professional development courses for accreditation. This team includes staff with teaching qualifications and backgrounds and expertise in teacher professional learning.

This team reports to a more senior staff member who provides day to day guidance and direction on the accreditation of professional development courses as required.

- (a) NESA established an independent Student/Child Mental Health Expert Advisory Panel to provide this expertise. This Expert Advisory Panel comprises 10 members including recognised child and adolescent mental health clinicians, an early childhood academic and representatives of the three education sectors who are qualified psychologists or have program responsibilities in the student/child mental health and wellbeing area. None of these members receive payment for their participation but do so as part of their professional commitments within their field.
- (2) Not all professional development course applications in the Student/Child mental health area are referred to the Panel. The Panel meets on a needs basis, subject to their availability, when a course application is being referred to it. The provider is advised that this is occurring.
- (3) As at 23 September 2022, a total of 235 accredited courses address the Student/Child Mental Health priority area requirements. These courses had been accredited by either NESA or other Authorised Providers.

Extracting data from the NESA database on accredited courses that specifically address mental health and trauma informed practice is limited to searching by the key word of 'trauma' in either the course title or synopsis. Using this search facility, more than 30 accredited courses deal with trauma (noting that a number of these courses are primarily aligned to a priority area other than Student/child mental health), including:

- Trauma Informed Teaching Practices
- Informed, sensitive and responsive trauma practices within your educational setting and community
- Trauma Informed Practice Sydney Catholic Schools
- Understanding the Ongoing Impact of Trauma in Aboriginal Communities
- Youth Mental Health First Aid
- (4) Courses are accredited in four mandatory priority areas:

Answer-

(1) (a - l)

The NSW Government has committed \$8.6 million over four years from 2021-22 for people with movement disorders, such as Parkinson's Disease. The \$8.6 million will fund 15 specialist nurses and allied health staff across the state. Having additional dedicated nurse or allied health professionals working across NSW will support high-quality, local multidisciplinary care for people with movement disorders and help keep them out of hospital. The funding also provides \$650,000 to Parkinson's NSW for training, teaching and increased services.

I am advised that not every person requiring treatment for Parkinson's requires hospital care and many are supported under General Practitioner (GP) and/or private specialist management.

Irrespective, patients with Parkinson's disease in the Illawarra Shoalhaven Local Health District are able to access services provided by the District including the neurology service, neurology clinics, rehabilitation clinics, the geriatrics team and general medicine specialists. Similar arrangements apply in other local health districts.

I am further advised that data on the number of people admitted to hospitals in the Illawarra-Shoalhaven Health District because of Parkinson's and its symptoms is not available.

Answer-

Traffic lights have been installed to improve safety and traffic flow at the roundabout, particularly to assist drivers on Moss Vale Road to access the Princes Highway during busy periods.

Improvements at this intersection were identified in the Illawarra-Shoalhaven Regional Transport Plan. Partial signalling of the roundabout is an effective interim solution to improve safety and traffic flow at the roundabout, while Transport for NSW continue to develop improvements required for the long term.

The traffic lights were switched on 26 June 2022. Interim data available to Transport for NSW indicates zero recorded crashes in the twelve months prior to the traffic lights being switched on.

An independent road safety audit of this roundabout was carried out in late June 2022 and no issues were identified.

* 8648 BOMADERRY SPEED ZONE CHANGES—Mr Gareth Ward to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—

Answer-

I am advised:

The area of the 70 km/h speed limit on the Princes Highway at Bomaderry was extended as part of the Berry to Bomaderry upgrade project, with the speed zone change shifting north towards Abernethys Lane by approximately 900 metres.

This change was made to introduce a consistent speed limit for the entrance to the Bomaderry urban centre. This change provides a safer environment for residents and road users, in particular northbound motorists, who need to access the U-turn bay on the eastern side of the highway before travelling south. To assist road users in complying with the posted speed limit, Transport for NSW will consider installing additional speed zone signage.

All matters related to fines are managed by Revenue NSW and should be referred to the Minister for Customer Service.

- * 8649 CALDERWOOD PUBLIC SCHOOL—Mr Gareth Ward to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—

 - (3) Who undertakes this monitoring work within your department and would this person be prepared to meet with local residents to discuss demand for a new school at Calderwood?
 - (4) Have those in your department responsible for monitoring growth and development trends met with any representatives of Shellharbour City Council in the last 5 years?

- (2) The Department of Education works with the Government, other government agencies and local councils to monitor population and development trends.
- (3) The Department's Service Planning Directorate monitors population and development trends. Refer to the Planning for Growth Fact Sheet at

https://www.schoolinfrastructure.nsw.gov.au/what-we-do/we-build-schools/planning-for-growth-fact-sheet.html.

- (4) The Department regularly meets with relevant departments and agencies such as the Department of Planning and Environment, local councils and non-government stakeholders to monitor population and development trends.
- (5) The provision of new or upgraded schools depends on a demonstrated need. The Department undertakes rigorous analysis and prioritisation across its portfolio of over 2,200 schools to inform when a new school or upgrade project is needed.

Early planning work for a new or upgraded school involves a range of preparatory work to inform the submission of a Business Case including, but not limited to:

- consideration and studies of demographic trends,
- an assessment of education requirements,
- an assessment of the condition of the existing school buildings or new sites,
- a review of catchment boundaries,
- identification of any heritage or cultural requirements,
- a review of any potential site constraints,
- ensuring appropriate transport links, and
- identifying potential partnership opportunities.

Once the business case is finalised it is then submitted to Treasury for funding approval.

- (6) Short to medium term is defined as 5 to 10 years.
- (7) The Department manages fluctuating enrolment demands in the short to medium term by:
 - enforcing the Department's school enrolment policy to restrict out of area enrolments,
 - reviewing school intake areas to improve utilisation across schools in a local area, and
 - providing additional demountable facilities, including classrooms and specialist spaces as required.
- (8) The Department uses projections to estimate the number of students due to enrol in New South Wales public schools in the short, medium and long term. These estimates help to plan where to build new schools or provide extra spaces at existing schools.

As part of this ongoing monitoring, the intake area boundaries for Tullimbar Public School and Albion Park Public School were adjusted in 2021. This intake area change ensures that students living in the same neighbourhood were now designated to the same school and ensures utilisation of all available permanent teaching spaces.

- (9) As previously advised, the Department of Education meets regularly with the Department of Planning and Environment and local councils, including Shellharbour City Council, to understand development trends to ensure adequate provision of education facilities. Through these discussions, Voluntary Planning Agreements (VPA) have been negotiated in the Calderwood area to secure two sites for potential future primary schools and one site for a potential future high school, should population trends require development of these schools and subject to future decision making of government.
- * 8650 HOSPITAL UPGRADES IN THE ILLAWARRA SHOALHAVEN HEALTH DISTRICT—Mr Gareth Ward to ask the Minister for Health—

I am advised that both the Shoalhaven Hospital Redevelopment and the Shellharbour Hospital and

Integrated Services projects remain on track. I understand the Parliamentary Secretary for the South Coast joined representatives from the hospital, local health district, aboriginal groups and preschool to mark the start of construction associated with the project in August 2022.

* 8651 JAMBEROO WATER AND SEWERAGE—Mr Gareth Ward to ask the Minister for Lands and Water, and Minister for Hospitality and Racing—

- (1) Is the Minister aware that the Jamberoo Sewerage Treatment plant is at capacity?
- (2) How many dwellings was the Jamberoo Sewerage Treatment Plant designed to service?

 - (a) If so, what analysis has been done on these impacts and what measures are being undertaken to prevent and manage these impacts?
- (6) Has your department considered upsizing and expanding the capacity of the Jamberoo Sewerage Treatment Plant and associated odour and environmental controls in the near future?

- (a) If so, when was consideration given and will you publish the associated documents?
- (b) If not, will your department consider upsizing and expanding the capacity of the Jamberoo Sewerage Treatment Plant and associated odour and environmental controls in the near future?
 - (i) If so, when?

Answer-

(1) There is no Sewerage Treatment plant in or close to Jamberoo. Wastewater generated in Jamberoo is transferred to Bomba Wastewater Treatment Plant. All further responses address the capacity of the wastewater network in Jamberoo.

The Minister is aware that the pressure sewer system in Jamberoo village is at capacity. This system was designed 20 years ago as part of the NSW government Priority Sewerage Program and has been able to service growth in the village over this time.

- (2) The pressure sewer system in Jamberoo was designed to service approximately 500 residential lots. There were 360 lots constructed at the time of the design in the early 2000s.
- (3) Growth was considered when the Jamberoo pressure sewer system was designed in the early 2000s. Sydney Water allowed for an additional 140 lots or 40% additional capacity. This was based on the land zoning and usage at the time.
 - (a) Sydney Water consults regularly with the Department of Planning and Environment, relevant councils and developers to understand the nature and timing of growth.

It is important for Sydney Water to understand the timing of development to stage infrastructure delivery in a coordinated way wherever possible. Sydney Water is not a consent authority for development and can only plan based on the most up to date information that is available.

(4) The Minister is aware that the Jamberoo pressure sewer system is at capacity. The system was sized to meet the ultimate capacity of Jamberoo based on the best information that was available at the time circa 2000.

This was outlined in previous correspondence with former Water Minister, Melinda Pavey in May 2021.

(5) No. Each of Sydney Water's wastewater systems is regulated by an Environment Protection Licence (EPL) with the NSW Environment Protection Authority (EPA). This outlines the limits that apply to both wet and dry weather overflows from the wastewater network.

The Jamberoo area is covered by the Bomba Sewage Treatment System Environment Protection Licence. When Sydney Water carries out planning, it ensures that the limits contained in the licence are not exceeded.

- (a) As part of Sydney Water's planning for growth in the Kiama Local Government Area (LGA), it models the impact of growth on the available capacity in its wastewater network. Amplifications and upgrades are identified where pipes or pumping station capacity will be exceeded due to growth. These investments are made ahead of time and in line with the timing of growth.
- (6) To date, Sydney Water has not considered upgrading the capacity of pressure sewer systems such as Jamberoo that were installed as part of the Priority Sewerage Program. Typically, these areas are situated in semi-rural and peri-urban area or zones of transition from rural to urban land, which have experienced limited growth since being provided a wastewater service.

- (a) The lack of additional capacity at Jamberoo was confirmed in Sydney Water's most recent planning for the Kiama LGA. Sydney Water's official advice around these areas and timing for servicing growth is outlined in its Growth Servicing Plan.
- (b) Sydney Water has committed to consult further with Kiama Council around plans and expectations for growth in Jamberoo village. Based on this consultation, Sydney Water will consider the scope of further planning on the Jamberoo wastewater system.
 - (i) If a decision is made to commence further planning in consultation with Kiama Council, this would take 12 months after securing funding. Design and construction would be in addition to this and typically takes several years.
- 8652 MOUNT TERRY PUBLIC SCHOL CANTEEN REFURBISHMENT—Mr Gareth Ward to ask the Premier—

Planning is underway to duplicate some of the rail line between Kiama and Bomaderry. This is being considered as part of broader plans for fast rail on the Sydney to Bomaderry corridor to improve travel times between Sydney, the Illawarra and Shoalhaven region.

Preliminary investigations are underway to inform the design for the proposed rail loop and how these works align with a future Fast Rail Network.

The NSW Government is committed to developing a blueprint for the delivery of a Fast Rail Network which is vitally important for the state. Transport for NSW is taking the time to get this right.

Stakeholders and the community will be provided with information as the program progresses.

- (6) Briefings with key stakeholders, including local MP's, will be undertaken by Transport for NSW when appropriate.
- (7) Upgrades are planned at Bomaderry Station as part of the scope of work for the Kiama to Bomaderry project, including the installation of an additional platform. Initially accredited teachers are those teachers accredited for the first time in NSW. They include recent initial teacher accreditation graduates and teachers moving to NSW from interstate and overseas.

What software updates have occurred to accommodate the NSW Education Standards Authority Accreditation portal to support teachers seeking to renew their NSW Teacher Accreditation?

Answer—

In 2018, NESA's electronic Teacher Accreditation Management System (eTAMS) and Customer Relationship Management (CRM) system were rebuilt to reflect changes to teacher accreditation policy in NSW. These changes streamlined accreditation processes and enabled teachers and principals in NSW to use eTAMS to:

- apply for accreditation at all levels
- manage their accreditation requirements
- complete the process for maintaining accreditation at Proficient Teacher; and
- record accreditation decisions.

eTAMS continues to be updated and streamlined with each teacher accreditation policy change. Since 2018, eTAMS and CRM undergo regular planned and on-demand updates to improve the functionality, useability and security of the platform.

Following changes to the Teacher Accreditation Act 2004 (NSW) in late 2021 and consequential changes to NESA policies and processes, NESA is updating or refreshing all applications within eTAMS that teachers use to renew their accreditation. The preparation for these updates started in mid-2022 and will be incrementally implemented during the remainder of 2022 and throughout 2023.

Between May and September 2022 updates included:

- the new online application for teachers seeking accreditation at Highly Accomplished and Lead Teacher levels
- the publication of the NSW Public Register of Teachers, and
