- \* 8805 STAYING HOME LEAVING VIOLENCE EXPANSION—Mr Roy Butler to ask the Attorney General representing the Minister for Metropolitan Roads, and Minister for Women's Safety and the Prevention of Domestic and Sexual Violence—
  - (1) What LGAs in Barwon were the recipients of the Staying Home Leaving Violence expansion program?
  - (2) Which locations in Barwon now have a Staying Home Leaving Violence service provider?

Answer—

I am advised:

The 2021-22 NSW Budget allocated an additional \$32.5 million over four years to support a major expansion of the Staying Home Leaving Violence program across New South Wales. This expansion was rolled out between February and August 2022. Expansion locations in the Barwon Electorate are Brewarrina, Warrumbungle, Narrabri, Gilgandra and Lachlan Local Government Areas.

- \* 8806 LIVE TRAFFIC REPORTS FOR LOCAL AND STATE ROADS—Mr Roy Butler to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—
  - (1) Given that Local Governments in the Western Division are using multiple and inconsistent web pages to publish news of road closures and maintenance, but a new platform OneRoad will be established in 2023, Minister, whilst we await OneRoad is there a temporary online platform we can implement which is mandatory for Local Governments to report road issues, particularly for regional LGA's, as we are seeing floods/damage occurring almost every week?
  - (2) Can the Minister advise which 22 Local Councils have been selected to transition onto OneRoad in October 2022?

Answer-

#### I am advised:

- (1) Local Councils are encouraged to report road issues on their publicly available websites and social media feeds. In times of emergency, and upon request from Councils, Transport for NSW assists the public to access road related information by featuring links to Council websites and social media pages on the Live Traffic NSW website, as well as a range of mobile apps.
  - Local Councils are responsible for keeping their channels accurate, ensuring those who access these links via Live Traffic NSW are up-to-date with the latest information.
- (2) This information publicly available on the Transport for NSW website.
- \* 8807 LOCAL ENVIRONMENT PLANNING PROJECT FOR AGRICULTRE AND AGRITOURISM—Mr Roy Butler to ask the Minister for Environment and Heritage—
  - (1) Considering that in April 2022 within my Electorate were asked to submit a nomination to the Department of Planning Industry and Environment in response to the Local Environment Planning Agriculture and Agritourism amendment project, can the Minister confirm when the LPA Amendment project will announce new legislation?

#### Answer-

This question should be referred to the Minister for Planning and Minister for Homes, the Hon Anthony Roberts MP.

- \* 8808 REGIONAL PENSIONERS DRIVER LICENCE RENEWALS—Mr Roy Butler to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—
  - (1) Considering elderly drivers are required to provide specialist approval for medical issues, Minister, what subsidy, if any, is currently available to subsidise pensioners for obtaining these approvals from their specialist doctors?
  - (2) Regional residents travel long distances to receive specialist care, would the Minister consider structuring a subsidy specifically for pensioners travelling for appointments such as drivers licence approvals?

Answer-

I am advised:

The NSW Government provides a range of initiatives and concessions designed to ease the cost of living and assist pensioners. Eligible pensioners are exempt from many fees including driver licence and registration fees, motor vehicle tax, NSW Photo Cards and Mobility Parking Scheme permits.

In addition, eligible seniors and pensioners are entitled to \$2.50 all day travel with the Country Pensioner Excursion ticket when booking within seven days of travel on NSW Train link regional services within NSW.

Eligible pensioners are also able to access the \$250 Regional Seniors Travel Card, which can be used for fuel, taxis, and public transport to assist with access to medical and other essential appointments.

Licence holders are responsible for any costs associated with undertaking a medical examination in order to produce evidence of compliance with the 'Assessing Fitness to Drive' medical standards.

- \* 8809 PARKS FOR PEOPLE—Mr Anoulack Chanthivong to ask the Minister for Planning, and Minister for Homes—
  - (1) In relation to the Parks for People program:
    - (a) How much of the \$50 million committed in 2019 has been expended?
    - (b) What is the breakdown of funded amounts and status for each of the nine projects?
    - (c) What is the reason the Glenfield Parklands project is yet to progress to the design stage, with the website stating, "No decisions have been made on the park design with extensive studies, community engagement and design work to occur"?
    - (d) Why is Glenfield Parklands the only project of the nine under the Parks for People program yet to progress to the design stage?
    - (e) When will the Glenfield Parklands masterplan be released?
    - (f) How much funding has been allocated to the Glenfield Parklands?
    - (g) Will Campbelltown City Council be expected to also provide funding for the project? If so, how much?

- \* 8811 LOW INCOME SOLAR PROGRAM—Mrs Helen Dalton to ask the Treasurer, and Minister for Energy—
  - (1) Does the Government confirm that the Low Income Solar program will be available for every low-income household in New South Wales as was originally committed to?
  - (2) When can low-income households in the remaining parts of New South Wales expect to be able to participate?

#### Answer—

- (1) The Solar for Low Income Household offer is available to every eligible household in New South Wales that is receiving the Low Income Household Rebate.
- (2) The Solar for Low Income Households offer was opened to applications from all parts of New South Wales on 1 August 2022.
- \* 8812 ISOLATED PATIENTS TRANSPORT AND ACCOMMODATION SCHEME—Mrs Helen Dalton to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—
  - (1) Is there a list of eligible medical services for which eligible patients are able to claim for under Isolated Patients Travel and Accommodation Assistance Scheme (IPTAAS)?
    - (a) What criteria is used to determine which services will be eligible?
  - (2) Why is treatment by a behavioural optometrist not covered under IPTAAS?

#### Answer—

- (1) The IPTAAS Assessment Guidelines include a list of currently approved specialist medical treatment, allied health clinics, high risk foot clinics and dental health clinics. The Guidelines also contain a list of eligible service criteria.
  - (a) Eligible health services are defined in section 3.5 of the Assessment Guidelines.
- (2) Treatment by a behavioural optometrist does not meet the IPTAAS eligibility criteria.
- \* 8813 COMPENSABLE FLOODPLAIN LICENCES—Mrs Helen Dalton to ask the Minister for Lands and Water, and Minister for Hospitality and Racing—
  - (1) Has the Government undertaken a recent calculation of the cost to the taxpayer of water licences in the north becoming compensable?
    - (a) Do you know how much this equates to per farm?

#### Answer-

The compensation provisions in the Water Management Act 2000 (the Act) have been temporarily disabled through amendment provisions. Whilst these amendment provisions remain, there are no foreseeable circumstances in which compensation would be payable to holders of floodplain harvesting licences.

\* 8815 HUME DAM AIRSPACE—Mrs Helen Dalton to ask the Minister for Lands and Water, and Minister for Hospitality and Racing—

Does the Government advise its representatives on the Basin Officials Committee (BOC) to maximise the Hume Dam existing airspace rules when La Nina conditions are evident?

#### Answer-

Day-to-day River Murray operational decisions are a matter for the Murray Darling Basin Authority (MDBA) in consultation with state river operators (i.e. WaterNSW) not the Basin Officials Committee.

\* 8816 SWAN HILL BRIDGE TRAFFIC LIGHTS—Mrs Helen Dalton to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—

The Murray River crossing at Swan Hill is a single carriage timber truss bridge built in 1896. Due to the increase traffic including heavy vehicles and safety concerns, will the Government consider installing traffic lights at this crossing?

#### Answer-

#### I am advised:

Traffic modelling carried out by Transport for NSW determined that traffic lights would not improve congestion, and traffic flow is better served by the current Give Way signage.

Transport for NSW will continue to look for ways to improve connectivity between communities and provide safer, more reliable journeys for locals and visitors to the region.

- \* 8817 MURRUMBIDGEE REGIONAL HIGH SCHOOL MERGER—Mrs Helen Dalton to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—
  - (1) Considering the Murrumbidgee Regional High School merger, when will the works begin on the school gymnasiums?
    - (a) What are the budget allocations for each school site for the gyms?
  - (2) Given the review from the University of New South Wales, will you demerge the schools to two sites, two schools which was a successful model previously?

#### Answer—

- (1) Planning work has already commenced on the new multipurpose halls at both the Griffith and Wade sites. This work is currently nearing completion of the masterplan phase.
  - (a) Funding for the gyms is part of the overall project budget. Funding for Stage 2 of the Murrumbidgee Regional High School upgrade project was approved in the 2021-22 NSW Budget. Final costs will be disclosed in the Budget Papers and the Department of Education's Annual Report.
- (2) The comprehensive study undertaken by the University of New South Wales did not recommend a demerger of Murrumbidgee Regional High School.

The Department has accepted all 14 recommendations from the University's report and will work to implement the recommendations to ensure the right and best outcomes are achieved for all students at Murrumbidgee Regional High School.

- \* 8819 SCHOOL WELLBEING NURSE PROGRAM—Mrs Helen Dalton to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—
  - (1) How many nurses are currently in New South Wales schools under the School Wellbeing Nurses Program?
  - (2) What schools within the Murray electorate currently have a nurse as part of the School Wellbeing Nurses Program?

- (1) There are 88 school wellbeing nurses located across NSW New South Wales public schools across the 15 local health districts.
- (2) Locations including a helpful, colour coded, interactive map, are publicly available on the NSW Health website.
- \* 8820 MOTOR HOME TOLLS—Mr Paul Lynch to ask the Attorney General representing the Minister for Metropolitan Roads, and Minister for Women's Safety and the Prevention of Domestic and Sexual Violence—

What steps will you take to ensure that motor homes are not charged as a truck on New South Wales toll roads?

Answer-

NSW Treasury is leading a toll regime review, supported by Transport for NSW, which is looking at a variety of different options to improve the consistency and fairness of pricing across the motorway network, whilst minimising congestion.

\* 8821 TRASH AND TREASURE SITE ON CAMDEN VALLEY WAY—Mr Paul Lynch to ask the Minister for Planning, and Minister for Homes—

What steps will you take to ensure that approval of the current development application for the Trash and Treasure site on Camden Valley Way Leppington will have access to Camden Valley Way?

The NSW Police Force is continuing to work towards addressing the Law Enforcement Conduct Commission conclusions in the Discussion Paper titled, the 'Review of the Operation of the Amendments to the Consorting Law under Part 3A Division 7 of the Crimes Act 1900', to ensure the ongoing appropriate practical application of consorting laws by Police.

\* 8823 BAIL ACT MONITORING GROUP—Mr Paul Lynch to ask the Attorney General—

On how many occasions since 12 July 2022 has the Bail Act Monitoring Group met?

The Bail Act Monitoring Group has met twice since 12 July 2022.

#### Answer-

The first stage of the Liverpool West Public School upgrade will be completed in early 2023 with the delivery of 16 new flexible teaching spaces, four new support units designed for students in need of behavioural support, a new hall and COLA, and a new library.

Construction of the second stage of the Liverpool West Public School, upgrade will commence immediately after the first stage is complete and updates will be provided on the School Infrastructure NSW website. The second stage will deliver a further 28 new flexible teaching spaces, four new special programs rooms, and a preschool within the refurbished Mainsbridge House.

The Independent Panel is currently assessing more than 500 applications and is expecting. to deliver its Final Report to the NSW Government later this year.

Following delivery, the NSW Government will review the recommendations contained within the Final Report.

- (1) Yes. The Social and Affordable Housing Fund (the Fund) has been used to award nine 25-year contracts with Community Housing Providers (CHPs) through two phases, SAHF 1 and SAHF 2 to provide access to over 3,486 social and affordable housing dwellings.
- (2) As of 30 September 2022, 3,040 new social and affordable homes across NSW have been funded through the Fund. 1,125 of these are in regional NSW meeting the 30 per cent regional target of the SAHF initiative.
- (3) The SAHF has delivered 17 additional social and affordable homes in the Sydney electorate.
- (4) While specific evaluation has not been carried out, effectiveness and value of the Fund was reviewed as part of the legislative review of the SAHF Act. It was determined that the Fund was achieving its policy objectives of providing more social and affordable dwellings but in a manner which empowers the tenants to lead more independent lives and encourages them to work towards economic independence.
  - As part of the evaluation of the Future Directions plan, aspects of the SAHF program are and will be evaluated.
- (5) The Government has invested in alternative schemes involving direct grants to non-profit CHPs for construction of low-cost housing. Specifically, the Government has invested in the Community Housing Innovation Fund (CHIF). The CHIF is a \$152.5 million program that is expected to deliver more than 700 social and affordable housing dwellings by 2025, with the CHP sector also contributing significant resources.
