- * 9253 EDUCTAION IN THE MAITLAND ELECTORATE—Ms Jenny Aitchison to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—
 - (1) From the commencement of term 1 this year, on how many occasions have schools in the Maitland electorate been unable to fill a vacancy with a casual replacement?
 - (a) When this occurs what arrangements are put in place to ensure that classes can still be conducted?
 - (b) How many occasions have resulted in two classes or more being combined?
 - (c) Is there a capped number of students allowed in a classroom?
 - (i) If there is such a cap, has it has been breached?
 - (ii) If so, how many times?

Answer-

The data requested regarding minimal supervision and merged classes is not centrally held by the Department of Education. This data has also never been a requirement for schools to collect and record.

- * 9254 TEACHERS ON EXTENDED LEAVE—Ms Jenny Aitchison to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—
 - (1) Why is there no flexibility for teachers on extended leave who have relinquished their position to undertake casual employment within the same school?
 - (2) Given there is such a shortage of teachers in New South Wales Schools, will this policy be reviewed?

Answer-

As extended leave is a benefit afforded to employees for the purpose of providing them with a break from their workplace after a significant period of service, they are currently not permitted to undertake work for the Department of Education during this leave period.

 - (1) Has modelling been conducted at the Maitland train station roundabout to assess the traffic flows?

Answer—

I am advised:

Since 2013, the New England Highway and Church Street roundabout has been upgraded twice to manage congestion and improve safety. The upgrades were undertaken in 2016 and 2020.

Both projects had traffic modelling carried out to identify any issues at the roundabout and to investigate options which would provide the best solution to improve congestion and safety.

The Independent Panel's report on the priority round is publicly available on their website. The terms of reference is also available on the website.

With the exception of the Kempsey-Armidale Road, inspections have been conducted on all the roads endorsed from the Independent Panel's interim report. These inspections will identify and prioritise any improvement works and inform a business case which Transport for NSW is currently developing.

Restoration work on the Kempsey-Armidale Road is being delivered by Armidale Regional Council. Inspections on this road will commence once the works are completed, followed by the transfer of asset management responsibilities.

* 9262 BUILD BACK BETTER FUNDING—Ms Jenny Aitchison to ask the Deputy Premier, Minister for Regional New South Wales, and Minister for Police—

In relation to the \$512.5 million joint funding recently announced to help New South Wales build back better, what is the Government's contribution?

Answer-

I am advised:

The Australian and NSW Governments are delivering two complementary infrastructure betterment programs to support communities impacted by natural disasters. This investment totals \$512.5 million and is co-funded 50:50 by the Australian and NSW Government.

The investment includes a \$200 million Infrastructure Betterment Fund, administered by the Department of Regional NSW, and a \$312.5 million Regional Roads and Transport Recovery Package, administered by Transport for New South Wales.

Both programs will be delivered as a consistent, whole-of-government approach to betterment.

(a) The CCTV fund has been assessed for expansion to other areas of NSW.

In October 2022, the Community and Small Business CCTV Fund was expanded to include an additional eight LGAs adjacent to the original 10 LGAs. The following LGAs were added as eligible LGAs under the CCTV fund:

- Burwood;
- Canada Bay;
- Georges River;
- Inner West;
- Strathfield;
- Blue Mountains;
- The Hills; and
- Hawkesbury.
- (b) As of 23 November 2022, a total of 755 applications have been received from the original 10 LGAs.

 - (1) Given that due to the current floods, there are increasing instances of isolated landholders and livestock, that many landholders are also unable to pinpoint the location of stranded livestock to move them to higher ground, and that currently Department of Planning and Environment (DPIE) provides helicopters to do flyovers, but will not let landowners accompany them (as was previously the case) will the Minister detail why and how this change in policy occurred?
 - (2) Will the Minister undertake to overturn this decision and provide vital access to landholders impacted by flooding?

 - (a) Would you consider 3 weeks to be acceptable?
 - (2) Considering lump sum payments are designed for an immediate relief measure for people severely impacted by a disaster, why are towns severely affected by recent September flooding still awaiting support?

Answer-

The Australian Government Disaster Recovery Payment (AGDRP) is a Commonwealth administered grant program which provides a lump sum payment to help those impacted by natural disasters. This emergency payment is activated by the Commonwealth.

- * 9267 EDUCATOR TO STUDENT RATIO—Mr Roy Butler to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—
 - (1) Given that educator to student ratio requirements for early childcare centres in New South Wales are impacting the availability of support for families and that regional and Metropolitan areas of New South Wales have the same requirements for educator to student ratio provision, and considering the availability of qualified person/s, can the Minister consider adjusting regional requirements, as many families are going unsupported?
 - (2) Attracting professionals to regional areas can often been determined by availability of childcare services, would more nurses, doctors and teachers be more inclined to move rurally if this measure was available?
 - (3) If educator to student ratio adjustments cannot be considered, what other options can the Minister suggest to improve the availability of this service?

Answer-

The NSW Government is committed to supporting the ECEC sector and growing the workforce without compromising children's safety or standards. Given the size and diversity of this sector, we rightly set a high standard for service ratios.

Educator-to-child ratio and qualification requirements are important aspects of structural quality that affect the provision of quality education and care.

Provisions exist within the National Regulations for services experiencing difficulty in meeting regulatory requirements, particularly services located in remote and very remote areas of NSW. The NSW Regulatory Authority may grant waivers to regulatory requirements on application, and in exceptional circumstances. These are considered on a case-by-case basis and are subject to there being no increased risk to the health, safety and wellbeing of children in education and care.

The NSW Government is committed to supporting children and families with access to affordable and quality early childhood education and care, no matter their circumstances or where they live through a \$15.9 billion investment in the Early Years Commitment. Investments include:

- \$5.8 billion over 10 years for the introduction of a universal pre-kindergarten year for every child in the year before school by 2030,
- \$5 billion over 10 years to deliver the Childcare and Economic Opportunity Fund
- \$281.6 million focused on growing, developing and retaining the ECEC workforce, including in regional and remote areas
- \$1.3 billion over four years in fee relief for affordable preschool, accessible across NSW from 2023
- \$376.5 million in Brighter Beginnings to implement a range of evidence-based inter-agency programs.

Since the \$281.6 million workforce package was announced in June 2022, over 1,000 successful early childhood scholarships have been announced.

The NSW Government is committed to replacing the State's ageing diesel bus fleet with zero emission vehicles. The Government will invest \$218.9 million over the next seven years to support the bus fleet move to zero emissions and will also set aside almost \$2 billion to help the transition process for more than 8,000 buses across the state ensuring NSW has a fully transitioned fleet by 2047.

The benefits of transitioning to zero emission vehicles include: significantly lower greenhouse gas emissions from public transport, reduced noise, better air quality for NSW communities, and quieter, smoother and more comfortable bus journeys for customers.

In accordance with Vehicle Standard (Australian Design Rule 83/00 -External Noise) 2005, Transport for NSW monitors external noise limits for the various categories of vehicles and the test conditions under which they apply.

Under the Road Transport (Vehicle Registration) Regulation 2017, inspections are conducted in relation to defects on buses that might cause increased noise levels. These inspections are carried out twice per year as a minimum requirement.

Additionally, the Environment Protection Authority can act on reports of high levels of noise from vehicle exhausts and direct vehicles for inspection.

Data in relation to vehicle noise emissions is publicly available on the Infrastructure Australia website.

(1) (a)-(c) and (g)The agritourism planning reforms aim to make it easier for primary producers to set up, run and grow agritourism experiences on their farms. Agritourism showcases what's unique about a region, educates the public about farm-to-plate, and encourages the next generation to farm the land.

Research by the NSW Small Business Commission and Service NSW in 2018-19, under the Making Business Easier program, identified blockages in the planning system which prevented famers doing their preferred agritourism activities and subjected them to delays and costs associated with development applications.

State-wide public consultation on the agritourism proposals in early 2021 and subsequent consultation with industry about the types of agritourism farmers are already doing, confirmed the need for broad land use terms, broad applicability, and simpler and low-cost planning pathways for minor development. This encourages innovation and saves farmers time and money.

To protect prime agricultural land, agritourism must be ancillary to the farm but could bring in more income than the agricultural operations, particularly during periods of drought or other circumstances beyond the farmer's control.

- (1) (e) Farm buildings up to 1200sqm can be built under complying development. A 200sqm building is about the size of a small shed and is not significant for farming properties but will enable a viable agritourism business. - (1) (h) For the first time, the reforms give clear definitions and metrics for agritourism development that can be easily understood by farmers, neighbours and councils.

Educator-to-child ratio and qualification requirements are important aspects of structural quality that affect the provision of quality education and care. Given the size and diversity of this sector in NSW, we rightly set a high standard for service ratios.

Provisions exist within the National Regulations for services experiencing difficulty in meeting regulatory requirements, particularly services located in remote and very remote areas of NSW. The NSW Regulatory Authority may grant waivers to regulatory requirements on application, and in exceptional circumstances. These are considered on a case-by-case basis and are subject to there being no increased risk to the health, safety and wellbeing of children in education and care.

The Department of Education has been working closely with Bourke and District Children's Services to support the temporary service re-location and minimise the impact on children and families while a long-term solution is coordinated, including a \$4.8 million grant awarded to Bourke and District Children's Services under the Start Strong Capital Works Crisis Fund.

- * 9342 SELF-FUNDED SCHOOL BUS SERVICE—Mr Roy Butler to ask the Minister for Skills and Training, Minister for Science, Innovation and Technology, Minister for Enterprise, Investment and Trade, and Minister for Sport representing the Minister for Education and Early Learning—
 - (1) Considering that a regional New South Wales school has established and funded a school bus service to support students who live remotely but are unable to support this service moving forward, also that a request was made to the Minister asking for support in 2024 but was declined due to student demand not meeting the requirements of the School Student Transport scheme (SSTS), when regional schools are unable to support the requirements of the SSTS model, can consideration be made by the Minister to ensure a service can be offered to those who live remotely?
 - (2) If a bus service is already established and self-funded, would the Minister consider some support to ensure the service can remain active?
 - (a) If not, why?

Answer—

The School Student Transport Scheme is managed by Transport for NSW.

Where there is no public transport available, the School Drive Subsidy, also managed by Transport for NSW, partly offsets the cost for driving students to school or to the nearest transport pick up point, by car, motorcycle or boat.

Principals work with their school communities regarding queries about getting students to and from school and may assist with local arrangements.

* 9343 PRIMARY PRODUCER VEHICLES REGISTRATION—Mr Roy Butler to ask the Minister for Customer Service and Digital Government, Minister for Small Business, and Minister for Fair Trading—

Considering that Service NSW cannot accept an email copy of the Primary Producer Declaration (PPD) as Transport for NSW auditing requires the original document and when establishing a vehicle registration under the PPD, the original is required. For Primary Producers in flooded areas this is impossible. Will the Minister adjust Service NSW's requirements so that Primary Producers can register their vehicles under this declaration whilst flood conditions remain?

Answer-

- (1) This question should be referred to the Minister for Metropolitan Roads, Women's Safety and the Prevention of Domestic and Sexual Violence.
- * 9344 SCHOOL STUDENT TRANSPORT SCHEME—Mr Roy Butler to ask the Minister for Agriculture, and Minister for Western New South Wales representing the Minister for Regional Transport and Roads—

Considering the fact that in regional NSW Boarding Schools students utilise the School Student Transport Scheme (SSTS) as means of travelling to and from school each term, a Government subsidy which enables students to be returned to school without parents having to travel hundreds of kilometres, and often incurring an accommodation cost as the trip has to be travelled over a two day period and that travel cards are issued based on students returning to their hometown/suburb only, rather than a close regional centre. However, regionally this is not always viable as bigger town centres have the availability of more reliable and frequent public transport options that may suit families better, can the Minister advise whether the scheme can be designed more specifically for regional Boarding School travellers or have flexible options?

Answer-

I am advised:

The School Student Transport Scheme is supported by the School Drive Subsidy. The School Drive Subsidy is provided to families where there is no public transport available. The subsidy partly offsets the cost for driving students to school or to the nearest transport pick up point. To provide flexibility, this subsidy can be applied for in conjunction with the travel available for boarders if this option suits the transport needs of the family.

Under the current School Student Transport Scheme, free travel is provided between the home and school to allow students to access education. For school students that are weekly boarders, up to 22 trips per semester can be claimed. Students that are term boarders can claim up to nine trips per year.

In addition, a Long Distance Coach Subsidy is available for students that require coach travel from a train line to either the school or home.

- * 9345 BROADMEADOW LOCOMOTIVE DEPOT—Mr Tim Crakanthorp to ask the Minister for Environment and Heritage—
 - (1) Will the Minister seek clarification from the NSW Heritage Council as to why it has not endorsed any s38A Heritage Act 1977 (NSW) conservation management plan (CMP) for the Broadmeadow Locomotive Depot State Heritage Inventory Site at 35 Cameron Street, Broadmeadow?
 - (2) Noting that the site's irreplaceable heritage values are falling into disrepair, will the Minister commit to ensuring a CMP for the site is prepared for the Heritage Council's consideration without

- delay and before the development proposed for the site pursuant to DA 2022/01269 (Newcastle City Council Local Government Area) proceeds?
- (3) Noting the state of disrepair into which the site has fallen, will the Minister commit to assessing whether use of his enforcement powers under s120 of the Act is necessary in order to ensure the Transport Asset Holding Entity complies with its obligations under clauses 10 and 25 of the Heritage Regulation to protect the heritage values of the site?

Answer-

- (1) The Heritage Act 1977 (the Act) does not require a Conservation Management Plan (CMP) for every State Heritage Register-listed place, nor that a CMP must be endorsed by the Heritage Council of NSW.
- (2) The current land subdivision application (integrated development application DA2022/01269), includes a Statement of Heritage Impact which Heritage NSW considers sufficient to manage the heritage values of the place.
- (3) The Heritage Council of NSW has powers under section 120 of the Act to issue repair orders. That power is reserved for critical breaches of the Act.
 - I am advised Heritage NSW (as a delegate of the Heritage Council of NSW) is holding ongoing discussions with the Transport Asset Holding Entity (TAHE) about its obligations under the Act, and to discuss its longer-term conservation and activation aspirations for the site.
- * 9346 NEW SOUTH WALES HYDROGEN STRATEGY—Mr Tim Crakanthorp to ask the Treasurer, and Minister for Energy—
 - (1) I refer to page 60 of the NSW Hydrogen Strategy, what resources have been dedicated to the Australian Hydrogen Council to support their program of works related to skills and training?
 - (2) How much money has the Government provided to the Australian Hydrogen Council to support their program of works related to skills and training?
 - (3) What skills and training does the Australian Hydrogen Council provide?

Answer-

- (1) In relation to Action 15 of the NSW Hydrogen Strategy, staff in the Office of Energy and Climate Change, within NSW Treasury, have supported the Australian Hydrogen Council's (AHC) program of works on skills and training, standards, technical regulatory policy development and social licence. This includes presenting at AHC's conferences, attending regular information sharing meetings, quarterly members meetings and webinars.
 - The NSW Government is working with AHC, the National Hydrogen Working Group under the National Hydrogen Strategy, and other key stakeholders to identify and address critical hydrogen skills and training gaps. This includes the development of the national report on Australia's hydrogen workforce, released in October 2022. This is to ensure the NSW Government supports nationally consistent skills development under the NSW Hydrogen Strategy.
- (2) The NSW Government has not provided any funds to the AHC for skills and training to date.
- (3) The AHC is the peak body for the hydrogen industry and is focused on advocacy and collaboration activities. The AHC engages in a range of educational activities, including conferences, webinars and information sessions, and provides a suite of tools across a range of issues, including skills and training requirements.

- * 9347 BROADMEADOW HERITAGE LOCOMOTIVE DEPT LOTS—Mr Tim Crakanthorp to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—
 - (1) What is the purpose of the Transport for NSW subdivision at the Broadmeadow Locomotive Depot located 35 Cameron Street, Broadmeadow?
 - (2) Can the Minister please indicate the proposed use for each of the following lots:
 - (a) Lot 49/A/4020?
 - (b) Lot 57/A/DP4020?
 - (c) Lot 26 in DP1147480?
 - (d) Lot 13/1231619?
 - (e) Lot 14/1231619?
 - (f) Lot 15/1231619?

 - (3) Has Transport for NSW ever had a conservation management plan for the former Broadmeadow locomotive depot?

Answer-

I am advised:

This is a matter for the Minister for Infrastructure, Cities, Active Transport.

* 9348 389 BUS SERVICE—Mr Alex Greenwich to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—

What locations have been explored for a potential new bus stop for the 389 in Pyrmont and in the Central Business District (CBD)?

Answer-

I am advised:

Route 389 provides connections to a large number of bus and rail services in the Sydney CBD and Bondi Junction. Stops in the Pyrmont area are less than 400 metres apart, except in areas where the route operates as a one-way loop where it is not common to provide stops. Transport for NSW found that a stop spacing of about 400 metres provides the best balance between commuter access and reasonable journey times.

Transport for NSW undertook a review of adding another bus stop on York St, travelling towards Bondi Junction, however, the proposed stop is already highly utilised by other bus services and the addition of the 389 would result in unnecessary delays to services and commuters.

- * 9349 ADOPTION REVERSAL—Mr Alex Greenwich to ask the Attorney General—
 - (1) What consideration has been given to the Western Australian adoption reversal process?
 - (2) What steps are being taken to make the process of adoption reversal easier for residents of New South Wales?

Answer-

This question should be directed to the Minister for Families and Communities as these matters fall within the Minister's portfolio of responsibilities.

- * 9350 COAL MINING: SCOPE 1 AND 2 EMISSIONS—Mr Alex Greenwich to ask the Minister for Planning, and Minister for Homes—
 - (1) Given coal mines are responsible for three percent of the state's electricity use and 14 percent of all greenhouse gas emissions in New South Wales, including methane, the most destructive greenhouse gas:
 - (a) How does the Government require all coal mines in New South Wales implement all "reasonable and feasible" mitigation measures for scope 1 and 2 emissions?
 - (b) What greenhouse gas abatement measures are imposed on the 24 coal mines that are "high emitting facilities"?
 - (c) What work is the Government doing to achieve the IEA gaol of eliminating technically avoidable methane emissions by 2030 in the coal mining sector?

Answer—

- (a) Development consents for mining projects require that greenhouse gas emissions are minimised and that best practice management is employed. In recent approvals, greenhouse gas performance measures have been set for Scope 1 and Scope 2 emissions along with a requirement for ongoing review and implementation of reasonable and feasible greenhouse gas abatement measures to reduce emissions over time.
 - The Environment Protection Authority has recently released its Climate Change Policy and Climate Action Plan. The plan requires coal mine operators to prepare and implement climate change mitigation and adaptation plans.
- (b) Recent mining approvals have been recommended a range of conditions to minimise, mitigate and offset greenhouse gas emissions if required. These conditions include requiring the preparation and implementation of a Scope 1 Emissions Minimisation Plan (to be updated and reviewed every 3 years), in consultation with the Advisory Panel for Underground Mining and key NSW government agencies, to ensure that GHG emission abatement technology continues to be comprehensively investigated and adopted.
- (c) The NSW Government is committed to reducing emissions from coal mining and is taking several actions including:
- Conditioning development consents to require mining projects to reduce emissions overtime as technology improves
- Establishing the coal innovation fund to advance low emission technology research
- Releasing the EPA Climate Change Policy and Action Plan that will progressively place emission reduction targets and limits on the mining industry.
- * 9351 COAL MINING: SCOPE 1 AND 2 EMISSIONS—Mr Alex Greenwich to ask the Deputy Premier, Minister for Regional New South Wales, and Minister for Police—
 - (1) Given coal mines are responsible for three percent of the state's electricity use and 14 percent of all greenhouse gas emissions in New South Wales, including methane, the most destructive greenhouse gas:
 - (a) What work is the Government doing to ensure all coal mines in New South Wales transition to using renewable energy?

- (b) Under this work, when will all coal mines in New South Wales be powered by 100 percent renewable energy?
- (c) What work is the Government doing to ensure all coal mines in New South Wales transition their fleet to electric or low/zero carbon fuel?
- (d) Under this work, when will the fleet in all coal mines in New South Wales be electric or low carbon fuel?

- (a) This question should be directed to the Treasurer and Minister for Energy. There are various initiatives to reduce emissions from the mining sector such as the High Emitting Industries fund under the Net Zero Industry and Innovation Program.
- (b) This question should be directed to the Treasurer and Minister for Energy.
- (c) This question should be directed to the Treasurer and Minister for Energy.
- (d) This question should be directed to the Treasurer and Minister for Energy.
- (e) In addition to the NSW Government's South 32 and CSIRO collaboration to construct a full-scale next generation ventilation air methane (VAM) mitigation reactor (VAMMIT unit), the NSW Government has funded two other ventilation air methane abatement projects, one at the Appin coal mine and one at the Mandalong coal mine.

* 9352 RESTRICTED DATA BREACHES—Mr Alex Greenwich to ask the Attorney General—

- (1) To what extent can a victim who has had their personal restricted data illegally accessed or modified take action against the perpetrator if the unauthorised access occurred through a company information or computer system, such as an employee illegally accessing customer data held by their employer?
- (2) To what extent is there a gap in pursuing the perpetrator if the company where the data breach occurred does not pursue the perpetrator for the data breach?
- (3) What steps have been taken to ensure that customers are protected from unauthorised access and what penalties are there for companies whose employees exercise breaches?
- (4) What steps are being taken to better protect customers from unauthorised access to their data in New South Wales?

Answer-

I am advised:

- The <u>Privacy and Personal Information Protection Act 1998 (NSW)</u> (PPIP Act) places obligations on NSW public sector agencies regarding the way personal information is collected, stored, used and disclosed.
- The <u>Privacy Act 1988 (Cth) (Cth Privacy Act)</u> regulates how Australian Government agencies and organisations with an annual turnover of more than \$3 million, and some other organisations, handle personal information.
- Depending on the setting of the breach, an aggrieved individual can raise a complaint with the NSW Information and Privacy Commission (for breaches of the PPIP ACT) or the Office of the Australian Information Commissioner (OAIC) (for breaches of the Cth Privacy Act).

The NSW Government has taken proactive action to prevent data breaches:

• In 2021, the NSW Government established ID Support NSW, which provides a 'no wrong doors' approach to support NSW citizens affected by identity misuse and which plays a role in uplifting privacy and cyber resilience across both the public and private sectors through an education and awareness campaign.

In November 2022, the NSW Government introduced the Privacy and Personal Information Protection Amendment Bill 2022 (NSW) (the MNDB Bill) to create a Mandatory Notification of Data Breach Scheme and to extend the PPIP Act to NSW State-Owned Corporations that are not already regulated by the Cth Privacy Act.

• In 2020, the NSW Government allocated \$60 million to establishing and funding Cyber Security NSW across three years. Cyber Security NSW is dedicated to uplifting the cyber security maturity of all NSW Government entities and has grown rapidly to provide a range of support services and tools to enhance the NSW Government's holistic capability to better prevent, detect and respond to cyber security incidents aimed at government entities. One of the outcomes of this ongoing maturity uplift is more effective protection against data breaches that have occurred due to a cyber attack.

Breaches of the Cth Privacy Act are enforced by the OAIC and are a matter for the Federal Government.

* 9353 LIGHT POLLUTION—Mr Alex Greenwich to ask the Treasurer, and Minister for Energy—

- (1) What laws or controls are currently in place to regulate light pollution?
- (2) How are residents able to protect themselves from the impacts of light pollution in their homes at night, particularly from signs and advertisements in new developments?

(1) The Department of Customer Services does not have access to information on applications made to the Land and Environment Court. However, before an application can be made to the Land and Environment Court an owners corporation must notify the Registrar General that the required level of support for a strata renewal plan was been obtained (s 176 Strata Scheme Development Act 2015).

Since commencement of the Strata Schemes Development Act 2015 the Registrar General has received notification under s 176 of the Act, relating to the required level of support for a strata renewal plan, from 17 strata schemes.

(2) Of the schemes that have notified the Registrar General of obtaining the required level of support for a strata renewal plan - 3 are in the Sydney electorate.

- (a) The Registrar General is only aware of one application being approved by the Land and Environment Court and that was in the Sydney electorate.

I am advised:

The intersection of Georges River Road and Milton Street, Ashfield currently has significant congestion issues, particularly during weekdays.

Installing a pedestrian crossing on the south side of the intersection and restricting right turn movements from Milton Street into and out of nearby Blackwood Avenue will help improve safety for motorists and pedestrians.

Between September 2020 and December 2022, noise-monitoring regimes were carried out throughout the 208 nights of work.

Since September 2020, Transport for NSW has received 86 complaints all of which have been individually addressed.

Transport for NSW and the Principal Contractor regularly consult, engage and communicate with residents throughout the project by informed notifications of upcoming works as well as provide SMS notifications, letter box drops, and door knock communications to residents

- * 9357 SYDENHAM ROAD AND FITZROY STREET, MARRICKVILLE—Ms Jo Haylen to ask the Attorney General representing the Minister for Metropolitan Roads, and Minister for Women's Safety and the Prevention of Domestic and Sexual Violence—
 - (1) What is the status of investigations into the installation of traffic lights at the corner of Sydenham Road and Fitzroy Street, Marrickville?

- (2) What conversations have Transport for NSW had with Inner West Council regarding this issue?
- (3) What other consideration is being given to a pedestrian crossing on Sydenham Road between Vitoria Street and Buckley Street?

Currently, there is a signalised pedestrian crossing on Sydenham Road at Victoria Road and Railway Parade.

Transport for NSW is planning to review the intersection of Sydenham Road and Fitzroy Street, Marrickville. The review will include the current operation of intersection and consider if any additional safety measures are warranted at this location, such as traffic signals.

- * 9358 DULWICH HILL STATION TRAFFIC LIGHTS—Ms Jo Haylen to ask the Minister for Infrastructure, Minister for Cities, and Minister for Active Transport—
 - (1) What is the status of the permit applications to install traffic lights on Wardell Road at Dulwich Hill Train Station?

Transport for NSW has been working with Inner West Council on a proposed set of traffic lights at the intersection of Wardell Road and Dudley Street in Dulwich Hill. On 6 December 2022, Transport for NSW approved the plan to install new traffic lights at the intersection that will improve customer access to the train station and also adjacent shops and nearby houses.

Inner West Council is responsible for installing the new traffic lights.

- * 9359 MARRICKVILLE TRAIN STATION—Ms Jo Haylen to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—
 - (1) Given residents have reported a persistent odour from Marrickville Train Station over the past few months, possibly associated with works to convert the line to Metro, what investigations have been undertaken by Transport for NSW?

The Sydney Metro Marrickville Station site project team has reported that they are not aware of any persistent or irregular environmental odours.

Regular inspections are conducted by the Sydney Metro project's independent Environmental Representative and other stakeholders, who have not provided any feedback related to odours.

* 9360 EMERALD CLASS 2—Ms Jo Haylen to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—

Have the Emerald Class 2 Ferries ever been inspected and certified in any other jurisdiction apart from New South Wales?

Answer-

I am advised:

In Australia, commercial vessels, including passenger ferries, are assessed against the National Standards for Commercial Vessels (NSCV). Compliance with NSCV is determined by an Australian Maritime Safety Authority (AMSA) accredited surveyor before a Certificate of Survey and Operations can be issued.

The Second Generation Emerald Class ferries were designed and built in accordance with NSCV requirements. The vessels have been inspected by AMSA accredited surveyors in New South Wales and certified to operate, issued a Certificate of Survey and Operations, in passenger service in Australia.

During the construction of the Second Generation Emerald Class fleet in China, inspections were carried out by third parties, including an international class society, as part of the assurance process for the build.

* 9361 QUEENSCLIFF—Ms Jo Haylen to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—

When does Transport for NSW expect the Queenscliff to return to service after works at Garden Island?

Transport for NSW is undertaking a review of the proposed design to remove the painted zebra crossing and replace it with a pedestrian refuge. Transport for NSW consulted with Central Coast Council and Lisarow Public School in November 2022 and the consultation is ongoing.

I am advised:

On 12 January 2023, an update about the Tuggerah Station Transport Access Program upgrade was published on the project website.

Work on the main project will start in February, with early works already underway and progressing well.

The platform will be widened to accommodate wheelchair access at the Boarding Assistance Zone, in accordance with Disability Standards Accessible Public Transport.

- * 9371 WASTE MANAGEMENT—Mr Jamie Parker to ask the Minister for Environment and Heritage—
 - (1) Following the release of the Audit Office's report into 'Waste levy and grants for waste infrastructure' which showed that less than 15% of revenue collected from the NSW Waste Levy is being spent on waste management, will the Government review this spending in order to allocate more funds to waste management?
 - (2) What is the Government doing to build soft plastic recycling facilities here in New South Wales to reduce our state's reliance on overseas and interstate recycling facilities?

Answer-

(1) The NSW Waste and Sustainable Materials Strategy 2041, and Auditor General for NSW's recommendations support formal five-yearly reviews of the operation of the waste levy to ensure it is continuing to achieve its policy objectives. This includes a review of levy area boundaries. The next review of the waste levy is due to commence in 2023.

All waste levy funds in NSW are returned to consolidated revenue, with a third returned to the environment portfolio, and the rest retained by the NSW Government to fund essential government services.

An interagency working group was formed in late 2022 to consider strategic waste infrastructure planning matters.

(2) The NSW Government committed to tripling the plastics recycling rate by 2030 in the NSW Plastics Action Plan.

This commitment is backed by financial support for the sector to reduce the amount of hard to recycle plastics used in manufacturing, increase the capacity to collect, sort and process more soft plastics in NSW, and to stimulate the end markets for the recycled product.

Through the Remanufacture NSW and Remanufacture NSW: Regional and Remote grant programs, \$26.3 million has been awarded to 27 projects, including four projects that will increase recycling and reuse processing capacity for soft plastics.

In September 2022, the NSW EPA opened the \$9 million Circular Plastics Program, which incentivises small to medium manufacturers to improve recyclability of the plastics they use, stimulate demand for recycled plastics, and for new infrastructure. Round 1 closed on 17 November 2022, and further funding will be available under Round 2.

* 9372 SHORE POWER AND WHITE BAY BERTHS 3 AND 4—Mr Jamie Parker to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—

Given the NSW Port Authority is open to including shore power capabilities at White Bay berths 3 and 4 once long-term users of the sites have been identified, what steps are now being taken to ensure the use of shore power is being encouraged and prioritised for potential users of these sites?

Port Authority of NSW is undertaking an open market process to find suitable long-term tenants for White Bay berths 3 and 4. Port Authority of NSW expects that all future tenants of these sites will commit to utilising the available shore power infrastructure for their commercial shipping activities.

Given Transport for NSW's safety audit of September 2020 found there is an "intolerable" risk of pedestrian safety resulting in potential fatality by motorists running red lights at the Victoria Road and Darling Street intersection, Rozelle, (which is a major pedestrian crossing for children attending Rozelle Public School) and that this intersection was not included in the shortlist for installation of a red-light speed camera in previous site selections, what is the criteria against which decisions to install red-light speed cameras are made?

What are the results of noise monitoring for the Pacific Adventure during its stay at White Bay Cruise Terminal on December 17 2022?

Preliminary advice received by the specialist noise consultants for the Port Authority of NSW, indicates the average noise level for the Pacific Adventure on 17 December 2022 was 60 dBA. The vessel was only berthed during the daytime period.

* 9375 GLEBE FERRY SERVICE PATRONAGE—Mr Jamie Parker to ask the Minister for Transport, Minister for Veterans, and Minister for Western Sydney—

How many trips have been taken each day on the F10 ferry service running between Glebe and Barangaroo since the service resumed in January 2022?

Answer—

From 2 January 2022 until 17 January 2023, on days which the F10 Blackwattle Bay service has operated, there have been an average of 140 trips made per day.

* 9376 INSURANCE GAP—Ms Janelle Saffin to ask the Treasurer, and Minister for Energy—

What action have you taken with your Federal counterpart to address the insurance gap we have across the flood-impacted communities within the electorate of Lismore and wider Northern Rivers region?

Answer—

The expected rise in the cost of flood disasters, which is linked with the frequency of disaster events and rising value of property, raises several challenges.

These challenges can lead to reduced insurance coverage against flood risk, particularly for people located in NSW flood-prone areas. For example, insurance companies may be less inclined to offer flood cover for properties exposed to a high level of flood risk or only offer cover at a high premium.

In December 2022, the National Cabinet tasked Treasurers, through the Council for Federal Financial Relations, to lead work on reforms to improve insurance affordability. This work is in progress and will be done in consultation with the Insurance Council of Australia.

The NSW Government is also progressing the implementation of the 2022 Independent Flood Inquiry Report recommendations. Insurance coverage and accessibility are being considered in this ongoing work.

* 9377 NON-GOVERNMENT HEALTHCARE BUSINESS GRANT—Ms Janelle Saffin to ask the Minister for Health representing the Minister for Women, Minister for Regional Health, and Minister for Mental Health—

Has the Government made representations to the Commonwealth Government to share the costs of a Northern Rivers Non-Government Healthcare Business Grant to help flood-impacted general practices and specialists rebuild and remain in the region to continue providing essential health services?

The authority's responsibilities include the development and implementation of the State disaster mitigation plan. The State disaster mitigation plan will set priorities for the plan, disaster adaptation plans and strategic plans under the Environmental Planning and Assessment Act 1979.

* 9379 PREPARATION FOR NATURAL DISASTERS—Ms Janelle Saffin to ask the Minister for Planning, and Minister for Homes—

How does the New South Wales Reconstruction Authority propose to prepare for natural disasters?

Answer-

I am advised:

The NSW Reconstruction Authority (NSWRA) is dedicated to disaster prevention, preparedness, recovery, and reconstruction. It reports to the Minister for Planning, the Hon Anthony Roberts MP, and the Minister for Emergency Services and Resilience, and Minister for Flood Recovery, the Hon Steph Cooke MP.

This represents a new and unique alignment between disaster planning and strategic planning that did not previously exist in NSW. This new approach will be an integral part of how we design our future cities and towns.

The NSWRA will lead disaster resilience, risk reduction, adaptation and mitigation activities in our communities. The NSWRA will also provide education and infrastructure before disasters to minimise harm. This will enable the reconstruction process begins swiftly when a disaster strikes and will reduce community devastation.

* 9380 NATURAL DISASTER PLAN—Ms Janelle Saffin to ask the Minister for Planning, and Minister for Homes—

If a natural disaster happened today how would the New South Wales Reconstruction Authority coordinate the rescue, response, recovery and rebuild?

The NSW Reconstruction Authority (NSW RA) is dedicated to disaster prevention, preparedness, recovery, and reconstruction. It reports to the Minister for Planning, the Hon Anthony Roberts MP, and the Minister for Emergency Services and Resilience, and Minister for Flood Recovery, the Hon Steph Cooke MP.

The NSW emergency services organisations will continue to lead the response and rescue efforts during natural disasters under the NSW State Emergency Management Plan. The NSWRA will focus on better preparing NSW communities against future disasters and building more resilient places that will protect lives and property.

* 9381 REGIONAL LIAISON OFFICERS—Ms Janelle Saffin to ask the Minister for Planning, and Minister for Homes—

When will the New South Wales Reconstruction Authority's promised Regional Liaison Officers be onboarded and allocated to local councils?

Regional Liaison Officers are a fixture of the Queensland Reconstruction Authority and have not been announced as part of the NSW Reconstruction Authority.

The NSW Reconstruction Authority works closely with local councils via its network of regionally based operational staff. As at December 2022 there are 54 regionally based staff.

The NSW Reconstruction Authority has also onboarded 17 Community Recovery Officers to support recovery following the successive flood events in 2022, to a total of \$9.24 million, which is jointly funded with the Commonwealth.

Under the Disaster Risk Reduction Fund (DRRF) grants, The NSW Reconstruction Authority are also funding for 18 months a small group of Community Resilience Officer roles.

These commenced recently and are place-based so that duties vary depending on a particular LGA need, with the aim being to help local communities build resilience.

* 9382 RECONSTRUCTION AUTHORITY STAFF—Ms Janelle Saffin to ask the Minister for Planning, and Minister for Homes—

How many staff does the New South Wales Reconstruction Authority have?

As at December 2022, the NSW Reconstruction Authority has a total headcount of 223. This reflects the interim structure of the new agency. A completed establishment will be finalised following the conclusion of organisational management changes.

 - (b) The selected real estate agency (Savills) has extensive experience in government property dealings and ROI campaigns, with strict adherence to probity and privacy.
 - (c) No.
 - (i) Not applicable.
 - (ii) The results of the process will not be published due to proponent privacy and confidentiality requirements.
- (2) Online access and communication has been effective in obtaining community, not-for-profit and market participants' feedback. Over 100 enquiries and feedback comments have been received to date from a wide spectrum of the community via the website.
 - In addition, there is signage at the site which provides agent contact details so interested parties can obtain further information, including the opportunity to request hard copies of the documents. The ROI process was also advertised in the local media, including the Illawarra Mercury.

An additional \$65 million of federal funding was announced on 10 January 2023, bringing the total joint commitment with the NSW Government to \$105 million. The funding committed will allow an options assessment for a bypass of Bomaderry and Nowra to be completed. This will also include a broader integrated transport plan that identifies and prioritises a range of transport solutions to complement a potential future bypass while ensuring the broader transport system is safe, efficient and can offer improved transport choice.

Community consultation will form part of the project development and the consultation plan is still being developed. Transport for NSW will keep the community informed as the project progresses.

The project design of the more than \$700 million new Shellharbour Hospital to be built at Dunmore will enable the construction of a rooftop helipad in the future. In disaster emergency response situations, helicopters will be able to land in the grounds next to the new hospital. NSW Ambulance continues to consult with Health Infrastructure and the local health district regarding the redevelopment of the Shellharbour Hospital.

Maternity services will be provided to expectant mothers on a daily basis at the new Shellharbour Hospital for both pre and post birthing care. These services will include midwifery-led clinics, doctor-led clinics, midwifery group practice (MGP) clinics, the establishment of an MGP in-home ante-natal and post-natal service both in-person and virtually, lactation support clinics, gynaecology clinics, women's health physiotherapy and childbirth education classes.

The new Shellharbour Hospital has been designed with the future in mind. There will be opportunity, should it be possible, for expanded or new services in line with the needs of the community. Birthing services will remain at Wollongong Hospital in the short to medium term due to the specialist services and staff that are required to maintain a safe birthing facility for mothers and their babies.

NSW Health records indicate that a number of representations have been received from the Member for Kiama about the redevelopment.

- * 9402 PLANNING DECISIONS AND POWERS—Mr Gareth Ward to ask the Minister for Planning, and Minister for Homes—
 - (1) With respect to the NSW Coalition's commitment in 2011 to return planning powers back to local communities:
 - (a) How as the Government returned planning powers back to local communities?
 - (b) How many planning proposals did the Government consider each calendar year from 2011 to 2022?
 - (c) How many amendments to planning legislation has the Government made since 2011?
 - (d) With respect to question (c), how many changes to planning policies, regulation, rules or legislation enhanced community consultation and community-based decision making?

- (e) With respect to question (c), how many changes to 'exempt and complying' rules has the Government made since 2011?
- (f) What role and input will local communities have in planning decisions that relate to offshore wind farms (and related onshore substations and networks) on the south coast of New South Wales?
- (g) What role and input will local communities have in planning decisions that relate to the expansion of pumped hydro at Kangaroo Valley?
- (h) With respect to questions (f) and (g), will the Minister meet with me and locals to discuss these concerns?

(1)

- (a) Over the last decade there have been significant reforms to the way the planning system operates and a renewed focus on local decision-making and accountability. Reforms have included the removal of Part 3A of the Environmental Planning and Assessment Act 1979, the establishment of local and regional planning panels to improve local decision-making and an enhanced focus on strategic planning whereby councils and communities are able to outline and deliver on their plans for the local area.
- (b) Details of the approved planning proposals can be searched on the legislation.nsw.gov.au website. Specific proposals can be found on the NSW Planning Portal.
- (c) The Environmental Planning and Assessment Act 1979 has been amended 78 times since April 2011. Details of these amendments are available on the legislation.nsw.gov.au website.
- (d) Details of legislative amendments are available on the legislation.nsw.gov.au website. However, notable reforms have involved the development of Community Consultation Plans and Local Strategic Planning Statements.
 - Community participation is a key aspect of the NSW planning system and is fundamental to both strategic and statutory planning (including rezoning and development assessment).
- (e) The State Environmental Planning Policy (Exempt and Complying Development Codes) 2008 has been amended 94 times since April 2011. Details of these and other amendments are available on the legislation.nsw.gov.au website.
- (f) The Commonwealth is yet to declare any offshore wind areas off the south coast of NSW. Offshore wind farms in NSW will be regulated by the Commonwealth Government.
 - The Department will however have a role in assessing and approving any transmission and other infrastructure required in NSW waters and land for any declared offshore wind areas. The Department would assess any applications for infrastructure under the existing development assessment process which includes extensive provisions for community consultation.
 - During the exhibition period for any applications for infrastructure the Department will request the local community provides submissions relating to the relevant application. Any issues raised in submissions must be addressed by the proponent and will be considered by the Department as part of its thorough assessment of the application.
- (g) The Shoalhaven Hydro Expansion Project, a critical State significant infrastructure application for a new 235 MW underground pumped hydro power station, was exhibited from 9 November 2022 to 6 December 2022. The project is required to be re-exhibited due to a procedural error by the proponent. The application, environmental impact statement and

accompanying documents are unchanged from the original exhibition and are on reexhibition from Friday 13 January 2023 until Friday 10 February 2023.

During this re-exhibition of the application any members of the local community may provide their considered input regarding the project. Submissions made during the initial exhibition period do not need to be re-submitted during the second exhibition period.

Once the second exhibition period is concluded the proponent will be requested to prepare a submissions report which will respond to all issues raised in submissions. All submissions made during both exhibition periods must be addressed by the proponent and will be considered by the Department as part of its thorough assessment of the application.
