- (1) Can the Minister confirm when remediation of the current contaminated site will proceed and provide a detailed timeline for the entire process?

- (3) Can the Minister provide a detailed timeline and process for the construction of the replacement replica boatshed?
- (4) Can the Minister confirm when Crown Lands will release an EOI for the management of the site and construction of the replica boatshed?

Answer—

I am advised:

- (1) The Department of Planning and Environment -Crown Lands is currently finalising assessments and planning documentation to support a development application for the removal of the underground fuel tanks and other structures to satisfy the directions of SafeWork NSW and the NSW Environment Protection Authority.

The timeline of actions is outlined in the Voluntary Management Proposal which is available on the Crown Lands website ([Empire Bay Marina | Crown Lands \(nsw.gov.au\)](https://www.crownlands.nsw.gov.au)).

Commencement of works is dependent on Crown Lands obtaining development consent or a demolish works order from Central Coast Council.

Additional contamination testing will be undertaken following removal of the boatshed and fuel tanks to determine the level and extent of the contamination. Crown Lands will then develop a remediation action plan and lodge a development application with Council for full remediation of the site.

- (2) The cost estimate provided to Crown Lands by its consultant to build a compliant, accessible replica boatshed is commercial-in-confidence information.
- (3) No further funding was provided by the former government for the project. It is premature to consider alternate future uses for the site until the extent and potential costs of contamination and remediation required is understood.
