\* 0139 MONA VALE PUBLIC SCHOOL UPGRADE—Mr Rory Amon to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

- (1) What is the total expenditure to date on the Mona Vale Public School Upgrade?
- (2) What is the anticipated total cost (all inclusive) of the Mona Vale Public School Upgrade?

Answer—

This information can be found in the 2022-23 Budget Paper. Project expenditure is published in the Infrastructure Statement of the NSW Budget Papers on a yearly basis.

\* 0140 AQUATIC RESERVES IN THE PITTWATER ELECTORATE—Mr Rory Amon to ask the Minister for Police and Counter-terrorism representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—

- (1) Do any plans exist to establish any additional Aquatic Reserves in the Pittwater electorate?
- (2) If so, what are the details of these plans?

Answer—

(1) The Government has no plans to establish any new aquatic reserves in the Pittwater electorate. The Government is aware of a proposal put forward by some community members to establish a new aquatic reserve at Bongin Bongin Bay, Mona Vale, and concerns raised by some recreational fishers about potential restrictions to access from the proposal.

\* 0145 TAX REVENUE COLLECTED FROM POKER MACHINES IN THE PITTWATER ELECTORATE—Mr Rory Amon to ask the Minister for Planning and Public Spaces representing the Treasurer—

- (1) What was the total tax revenue collected from poker machines located in the Pittwater electorate during:
  - (a) 2018-19?
  - (b) 2019-20?
  - (c) 2020-21?
  - (d) 2021-22?

Answer—

I am advised this question is more appropriately directed to the Minister for Finance.

\* 0146 GOVERNMENT OWNED RESIDENTIAL PROPERTIES IN THE PITTWATER ELECTORATE—Mr Rory Amon to ask the Minister for the Illawarra and the South Coast, Minister for Regional Health, and Minister for Health representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—

- (1) How many residential properties in the Pittwater Electorate are currently under the ownership of the Government?
- (2) How many tenants are housed in Government owned residential properties in the Pittwater Electorate?
- (3) Are there any plans to increase the number of Government owned residential properties in the Pittwater Electorate?

Answer—

As at 30 June 2022, there are 38 community housing residential properties owned by the Land and Housing Corporation (LAHC) in the Pittwater Electorate. 51 tenants reside in the residential properties.

LAHC has no plans in the current development pipeline to increase the number of Government owned social homes in the Pittwater Electorate

If the Member is interested in discussing opportunities to increase public housing in the Electorate of Pittwater I would welcome the opportunity to meet with him regarding the matter.

- (1) How many patients were transported from an address in the electorate of Pittwater via ambulance service to a hospital in following financial years;

  - (c) 2021-22?
- (2) Of the patients transport via ambulance service referred to above, in each of the above financial years, please advise how many patients were initially transported to;
  - (a) Northern Beaches Hospital?

  - (e) St Vincent's Hospital Sydney?

- \* 0148 ENERGY SAVINGS SCHEME—The Hon. Kevin Anderson to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice representing the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—

In relation to the Government's Energy Savings Scheme (ESS):

- (1) Are residents in the Tamworth electorate eligible to receive upgrades to their hot water system under the Government's Energy Savings Scheme (ESS)?
- (2) If so, when can the community expect to see suppliers servicing the region?
- (3) Can the Minister supply a list of locations currently serviced by approved suppliers in regional New South Wales?

Answer—

- (1) Yes, the Government's Energy Savings Scheme (ESS) provides financial incentives for residents and businesses in the Tamworth electorate to upgrade their hot water system .
- (2) According to data collected the ESS scheme administrator, the Independent Pricing and Regulatory Tribunal, suppliers are already servicing the Tamworth electorate.
- (3) A list of locations currently serviced by approved suppliers in regional NSW is not available. The ESS is a market-based scheme and suppliers make their own commercial decisions about the areas they service, and services that they provide.

- \* 0149 PUBLIC SCHOOL INFRASTRUCTURE IN THE TAMWORTH ELECTORATE—The Hon. Kevin Anderson to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

In relation to public school infrastructure in the Tamworth electorate:

- (1) Can the minister provide an update on the current capacity of public schools in Tamworth when compared to the current student population?
- (2) What is the government's plan to meet the growing demand for public education in Tamworth?
- (3) Is the Government planning to explore infrastructure options in Tamworth to ensure that schools do not expand beyond capacity over the coming years?

Answer—

In 2023, schools in the Tamworth electorate have a utilisation rate of around 85 per cent of the existing accommodation.

Population and dwelling projection data will continue to be used from relevant departments and agencies such as the Department of Planning and Environment, local councils, and non-government stakeholders to assess the anticipated demand for public schools.

Any future funding decisions on capital works will also be subject to budget processes.

- \* 0150 REGIONAL SENIORS TRAVEL CARD CONTINUATION—The Hon. Kevin Anderson to ask the Minister for Regional Transport and Roads—

In relation to the Regional Seniors Travel card:

- (1) Is the Regional seniors Travel Card program continuing beyond the initial 4-year trial period, ending November 2023?
- (2) If not, what is the Government's plan to assist regional seniors in travelling from their home to access essential services?

Answer—

I am advised

The former Liberal-National Government failed to fund the Regional Seniors Travel Card beyond the four-year trial. Results of the trial are being monitored and evaluated before determining next steps.

Regional seniors who hold a Pensioner Concession Card or a Seniors Card continue to have access to the Senior/Pensioner fare for local train and bus services.

The Senior/Pensioner fare can be obtained through the Country Pensioner Excursion on Trainlink, the Regional Explorer Daily tickets on regional contracted bus services and the Gold Opal Card for any Opal enabled service.

\* 0151 GOONOO GOONOO ROAD REDEVELOPMENT—The Hon. Kevin Anderson to ask the Minister for Regional Transport and Roads—

Is the Goonoo Goonoo Road development in Tamworth going to progress?

Answer—

I am advised

Transport for NSW is continuing to develop the Goonoo Goonoo Road project.

The delivery of the project is subject to the Australian Government's Infrastructure Investment Program Strategic Review and Infrastructure NSW's Strategic Infrastructure Review.

As both reviews are ongoing, Transport for NSW will update the community should any changes to the Goonoo Goonoo Road project occur.

\* 0152 SCHOOL BUS PATRONAGE—Mrs Tina Ayyad to ask the Minister for Transport—

- (1) Has school bus patronage from Voyager Point, Pleasure Point, and Sandy Point to schools in the Sutherland Shire increased over the last five years?
- (2) Is there an adequate level of patronage for a direct schoolbus service from Holsworthy Train Station to the Sutherland Shire via the three aforementioned suburbs?

Answer—

I am advised Transport for NSW works closely with the Department of Education, local councils and local bus operators while planning transport arrangements and school bus services for the community.

Student school travel demand is reviewed before the beginning of each school year, including evaluation of the boarding/alighting data available together with residential locations of enrolled students.

Transport for NSW will investigate opportunities to improve school services between Voyager Point, Pleasure Point and Sandy Point and schools in Sutherland Shire as part of future planning, with consideration to operational and funding constraints.

\* 0153 HEATHCOTE ROAD, INFANTRY PARADE AND MACARTHUR DRIVE—Mrs Tina Ayyad to ask the Minister for Transport representing the Minister for Jobs and Tourism, Special Minister of State, Minister for Roads, Minister for the Arts, and Minister for Music and the Night-time Economy—

- (1) Are there any planned or implemented temporary traffic contingencies in place at the intersection between Heathcote Road and Macarthur Drive, Holsworthy?
- (2) Has the Government observed an increase in traffic levels at this intersection?
- (3) Is there a timeline on the expected completion for the works being done between Infantry Parade and Macarthur Drive?

Answer—

I am advised

- (1) As part of the Heathcote Road Upgrade from Infantry Parade at Holsworthy to The Avenue at Voyager Point, the Macarthur Drive roundabout will be converted into a fully signalised intersection.

Transport for NSW has implemented several temporary traffic changes for the Macarthur Drive intersection as part of the project's Construction Traffic Management Plan.

The Construction Traffic Management Plan implemented four Variable Message Signs to notify road users of the change in traffic conditions. These Variable Message Signs are deployed in each direction on Heathcote Road at the limit of the works, and individual Variable Message Signs near Infantry Parade and the Macarthur Drive roundabout. A Community Notification was distributed in April 2023 to the adjacent project community regarding the barrier relocation works. A Road Safety Audit was also undertaken, as part of the traffic changes.

Additional temporary traffic changes are also being planned during the construction of the upgrade to include temporary traffic signals. This will allow for works to be carried out within the area without major disruption to the traffic flow along Heathcote Road during peak periods. Transport for NSW will notify stakeholders and the community prior to implementing any traffic changes.

- (2) An increase of traffic has been observed during peak hours with temporary traffic measures implemented on approaches to the intersection to manage these impacts.

As works continue and staging to the project progresses, Transport for NSW will continue to monitor traffic conditions along Heathcote Road. Where appropriate, measures will be put in place to effectively manage the impacts of construction on road users, without compromising safety to workers during construction.

- (3) The Heathcote Road Upgrade project, including the upgrade of the roundabout at Macarthur Drive to a four-way intersection with traffic lights, is expected to be completed in late 2024

\* 0154 ELECTION COMMITMENTS IN THE HOLSWORTHY ELECTORATE—Mrs Tina Ayyad to ask the Minister for Planning and Public Spaces representing the Treasurer—

- (1) What election commitments were made by the NSW Labor Party in the seat of Holsworthy during the recent state election campaign?
- (2) Is there a timeline for when these commitments will be funded and delivered?

Answer—

The government's election commitments are on the public record and will be delivered as promised.

\* 0155 FAR WEST LOCAL HEALTH DISTRICT'S REVIEW OF THE BROKEN HILL HOSPITAL'S HYDROTHERAPY POOL—Mr Roy Butler to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

When will the outcomes of Far West Health District's review of the Broken Hill Hospital's hydrotherapy pool be known and the decisions made available to the Broken Hill community?

Answer—

- (1) The hydrotherapy pool remains closed due to the ongoing infrastructure review and continuing analysis of the service model. Any patients referred and requesting water-based therapy are being appropriately assessed by the physiotherapy outpatient staff at the hospital and provided suitable therapy programs. These may include self-directed water-based exercises that can be done safely at the local public hydrotherapy pool.

\* 0156 NSW LOCAL HEALTH DISTRICTS' PROTOCOLS FOR HOSPITAL ADMINISTRATION OF HIGHLY INFECTIOUS PATIENTS—Mr Roy Butler to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

- (1) Could the Minister advise whether it is within Local Health District protocols to remove palliative and/or aged care patients from hospital if the hospital is expecting the admission of a highly infectious patient?
- (2) If so, within those protocols what is the time frame for the removal of existing patients to make way for the infectious patient?
- (3) Could the Minister explain why an infectious patient would be transferred from a Regional City base hospital to a remote hospital in regional NSW?

Answer—

- (1) Local health districts are required to conduct a risk assessment for appropriate placement and management of patients according to policy and guidelines. Infectious risk is considered along with all other factors required for care, and risk assessment is assisted by guidelines for prioritizing infections matched with required precautions. The term highly infectious is not used. Precautions are applied based on mode of transmission.

There are specific requirements for High Consequence Infectious Diseases however there is greater likelihood these diseases would be transferred from regional to the NSW Biocontainment Centre at Westmead.

- (2) Time frames where patient moves are required is dependent on many factors - suitable bed allocation, bed availability and capacity, care required, type of precautions and isolation required and are not dictated by policy.
- (3) Any patient can be transferred from a regional, city base hospital to a remote hospital where appropriate precautions can be implemented. Depending on requirements, isolation facilities may be spread across a district, with each facility having ability and capacity to manage infectious patients.

\* 0157 ROUND 3 OF THE ACCELERATED INFRASTRUCTURE FUND COUNCIL SELECTION PROCESS—Mr Roy Butler to ask the Minister for Planning and Public Spaces—

- (1) The Barwon Electorate is comprised of several LGAs with considerably lower population growth than what the AIF criteria specifies, are there plans to offer a portion of the AIF to LGAs who have a high percentage growth rate relative to the size of their community?

Answer—

I am advised:

The 41 councils eligible to apply for funding under Round 3 of the Accelerated Infrastructure Fund (AIF) were selected by the previous government and based on the 2022 NSW population and housing projections. These LGAs are experiencing some of the highest levels of housing growth or pressure and forecast to account for 94 per cent of the state's population growth over the next 10 years.

Based on the previous government's criteria, no councils within the Barwon electorate were eligible to receive funding under AIF Round 3.

\* 0158 FREEZE ON SALE OF ALL PUBLIC AND SOCIAL HOUSING—Mr Justin Clancy to ask the Minister for the Illawarra and the South Coast, Minister for Regional Health, and Minister for Health representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—

- (1) In relation to the previous Government's commitment to the Albury Electorate to construct 500 new social housing dwellings and 740 private dwellings on existing social housing land in Albury over the period 2023 to 2033:
  - (a) Is the Government freezing the sale of all public and social housing?
  - (b) If not, how many dwellings are the Government planning to construct in Albury?
- (2) What is the timeline for the 24-home social housing project for East Street Albury?
- (3) What is the timeframe for the completion of the 1,240 home Albury program?
- (4) Does the Government have a Land and Housing Corporation agreement with Albury City Council?
- (5) By what means will the Government be funding the 1,240 home delivery project?
- (6) By what means will the Government be funding the 24-home East Albury home delivery project?
- (7) How many construction contracts have been paused or cancelled across the state?
- (8) How many construction contracts have been paused or cancelled in regional New South Wales?
- (9) What percentage of sales of public and social housing land dwellings were sold to Community Housing Providers each financial year for the period 1 July 2019 to 30 June 2022?
  - (a) Separately, what are the number of such sales for the current partial financial year?

Answer—

- (1) (a) The pause on the sale of NSW land and property is a temporary measure. It will remain in place as long as is necessary.
  - (b) The government expects to deliver around 540 new social housing dwellings and 700 private dwellings in the Albury electorate over the next 10 years.

- (4) Land and Housing Corporation (LAHC) and Albury City Council signed a Collaboration Agreement in March 2022.
  - (5) A variety of funding initiatives were identified to help deliver 1,240 new dwellings including land value leveraging opportunities and potentially from direct Government funding including from the National Housing Finance and Investment Corporation (NHFIC).
  - (6) Funding for the first 24 unit new social housing supply project in East Albury will be confirmed in due course.
  - (7 - 8) Construction contracts signed before the NSW Government announced its pause on asset sales remain active with new homes still under construction.
  - (9) Percentage of LAHC sales to community housing providers (CHP) for financial years:
    - 2019/20 - 1.7% which represents 5 sales to CHP out of 302.
    - 2020/21 - 0.4% which represents 1 sale to CHP out of 247.
    - 2021 /22 - 0.8% which represents 2 sales to CHP out of 262.

\* 0159 WARRAGAMBA DAM—Ms Steph Cooke to ask the Minister for the Illawarra and the South Coast, Minister for Regional Health, and Minister for Health representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—

With respect to Warragamba Dam, what safety issues are associated with the Dam, and what directive has been given to Water NSW in response to any safety issues raised?

Answer—

The operators of Warragamba Dam, WaterNSW, are taking steps to adapt to climate change and to ensure the dam complies with stringent new dam safety standards.

The dam remains safe for day-to-day operations, is structurally sound, does not need repair, and can easily handle an extremely large and rare flooding event, orders of magnitude larger than anything that has been experienced to date.

WaterNSW undertakes routine dam safety activities at Warragamba Dam, including daily inspections, seepage monitoring, comprehensive surveillance inspections and many other steps to ensure the dam remains safe.

The NSW Government has requested WaterNSW continue this work and provide a feasibility brief on any other actions required as soon as possible.

I understand WaterNSW is arranging to brief the Member in more detail.

\* 0160 REGIONAL APPRENTICE AND UNIVERSITY STUDENT TRAVEL CARD—Ms Steph Cooke to ask the Minister for Regional Transport and Roads—

With respect to the Regional Apprentice and University Student Travel Card, and for each of the nine local government areas in the Cootamundra electorate, to date;

- (1) How many applications by eligible apprentices and trainees have been received?
- (2) How many applications by eligible apprentices and trainees have been approved?
- (3) How many travel cards have been issued?
- (4) Of the cards issued, how many have been expended?
- (5) When will applications from eligible university students open?
- (6) How will eligible university students be informed that applications are open?
- (7) How many registered retailers and providers are there?

Answer—

I am advised

- (1) A total of 178 applications have been received.
- (2) A total of 178 applications have been approved.
- (3) A total of 178 cards have been issued.
- (4) A total of 28 cards issued have been expended.
- (5 - 7) The clear intention of the Regional Apprentice and University Student Travel Card is aimed at assisting with travel related expenses; however, the former Liberal-National government did not provide sufficient measures to minimise misuse of the card.

The card is restricted to certain Merchant Category Codes (MMC). This is a number used by the financial services industry to classify businesses by the type of goods or services they provide. While this allows electronic restrictions to be placed on the types of businesses the travel card can be used at, it does not electronically restrict specific purchases within those businesses.

Recent tests have shown that the card can be used to purchase non-travel related expenses such as cigarettes, soft drinks and confectionary.

I have instructed Transport for New South Wales to investigate options to reduce mitigate the risks of potential misuse in the scheme.

\* 0161 JUNEE TRAIN STATION—Ms Steph Cooke to ask the Minister for Regional Transport and Roads—

With respect to the Junee Train Station:

- (1) Are TfNSW personnel required to be present on the platform when a passenger train is stationed there?
- (2) When will TfNSW be fixing the PA system and lighting in the men's restrooms?
- (3) What other maintenance issues are still to be addressed at the station?

Answer—

I am advised

- (1) NSW Trainlink staff are present on trains and alight to the platform when the train arrives to assist passengers to get on and off from all regional services.
- (2) In July 2022, an upgrade of Junee Station was completed as a part of the Transport Access Program, including an upgrade of the public address system to increase the volume of the announcements.

Station lighting was also upgraded to provide better lighting of the station for passengers and staff. Lighting in the men's restrooms has also been upgraded and is now in a working condition.

\* 0164 COMMUNITY BUILDING PARTNERSHIP GRANT PROGRAM—Mr Mark Coure to ask the Premier—

Is the Community Building Partnership Grant program going to continue?

Answer—

I am advised details regarding Community Building Partnership (CBP) program will be announced after the 2023-24 NSW Budget is handed down in September 2023.

\* 0165 TERRIGAL OFFSHORE ARTIFICIAL REEF—Mr Adam Crouch to ask the Minister for Police and Counter-terrorism representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—

- (1) What is the detailed timeline for the completion of construction and delivery of the Terrigal Offshore Artificial Reef?
- (2) Will the location be at Terrigal Haven?

Answer—

- (1) Deployment of the Central Coast and Forster offshore artificial reefs is set to commence during the first suitable weather window in August 2023. The deployment schedule is heavily dependent on suitable weather conditions.
- (2) The location for the Central Coast artificial reef is a sandy area approximately 6 km east-south-east of Terrigal Haven within NSW State waters at a depth of 40-45 m.

\* 0166 NEW AMBULANCE STATIONS CENTRAL COAST—Mr Adam Crouch to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

- (1) As part of the former Governments Rural Ambulance Infrastructure Reconfiguration program, Kincumber and Lisarow were selected for new ambulance stations. Will the construction of these stations go ahead?
- (2) Can the Minister provide site locations and a detailed timeline for the construction of both ambulance stations?

Answer—

- (1) The NSW Government has committed to undertake a Strategic Infrastructure Review of significant capital works. This will be led by Mr Ken Kanofski and supported by Infrastructure NSW. The outcome of the Review will inform future capital decisions and expenditure in relation to the \$615.5 million Ambulance Infrastructure Program.

The proposed ambulance stations funded under the NSW Ambulance Infrastructure Program are scheduled to be complete and ready for operations from mid-2025 through to 2027.

- (2) Health Infrastructure is working with NSW Ambulance and other key government stakeholders to identify potential sites for the new ambulance stations. Once the outcomes of the Review are available, construction timeframes for stations will be confirmed.

\* 0167 COAST RELIEF FOR CENTRAL COAST COMMUTERS—Mr Adam Crouch to ask the Minister for Transport—

In relation to Central Coast commuters who use their Opal card every day:

Since the First Home Buyer Choice Program came into effect on 16 January 2023, how many people have applied for the Program and how many of those applications have been successful?

Answer—

Under the Property Tax (First Home Buyer Choice) Act 2022, a property becomes subject to property tax if:

- (1) An application to opt a property into property tax is made and approved, and
- (2) Transfer of the property is completed.

As at 15 June 2023, 10,166 people had applied to opt a property into property tax. Of these:

- 8,020 applied to opt a property into property tax, the application was approved and transfer of the property was completed.
- 1, 893 people have made applications but transfer of the property is yet to be completed.
- 253 people applied but the property did not become subject to property tax. This may occur for various reasons, such as withdrawal of the application, cancellation of the contract or the applicant not being eligible to opt the property into property tax.

The work of the review is critical, ongoing and will inform Cabinet deliberations for the 2023-24 Budget, to be delivered on September 19th.

Negotiations were also sought to secure a financial commitment from proponents that could support the maintenance and improvements to the buildings over the period of the proposed tenancy.

NSW Health staff visit the site frequently and a small team works on-site to ensure it is adequately secured. Measures are in place to preserve and maintain activities while the building is vacant, and it is used for occasional filming and storage.

NSW Health continues to consider all its options for the site.

The ADC is not intended to replicate the work of the Aged Care Quality & Safety

Commission or the NDIS Quality & Safeguards Commission. While the ADC may choose to investigate allegations in relation to aged care services, the Commonwealth's Aged

Care Quality and Safety Commission has responsibility for aged care facilities and services.

As well as the ADC providing information and support where appropriate, advice and support for older people wishing to buy a personal alarm is available through a range of local service providers including neighbourhood centres, hospital and community health services, GPs, Aged Care Assessment Teams and local councils.
