Answer-

I am advised by the Minister for Better Regulation and Innovation, Minister for Industry and Trade, Minister for Innovation, Science and Technology, Minister for Building and Minister for Corrections that the Serious Offenders Review Council (the Council) does not make the final determination as to whether an inmate is suitable to be released to parole. The State Parole Authority (SPA) is an independent statutory authority empowered to determine matters with respect to parole orders. While the Council provides advice about serious offenders, the SPA has the discretion to determine matters relating to an offender's parole.

Answer-

I am advised the following;

- Flights for the May 2023 Vice Regal mission to the United Kingdom via the United Arab Emirates (UAE) were booked in November 2022.
- The trip was a scheduled Vice Regal Mission, the last NSW Vice Regal mission to the UAE was undertaken by Governor Hurley in 2017.
- There are presently no international visits planned for the NSW Governor.
- The former Government was informed prior to the Governor's proposed overseas travel.
- The ceremonial opening of Parliament was conducted by the Lieutenant-Governor as the Vice Regal representative in accordance with the Constitution Act 1902 as the Governor was discharging other Vice Regal duties.
- The Premier is not responsible for approving Vice Regal travel.
